5 "C. ADDITIONAL VOTER REGISTRATION VOLUNTEERS AND THOSE PAID AND
6 UNPAID VOTER REGISTRATION COLLECTORS WHO RECEIVE VOTER REGISTRATION FORMS
7 PURSUANT TO SECTION 16-131, SUBSECTION E SHALL RETURN OR MAIL COMPLETED
8 VOTER REGISTRATIONS TO THE COUNTY RECORDER OF THE COUNTY IN WHICH THE
9 APPLICANT RESIDES, TO THE SECRETARY OF STATE OR TO THE COUNTY RECORDER WHO
10 PROVIDED THE VOTER REGISTRATION FORMS WITHIN FIVE DAYS AFTER RECEIVING
11 THOSE REGISTRATIONS OR SHALL RETURN THOSE REGISTRATIONS TO THE APPROPRIATE
12 COUNTY RECORDER SO THAT THEY ARE RECEIVED ON OR BEFORE THE VOTER
13 REGISTRATION DEADLINE FOR THE NEXT UPCOMING ELECTION, WHICHEVER IS
14 EARLIER."

8 ADDRESS AND IF THE ELECTOR WISHES TO RECEIVE VOTING MATERIALS AT THAT
9 PERMANENT FORWARDING ADDRESS, THE ELECTOR MUST UPDATE THE ELECTOR'S
10 INFORMATION AND REREGISTER AT THE NEW ADDRESS.

11 2. TEMPORARY FORWARDING ADDRESS AND PROVIDES TO THE COUNTY RECORDER
12 THE TEMPORARY ADDRESS FOR THE VOTER WITHIN ELEVEN DAYS BEFORE THE DATE OF
13 THE ELECTION, THE COUNTY RECORDER MAY SEND NOTICE TO THE ELECTOR AT THAT
14 FORWARDING ADDRESS THAT VOTING MATERIALS CANNOT BE FORWARDED TO THAT
15 ADDRESS UNLESS THE VOTER MAKES A REQUEST PURSUANT TO SECTION 16-542."

15 A. The sum of \$4,622,000 and 35.25 FTE positions are appropriated
16 from the state general fund in fiscal year 2022-2023 to the auditor general
17 for election integrity audits as prescribed in section 41-1279.08, Arizona
18 Revised Statutes, as added by this act.

19 B. The appropriation made in subsection A of this section is exempt
20 from the provisions of section 35-190, Arizona Revised Statutes, relating
21 to lapsing of appropriations."
