1 Page 1, line 6, after "writing" insert "AND ON THE RECORD"; strike the period

2 insert "IN THE FOLLOWING MANNER:"

3 Line 7, strike "B." insert "1."

4 Reletter to conform

5 Line 8, strike "AT THE TIME OF" insert "THE COURT SHALL INFORM THE PERSON THAT

6 THE PERSON'S RIGHTS WILL BE AUTOMATICALLY RESTORED ON"

7 Line 9, after "IMPRISONMENT" insert a period strike remainder of line

8 Strike lines 10 through 13, insert "THE COURT'S ORDER AND JUDGMENT OF GUILT

9 MUST INCLUDE AN EXPLANATION OF THE CIVIL RIGHTS THAT WILL BE AUTOMATICALLY

10 RESTORED PURSUANT TO THIS PARAGRAPH."

11 Line 14, strike "C." insert "2."

12 Reletter to conform

13 Line 15, after the comma strike remainder of line

14 Strike lines 16 through 20, insert "THE COURT SHALL INFORM THE PERSON OF THE

15 PERSON'S RIGHT TO THE RESTORATION OF CIVIL RIGHTS. THE COURT'S ORDER AND

16 JUDGMENT OF GUILT MUST INCLUDE AN EXPLANATION THAT INCLUDES WHEN THE PERSON

17 CAN APPLY TO HAVE THE PERSON'S CIVIL RIGHTS RESTORED.

1 B. THE PROBATION DEPARTMENT SHALL PROVIDE A COPY OF THE COURT'S
2 SENTENCING ORDER AND JUDGMENT OF GUILT TO EACH PERSON WHO COMPLETES
3 PROBATION. THE STATE DEPARTMENT OF CORRECTIONS SHALL PROVIDE A COPY OF THE
4 COURT'S SENTENCING ORDER AND JUDGMENT OF GUILT TO EACH PRISONER WHO OBTAINS
5 AN ABSOLUTE DISCHARGE FROM IMPRISONMENT UNLESS THE PRISONER WAS SENTENCED
6 TO A TERM OF PROBATION TO BEGIN ON ABSOLUTE DISCHARGE FROM THE STATE
7 DEPARTMENT OF CORRECTIONS."
