FLOOR AMENDMENT EXPLANATION

1. Removes all appropriations.
2. Removes the requirement that any remaining monies unexpended for the Student Nurse Clinical Rotation and Licensed or Certified Nurse Training Program and the Preceptor Grant Program for Graduate Students revert to the state General Fund.
3. Requires that monies in the Pilot Program Fund be used to expand the capacity of the Maricopa County Community College District and the Navajo County Community College District to train students as behavioral health workers by developing behavioral health curriculum.
4. Removes the legislative intent clause.
