# **SB 1525**

AN ACT

ESTABLISHING THE INTERSTATE CABLE BARRIER MEDIAN EXPANSION STUDY COMMITTEE; APPROPRIATING MONIES; RELATING TO TRANSPORTATION.

1 Be it enacted by the Legislature of the State of Arizona:

2       Section 1. Interstate cable barrier median expansion study  
3                   committee; duties; report; repeal

4       A. The interstate cable barrier median expansion study committee is  
5 established consisting of the following fifteen members:

6       1. Three members of the senate who are appointed by the president  
7 of the senate, not more than two of whom are members of the same political  
8 party. The president of the senate shall designate one of these members  
9 to serve as cochairperson of the committee. Two of the members shall be  
10 the chairperson and the ranking minority member on the senate  
11 transportation and technology committee or its successor committee.

12      2. Three members of the house of representatives who are appointed  
13 by the speaker of the house of representatives, not more than two of whom  
14 are members of the same political party. The speaker of the house of  
15 representatives shall designate one of these members to serve as  
16 cochairperson of the committee. Two of the members shall be the  
17 chairperson and the ranking minority member on the house of  
18 representatives transportation committee or its successor committee.

19      3. The director of the department of transportation or the  
20 director's designee.

21      4. The director of the department of public safety or the  
22 director's designee.

23      5. The director of the Maricopa association of governments or the  
24 director's designee.

25      6. The director of the Pima association of governments or the  
26 director's designee.

27      7. The director of the central Arizona governments or the  
28 director's designee.

29      8. The chairperson of the state transportation board or the  
30 chairperson's designee.

31      9. The director of the rural transportation advocacy council or the  
32 director's designee.

33      10. Two public members who have been impacted by a fatality on a  
34 highway without median cable barriers and who are appointed by the  
35 governor. One member must reside in the northern portion of this state  
36 and one member must reside in the southern portion of this state.

37       B. The study committee shall conduct hearings on and examine the  
38 following:

39       1. The current landscape, inventory and mapping of cable median  
40 barriers throughout this state.

41       2. The feasibility of installing cable median barriers and public  
42 safety alternatives throughout highways, interstates and state routes in  
43 this state.

44       3. A historical accounting of fatalities and crossover accidents  
45 for the past ten years in this state.

1       4. Other issues that the study committee deems necessary relating  
2 to best practices on:

3           (a) Installation of cable median barriers.

4           (b) Mitigation of fatalities, crossover accidents and severe  
5 injury.

6           (c) Other public safety tools to increase safety on highways,  
7 interstates and state routes in this state.

8           (d) Determination of the criteria to prioritize the installation of  
9 cable median barriers.

10          C. The department of transportation shall provide the committee  
11 with administrative support. Members of the committee are not eligible to  
12 receive reimbursement of expenses pursuant to title 38, chapter 4, article  
13 2, Arizona Revised Statutes.

14          D. On or before December 15, 2022, the committee shall submit a  
15 report regarding the committee's activities and recommendations for  
16 administrative or legislative action to the governor, the president of the  
17 senate and the speaker of the house of representatives and provide a copy  
18 of this report to the secretary of state and any member of the public who  
19 request a copy. The report shall include a proposed priority list of  
20 cable median barriers to be installed in this state.

21          E. This section is repealed from and after September 30, 2023.

22          Sec. 2. Appropriation; department of transportation; cable  
23 median barriers

24          The sum of \$10,000,000 is appropriated from the state general fund  
25 in fiscal year 2022-2023 to the department of transportation to install  
26 cable median barriers in this state. The department shall prioritize the  
27 installation projects as provided in section 1, subsection B, paragraph 4,  
28 subdivision (d) of this act.
