

PROPOSED

SENATE AMENDMENTS TO S.B. 1596

(Reference to printed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Arizona off-highway vehicle study committee;  
3 membership; duties; report; delayed repeal

4 A. The Arizona off-highway vehicle study committee is established  
5 consisting of the following members:

6 1. Two members of the senate who are appointed by the president of  
7 the senate and who are members of different political parties. The  
8 president of the senate shall designate one of these members to serve as  
9 cochairperson of the committee.

10 2. Two members of the house of representatives who are appointed by  
11 the speaker of the house of representatives and who are members of  
12 different political parties. The speaker of the house of representatives  
13 shall designate one of these members to serve as cochairperson of the  
14 committee.

15 3. The director of the Arizona game and fish department or the  
16 director's designee.

17 4. The director of the department of transportation or the  
18 director's designee.

19 5. The director of the Arizona state parks board or the director's  
20 designee.

21 6. The commissioner of the state land department or the  
22 commissioner's designee.

23 7. One law enforcement officer who enforces off-highway vehicle laws  
24 and who is appointed by the governor.

1           8. One representative of an organization representing hunting or  
2 fishing or a similar outdoor sports activity in this state who is appointed  
3 by the governor.

4           9. Two members who represent an off-highway vehicle organization or  
5 recreational group in this state. One member shall be appointed by the  
6 president of the senate and one member shall be appointed by the speaker of  
7 the house of representatives.

8           10. One representative of an off-highway vehicle rental company in  
9 this state who is appointed by the president of the senate.

10           11. One representative of an off-highway vehicle manufacturer or  
11 retailer in this state who is appointed by the speaker of the house of  
12 representatives.

13           12. One representative of the farming and agriculture industry in  
14 this state who is appointed by the governor.

15           13. Two members of the public who are knowledgeable about outdoor  
16 recreation issues in this state and about trails used by off-highway  
17 vehicle operators. The president of the senate shall appoint these  
18 members. One of the members shall represent holders of federal grazing  
19 permits or other land use permits.

20           B. Appointed members serve at the pleasure of the person who made  
21 the appointment.

22           C. Committee members are not eligible to receive compensation, but  
23 members who are appointed by the governor are eligible for reimbursement of  
24 expenses under title 38, chapter 4, article 2, Arizona Revised Statutes.

25           D. The committee shall:

26           1. Meet to collect and study information from the public and  
27 stakeholders regarding off-highway vehicle issues in this state.

28           2. On or before January 1 of each year, submit a report regarding  
29 the committee's activities and recommendations for administrative or  
30 legislative action to the governor, the president of the senate and the

1 speaker of the house of representatives and provide a copy of this report  
2 to the secretary of state.

3 E. This section is repealed from and after May 31, 2024."
