1 Page 1, line 10, after "16-140" strike remainder of line

7 PURSUANT TO SECTION 16-131, SUBSECTION E SHALL RETURN OR MAIL COMPLETED

12 COUNTY RECORDER SO THAT THEY ARE RECEIVED ON OR BEFORE THE VOTER
13 REGISTRATION DEADLINE FOR THE NEXT UPCOMING ELECTION, WHICHEVER IS
14 EARLIER."

5 THE ELECTION, THE COUNTY RECORDER MAY SEND NOTICE TO THE ELECTOR AT THAT
6 FORWARDING ADDRESS THAT VOTING MATERIALS CANNOT BE FORWARDED TO THAT
7 ADDRESS AND IF THE ELECTOR WISHES TO RECEIVE VOTING MATERIALS AT THAT
8 PERMANENT FORWARDING ADDRESS, THE ELECTOR MUST UPDATE THE ELECTOR'S
9 INFORMATION AND REREGISTER AT THE NEW ADDRESS.

10 2. TEMPORARY FORWARDING ADDRESS AND PROVIDES TO THE COUNTY RECORDER
11 THE TEMPORARY ADDRESS FOR THE VOTER WITHIN ELEVEN DAYS BEFORE THE DATE OF
12 THE ELECTION, THE COUNTY RECORDER MAY SEND NOTICE TO THE ELECTOR AT THAT
13 FORWARDING ADDRESS THAT VOTING MATERIALS CANNOT BE FORWARDED TO THAT
14 ADDRESS UNLESS THE VOTER MAKES A REQUEST PURSUANT TO SECTION 16-542."

11 A. The sum of \$4,622,000 and 35.25 FTE positions are appropriated
12 from the state general fund in fiscal year 2022-2023 to the auditor general
13 for election integrity audits as prescribed in section 41-1279.08, Arizona
14 Revised Statutes, as added by this act.

15 B. The appropriation made in subsection A of this section is exempt
16 from the provisions of section 35-190, Arizona Revised Statutes, relating
17 to lapsing of appropriations."
