SENATE BILL 1673

AN ACT

AMENDING SECTIONS 21-101 AND 21-301, ARIZONA REVISED STATUTES; RELATING TO JURIES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 21-101, Arizona Revised Statutes, is amended to
3 read:

4 21-101. Definitions

5 In this title, unless the context otherwise requires:

6 1. "Juror pool" means the persons who are summoned and who report
7 on a specific date to or for a specific location for either trial or grand
8 jury service.

9 2. "Jury commissioner" means the clerk of the superior court,
10 except that in any county having a population of more than five hundred
11 thousand persons, the presiding judge of the superior court may appoint a
12 jury commissioner.

13 3. "Jury manager" means the person who is responsible for jury
14 management in a justice of the peace court or a municipal court.

15 4. "Jury panel" means a group of jurors who are drawn at random
16 from the juror pool and who are assigned to a specific case or trial.

17 5. "Master jury file" means a list of prospective jurors who are
18 randomly selected from the master jury list.

19 6. "Master jury list":

20 (a) Means a record of the names, ~~and~~ addresses, DATES OF BIRTH AND,
21 IF AVAILABLE, TELEPHONE NUMBERS AND EMAIL ADDRESSES of eligible persons
22 who reside in the county. ~~and~~

23 (b) Includes persons on the voter registration list of the county
24 and other persons who are eligible for jury service and who have been
25 licensed pursuant to title 28, chapter 8, article 4 or 5.

26 Sec. 2. Section 21-301, Arizona Revised Statutes, is amended to
27 read:

28 21-301. Master jury list; source lists

29 A. The jury commissioner shall produce a master jury list. The
30 master jury list shall be comprised of the names, ~~and~~ addresses, DATES OF
31 BIRTH AND, IF AVAILABLE, TELEPHONE NUMBERS AND EMAIL ADDRESSES of eligible
32 persons who reside in the county and shall include persons on the voter
33 registration list of the county, other persons eligible for jury service
34 who have been licensed pursuant to title 28, chapter 8, article 4 or 5 and
35 persons from other lists as determined by the supreme court. The master
36 jury list shall be prepared so as to avoid duplication of the names of
37 eligible juror candidates.

38 B. Not later than January 1 following each biennial general
39 election, the county recorder shall provide the jury commissioner or jury
40 manager with a list containing the names, ~~and~~ addresses, DATES OF BIRTH
41 AND, IF AVAILABLE, TELEPHONE NUMBERS AND EMAIL ADDRESSES of all persons
42 WHO ARE qualified to vote at the preceding general election. At least
43 once every six months thereafter the county recorder shall provide the
44 jury commissioner with the names, ~~and~~ addresses, DATES OF BIRTH AND, IF

1 AVAILABLE, TELEPHONE NUMBERS AND EMAIL ADDRESSES of all additional persons
2 who have registered as voters since the date of the last list.
3 C. On written request by a jury commissioner or jury manager, the
4 director of the department of transportation shall furnish and
5 periodically revise a list of the names, ~~and~~ addresses, DATES OF BIRTH
6 AND, IF AVAILABLE, TELEPHONE NUMBERS AND EMAIL ADDRESSES of all persons in
7 that county who are at least eighteen years of age and who have been
8 licensed pursuant to title 28, chapter 8, article 4 or 5. Except as
9 provided in section 21-312, ~~no~~ A jury commissioner or jury manager may NOT
10 disclose information furnished by the director of the department of
11 transportation pursuant to this section to any person, organization or
12 agency for any use other than the selection of jurors.
