HOUSE OF REPRESENTATIVES AMENDMENTS TO H.B. 2669

(Reference to printed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Section 49-255.03, Arizona Revised Statutes, is amended
3 to read:

4 49-255.03. Sewage sludge program; rules and requirements

5 A. The director shall adopt rules to establish a sewage sludge
6 program that is consistent with the requirements of sections 402 and 405 of
7 the clean water act. Except as otherwise required by this article, the
8 director shall not adopt any requirement that is more stringent than any
9 requirements of the clean water act. The director shall not adopt any
10 requirement that conflicts with any requirement of the clean water act.

11 B. The rules adopted by the director shall provide for the
12 regulation of all sewage sludge use or disposal practices used in this
13 state.

14 C. NOTWITHSTANDING ANY OTHER LAW OR RULE, EXCEPT FOR EXCEPTIONAL
15 QUALITY BIOSOLIDS, A PERSON MAY NOT SUBMIT A REQUEST FOR REGISTRATION TO
16 LAND APPLY, AND MAY NOT LAND APPLY, A SUBSTANCE THAT CONTAINS BIOSOLIDS,
17 SEWAGE SLUDGE OR SEPTAGE, WITHIN THREE MILES OF AN AREA CONTAINING A
18 POPULATION DENSITY EQUAL TO OR GREATER THAN ONE HUNDRED TWENTY-EIGHT
19 PERSONS PER SQUARE MILE, OR WITHIN ONE MILE OF A CROP PRODUCED FOR HUMAN
20 CONSUMPTION OR ANY PROPERTY ZONED RESIDENTIAL.

21 D. NOTWITHSTANDING ANY OTHER LAW OR RULE, THE DIRECTOR SHALL REQUIRE
22 ANY LAND APPLICATION OF A SUBSTANCE THAT CONTAINS BIOSOLIDS, SEWAGE OR
23 SEPTAGE TO COMPLY WITH THE RULES ESTABLISHED PURSUANT TO SUBSECTION A OF
24 THIS SECTION INCLUDING PATHOGEN REDUCTION REQUIREMENTS FOR BIOSOLIDS.

1 E. NOTWITHSTANDING ANY OTHER LAW OR RULE, A BIOSOLID COMBINED WITH A
2 SOLID WASTE SHALL BE REGULATED AS A SOLID WASTE PURSUANT TO TITLE 49,
3 CHAPTER 4."
