SENATE AMENDMENTS TO S.B. 1366
(Reference to printed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Title 32, chapter 32, article 1, Arizona Revised
3 Statutes, is amended by adding section 32-3230.02, to read:

4 32-3230.02. Health professionals; pregnant women; required
5 information

6 EACH PHYSICIAN WHO IS LICENSED PURSUANT TO CHAPTER 13 OR 17 OF THIS
7 TITLE, NURSE PRACTITIONER WHO IS LICENSED PURSUANT TO CHAPTER 15 OF THIS
8 TITLE AND PHYSICIAN ASSISTANT WHO IS LICENSED PURSUANT TO CHAPTER 25 OF
9 THIS TITLE IS REQUIRED TO INFORM A PATIENT WHO IS PREGNANT AND WHOSE VISIT
10 WITH THE PHYSICIAN, NURSE PRACTITIONER OR PHYSICIAN ASSISTANT IS RELATED TO
11 THE PREGNANCY THAT:

12 1. MEDICAL ASSISTANCE BENEFITS MAY BE AVAILABLE FOR PRENATAL CARE,
13 CHILDBIRTH AND NEONATAL CARE.

14 2. THE FATHER OF THE UNBORN CHILD IS LIABLE TO ASSIST IN THE SUPPORT
15 OF THE CHILD, EVEN IF HE HAS OFFERED TO PAY FOR AN ABORTION. IN THE CASE
16 OF RAPE OR INCEST, THIS INFORMATION MAY BE OMITTED.

17 3. PUBLIC AND PRIVATE AGENCIES AND SERVICES ARE AVAILABLE TO ASSIST
18 THE WOMAN DURING HER PREGNANCY AND AFTER THE BIRTH OF HER CHILD IF SHE
19 CHOOSES NOT TO HAVE AN ABORTION, WHETHER SHE CHOOSES TO KEEP THE CHILD OR
20 PLACE THE CHILD FOR ADOPTION.

21 4. IT IS UNLAWFUL FOR ANY PERSON TO COERCE A WOMAN TO UNDERGO AN
22 ABORTION.

1 5. THE DEPARTMENT OF HEALTH SERVICES MAINTAINS A WEBSITE THAT
2 DESCRIBES THE UNBORN CHILD AND LISTS THE AGENCIES THAT OFFER ALTERNATIVES
3 TO ABORTION.

4 6. THE WOMAN HAS THE RIGHT TO REVIEW THE WEBSITE AND THAT A PRINTED
5 COPY OF THE MATERIALS ON THE WEBSITE WILL BE PROVIDED TO HER FREE OF CHARGE
6 IF SHE CHOOSES TO REVIEW THESE MATERIALS."
