5 B. THE BOARD SHALL ADOPT RULES ESTABLISHING ADDITIONAL CERTIFICATION
6 STANDARDS OR REQUIREMENTS FOR PHYSICIAN ASSISTANTS WHO PREVIOUSLY COMPLETED
7 EIGHT THOUSAND CLINICAL PRACTICE HOURS CERTIFIED BY THE BOARD AND WHO ARE
8 SEEKING EMPLOYMENT WITH A COLLABORATING PHYSICIAN OR ENTITY FOR A POSITION
9 THAT IS NOT SUBSTANTIALLY SIMILAR TO THE PRACTICE SETTING OR SPECIALTY IN
10 WHICH THE PHYSICIAN ASSISTANT WAS PREVIOUSLY CERTIFIED. THE CERTIFICATION
11 STANDARDS OR REQUIREMENTS SHALL ENSURE APPROPRIATE TRAINING AND OVERSIGHT,
12 INCLUDING A SUPERVISION AGREEMENT IF WARRANTED, FOR THE PHYSICIAN
13 ASSISTANT'S NEW PRACTICE SETTING OR SPECIALTY."
