1 Page 1, line 22, strike "~~, and~~" insert "and"

2 Line 23, strike ", DRAG SHOW PERMITS AND DRAG PERFORMER PERMITS"

3 Line 28, after "CONDUCT" insert "SEXUALLY EXPLICIT"

4 Page 3, line 11, after "CONDUCT" insert "SEXUALLY EXPLICIT"

5 Strike lines 36 through 41

6 Renumber to conform

7 Page 5, between lines 4 and 5, insert:

8 "18. "SEXUALLY EXPLICIT" MEANS:

9 (a) AN INTENTION TO AROUSE OR SATISFY THE SEXUAL DESIRES OR APPEAL  
10 TO THE PRURIENT INTEREST.

11 (b) DEPICTIONS, SIMULATIONS OR ACTS OF MASTURBATION, SEXUAL  
12 INTERCOURSE OR PHYSICAL CONTACT WITH A PERSON'S CLOTHED OR UNCLOTHED  
13 GENITALS, PUBIC AREA, BUTTOCKS OR BREAST.

14 (c) SEXUAL EXCITEMENT. FOR THE PURPOSES OF THIS PARAGRAPH, "SEXUAL  
15 EXCITEMENT" MEANS THE CONDITION OF THE HUMAN MALE OR FEMALE GENITALS WHEN  
16 IN A STATE OF SEXUAL STIMULATION OR AROUSAL.

17 (d) ULTIMATE SEXUAL ACTS. FOR THE PURPOSES OF THIS PARAGRAPH  
18 "ULTIMATE SEXUAL ACTS" MEANS ACTUAL OR SIMULATED SEXUAL INTERCOURSE,  
19 VAGINAL OR ANAL FELLATIO, CUNNILINGUS, BESTIALITY OR SODOMY. A SEXUAL ACT  
20 IS SIMULATED WHEN IT DEPICTS EXPLICIT SEXUAL ACTIVITY THAT GIVES THE  
21 APPEARANCE OF CONSUMMATION OF ULTIMATE SEXUAL ACTS.

22 19. "SEXUALLY EXPLICIT DRAG SHOW" MEANS A SHOW OR PERFORMANCE FOR  
23 ENTERTAINMENT AT WHICH A SINGLE DRAG PERFORMER OR GROUP OF DRAG PERFORMERS  
24 ENTERTAINS AN AUDIENCE OF TWO OR MORE PEOPLE IN A MANNER THAT IS SEXUALLY  
25 EXPLICIT."
