

PROPOSED
SENATE AMENDMENTS TO S.B. 1376
(Reference to printed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Laws 2022, chapter 313, section 110 is amended to read:

3 Sec. 110. Department of emergency and military affairs; border
4 security; exemption; fiscal year 2022-2023

5 A. The sum of \$209,205,000 is appropriated from the border security
6 fund established by section 26-105, Arizona Revised Statutes, in fiscal
7 year 2022-2023 to the department of emergency and military affairs. The
8 department of emergency and military affairs shall allocate, in
9 consultation with the department of public safety, the following amounts:

10 1. \$20,000,000 to Cochise county to construct a new county jail
11 facility. The monies allocated in this paragraph are intended to fund up
12 to twenty percent of the total jail facility construction cost but not to
13 exceed \$20,000,000. The monies allocated in this paragraph shall not be
14 distributed until Cochise county has submitted to the director of the joint
15 legislative budget committee, the director of the governor's office of
16 strategic planning and budgeting and the director of the department of
17 administration a report that the county has raised sufficient monies to
18 fund the remainder of the project's budget. Notwithstanding section

1 41-1252, Arizona Revised Statutes, the monies allocated in this paragraph
2 are not subject to review by the joint committee on capital review. Any
3 monies allocated pursuant to this paragraph that remain unexpended and
4 unencumbered on June 30, 2027 revert to the border security fund
5 established by section 26-105, Arizona Revised Statutes.

6 2. \$15,000,000 to reimburse a county or local law enforcement agency
7 for costs incurred by the county or local law enforcement agency for
8 participating in a program with the United States immigration and customs
9 enforcement pursuant to 8 United States code section 1357(g).

10 3. \$10,000,000 for deposit in the ~~antihuman~~ ANTI-HUMAN trafficking
11 grant fund established by section 26-106, Arizona Revised Statutes. The
12 monies shall be allocated as follows:

13 (a) \$2,000,000 to the department of public safety Arizona counter
14 terrorism information center for ~~antihuman~~ ANTI-HUMAN trafficking
15 operations that comply with the requirements prescribed in section 26-106,
16 Arizona Revised Statutes.

17 (b) \$8,000,000 in award grants to city, town and county law
18 enforcement agencies, in an amount of not more than \$500,000 per agency,
19 for programs that reduce human trafficking and that comply with the
20 requirements prescribed in section 26-106, Arizona Revised Statutes.

21 4. \$30,000,000 to distribute to cities, towns or counties for costs
22 associated with prosecuting and imprisoning individuals charged with drug
23 trafficking, human smuggling, illegal immigration and other border-related
24 crimes.

1 5. \$10,000,000 for costs incurred by Arizona national guard assets
2 augmenting and supporting the department of public safety and local law
3 enforcement agencies relating to violations of the laws of this state in
4 the southern Arizona border region.

5 6. \$10,000,000 for emergency health care and testing for immigrants
6 along the southern Arizona border.

7 7. \$15,000,000 for transportation of individuals who entered Arizona
8 seeking asylum to other states in the United States, including the cost of
9 meals, onboard staffing and support.

10 8. \$53,405,000 for deputy sheriff compensation to be distributed to
11 the department of administration for the following purposes:

12 (a) \$48,310,000 to counties for the purposes of a \$10,000 onetime
13 payment to line-level deputies and detention officers employed by each
14 county sheriff's office as of May 1, 2022. The county shall distribute the
15 payment to eligible employees in equal quarterly installments over ~~two~~
16 ~~years~~ ONE YEAR. FROM AND AFTER APRIL 30, 2023, A COUNTY MAY SPEND MONIES
17 THAT ARE UNENCUMBERED AND UNEXPENDED PURSUANT TO THIS SUBDIVISION FOR THE
18 PURPOSES PRESCRIBED BY SUBDIVISION (b) OF THIS PARAGRAPH. If the amount is
19 insufficient for a \$10,000 per employee payment, the department shall
20 distribute a prorated amount based on the total number of deputies and
21 detention officers employed. On or before August 30, 2023 and August 30,
22 2024, each county sheriff shall submit a report to the department of
23 administration on the actual use of the monies received and the most recent
24 staffing and retention data for the positions receiving the payment. On or

1 before September 30, 2023 and September 23, 2024, the department of
2 administration shall submit a report to the directors of the joint
3 legislative budget committee and the governor's office of strategic
4 planning and budgeting detailing the total amounts distributed by county
5 and summarizing the individual county reports.

6 (b) \$5,095,000 to counties for the purposes of a \$5,000 onetime
7 payment to line-level deputies and detention officers hired ~~between~~ AFTER
8 May 1, 2022 ~~and May 1, 2023~~. The county shall distribute the payment to
9 eligible employees in equal quarterly installments over one year. On ~~June~~
10 MAY 1, ~~2023~~ 2022, the department of administration shall distribute the
11 ~~funding~~ MONIES to the counties based on the ~~actual~~ TOTAL number of ~~hires~~
12 ~~during this time period, as demonstrated by~~ VACANCIES FOR LINE-LEVEL
13 DEPUTIES AND DETENTION OFFICERS IN each county. ~~If the amount is~~
14 ~~insufficient for a \$5,000 per employee payment, the department shall~~
15 ~~distribute a prorated amount based on the total number of hired detention~~
16 ~~officers and sheriff's deputies.~~ On or before June 30, 2023, the
17 department shall submit a report to the directors of the joint legislative
18 budget committee and the governor's office of strategic planning and
19 budgeting detailing the amounts distributed to each county.

20 9. \$800,000 for the purposes prescribed in section 26-174, Arizona
21 Revised Statutes, regarding the established chain of command within the
22 Arizona state guard.

23 10. \$30,000,000 for the construction costs of a state emergency
24 operations center. Pursuant to section 41-1252, Arizona Revised Statutes,

1 before spending the monies allocated in this paragraph, the department of
2 emergency and military affairs shall submit for review by the joint
3 committee on capital review the scope, purpose and estimated cost of the
4 capital improvements.

5 11. \$15,000,000 to the department of public safety for the
6 construction costs of a southern border coordinated response center.
7 Pursuant to section 41-1252, Arizona Revised Statutes, before spending the
8 monies allocated in this paragraph, the department of public safety shall
9 submit for review by the joint committee on capital review the scope,
10 purpose and estimated cost of the capital improvements.

11 B. Within thirty days after the end of each calendar quarter until
12 the monies appropriated by this section are fully expended, the department
13 of emergency and military affairs, in consultation with the Arizona
14 department of homeland security and the department of public safety, shall
15 report to the joint legislative budget committee on the status of the
16 project allocations and monies expended as prescribed by this section.

17 C. The department of emergency and military affairs may transfer
18 spending authority between and within the programs and purposes listed in
19 subsection A of this section. Before making a transfer, the department
20 shall submit the proposed transfer to the joint legislative budget
21 committee for review.

22 D. The appropriations made in subsection A of this section are
23 exempt from the provisions of section 35-190, Arizona Revised Statutes,
24 relating to lapsing of appropriations.
