FLOOR AMENDMENT EXPLANATION

1. Increases, from two to four years, the continuation of the Arizona Department of Administration (ADOA).
2. Increases, from two years to eight years, the continuation of the Occupational Safety and Health Review Board, the Boiler Advisory Board, the Board of Technical Registration, the State Personnel Board, the Governor's Office on Tribal Relations, the Arizona Historical Society and the Prescott Historical Society.
3. Eliminates the requirement for the Joint Legislative Audit Committee to direct the committees of reference to conduct the sunset reviews for the next sunset termination schedule.
4. Eliminates the prohibition on the ADOA, the State Personnel Board and the Governor's Office on Tribal Relations from spending public monies or using public resources relating to training, orientation or therapy that presents any form of blame or judgment on the basis of race, ethnicity or sex.
5. Removes the requirement that the Board of Technical Registration adopt rules, hear complaints and take disciplinary action only relating to the review of drawings, plans or design specifications.
6. Eliminates the requirement that the Board of Technical Registration only investigate a complaint or take a disciplinary or enforcement action if the complainant has a substantial nexus with the person who is subject to the complaint.
7. Restores the Home Inspectors Rules and Standards Committee.
8. Reinserts the authorization of the Board of Technical Registration to issue letters of concern to home inspector.
9. Makes conforming changes.
