SENATE AMENDMENTS TO S.B. 1034

1 Strike everything after the enacting clause and insert:

2 "Section 1. Title 6, chapter 12, article 1, Arizona Revised  
3 Statutes, is amended by adding section 6-1235, to read:

4 6-1235. Money transmission; transmission of money by wire or  
5 electronic transfer; consumer fraud warnings;  
6 requirements; applicability; civil penalty

7 A PERSON THAT IS IN THE BUSINESS OF MONEY TRANSMISSION SHALL  
8 CLEARLY AND PROMINENTLY DISPLAY CONSUMER FRAUD WARNINGS THAT INCLUDE ALL OF  
9 THE FOLLOWING:

10 1. THE RISKS OF CONSUMER FRAUD AND HOW TO FIND ADDITIONAL  
11 INFORMATION ABOUT CONSUMER FRAUD REGARDING MONEY TRANSMISSION.

12 2. INFORMATION ABOUT THE DANGERS OF TRANSMITTING MONEY TO UNKNOWN  
13 PERSONS OR TO PERSONS WHOM THE SENDER CANNOT VERIFY.

14 3. INFORMATION ABOUT HOW TO STOP A MONEY TRANSMISSION, IF THAT  
15 OPTION IS AVAILABLE.

16 4. INFORMATION WARNING THE SENDER THAT MONIES MAY NOT BE RETURNED  
17 ONCE THE MONEY TRANSMISSION IS COMPLETE.

18 B. THE PERSON SHALL COMMUNICATE THE INFORMATION AS PRESCRIBED IN  
19 SUBSECTION A OF THIS SECTION TO A CONSUMER BY ANY OF THE FOLLOWING METHODS:

20 1. IN PERSON, DIRECTLY TO THE CONSUMER.

21 2. DISPLAYED PROMINENTLY IN THE PLACE OF BUSINESS USING A FONT SIZE  
22 THAT IS LARGE ENOUGH FOR ANY CONSUMER TO READ. THE WRITTEN WARNING SHALL  
23 BE IN A TYPE THAT CONTRASTS WITH THE BACKGROUND AGAINST WHICH THE WRITTEN  
24 WARNING APPEARS.

1           3. DISPLAYED PROMINENTLY IN ANY ELECTRONIC NOTICE USING A FONT SIZE  
2        THAT IS LARGE ENOUGH FOR ANY CONSUMER TO READ. THE WRITTEN WARNING SHALL BE  
3        IN A TYPE THAT CONTRASTS WITH THE BACKGROUND AGAINST WHICH THE WRITTEN  
4        WARNING APPEARS.

5           C. THIS SECTION DOES NOT APPLY TO EITHER OF THE FOLLOWING:  
6           1. AN ELECTRONIC FUNDS TRANSFER WHERE THE MONIES ARE NOT TRANSFERRED  
7        DIRECTLY TO ANOTHER PERSON AND ARE NOT AVAILABLE FOR IMMEDIATE USE.

8           2. AN ELECTRONIC FUNDS TRANSFER THAT IS MADE WITH A GIFT  
9        CERTIFICATE.

10          D. A PERSON WHO VIOLATES THIS SECTION IS SUBJECT TO A CIVIL PENALTY  
11        OF NOT MORE THAN \$250 FOR EACH OFFENSE."
