7 A. IF, BY DECEMBER 31, 2024, AN ENTITY PAYS \$32,000 TO THE  
8 DEPARTMENT FOR THE IMPLEMENTATION OF THIS SECTION, THE DEPARTMENT SHALL  
9 ISSUE DIVINE NINE SPECIAL PLATES. THE ENTITY THAT PROVIDES THE \$32,000  
10 SHALL DESIGN THE DIVINE NINE SPECIAL PLATES. THE DESIGN AND COLOR OF THE  
11 DIVINE NINE SPECIAL PLATES ARE SUBJECT TO THE APPROVAL OF THE  
12 DEPARTMENT. FOR A SORORITY OR FRATERNITY THAT IS A MEMBER OF THE ENTITY  
13 DESCRIBED IN SUBSECTION E OF THIS SECTION, THE NAME OF THE SORORITY OR  
14 FRATERNITY MAY BE DISPLAYED ALONG THE BOTTOM OF THE SPECIAL PLATE AS  
15 APPROVED BY THE DEPARTMENT. THE DIRECTOR MAY ALLOW A REQUEST FOR DIVINE  
16 NINE SPECIAL PLATES TO BE COMBINED WITH A REQUEST FOR PERSONALIZED SPECIAL  
17 PLATES. IF THE DIRECTOR ALLOWS SUCH A COMBINATION, THE REQUEST SHALL BE IN  
18 A FORM PRESCRIBED BY THE DIRECTOR AND IS SUBJECT TO THE FEES FOR THE  
19 PERSONALIZED SPECIAL PLATES IN ADDITION TO THE FEES REQUIRED FOR THE DIVINE  
20 NINE SPECIAL PLATES.

21 B. OF THE \$25 FEE REQUIRED BY SECTION 28-2402 FOR THE ORIGINAL  
22 SPECIAL PLATES AND FOR RENEWAL OF SPECIAL PLATES, \$8 IS A SPECIAL PLATE  
23 ADMINISTRATION FEE AND \$17 IS AN ANNUAL DONATION.

24 C. THE DEPARTMENT SHALL DEPOSIT, PURSUANT TO SECTIONS 35-146 AND  
25 35-147, ALL SPECIAL PLATE ADMINISTRATION FEES IN THE STATE HIGHWAY FUND  
26 ESTABLISHED BY SECTION 28-6991 AND SHALL TRANSMIT ALL DONATIONS COLLECTED  
27 PURSUANT TO THIS SECTION TO THE DIVINE NINE SPECIAL PLATE FUND ESTABLISHED  
28 BY THIS SECTION.

1 D. THE DIVINE NINE SPECIAL PLATE FUND IS ESTABLISHED CONSISTING OF  
2 MONIES DEPOSITED PURSUANT TO THIS SECTION. THE DIRECTOR SHALL ADMINISTER  
3 THE FUND. MONIES IN THE FUND ARE CONTINUOUSLY APPROPRIATED.

4 E. THE DIRECTOR SHALL ANNUALLY ALLOCATE MONIES FROM THE FUND TO THE  
5 ENTITY THAT PAID THE IMPLEMENTATION FEE TO THE DEPARTMENT PURSUANT TO  
6 SUBSECTION A OF THIS SECTION. THE ENTITY MUST HAVE BEEN FOUNDED IN 2018  
7 AND HAVE A MISSION TO:

8 1. FOSTER COOPERATIVE ACTIONS OF ITS MEMBERS IN DEALING WITH MATTERS  
9 OF MUTUAL CONCERN.

10 2. PROMOTE THE WELL-BEING OF ITS AFFILIATE SORORITIES AND  
11 FRATERNITIES, FACILITATE THE ESTABLISHMENT AND DEVELOPMENT OF LOCAL  
12 COUNCILS AND PROVIDE LEADERSHIP TRAINING FOR ITS CONSTITUENTS.

13 3. EDUCATE CITIZENS AND COMMUNITIES IN THIS STATE IN THE INTEREST OF  
14 THE GENERAL PUBLIC THROUGH COMMUNITY EDUCATION, LITERATURE AND BROADCAST  
15 INFORMATION WITH RESPECT TO GOVERNMENT ISSUES ABOUT METHODOLOGIES AND  
16 STRATEGIES TO IMPROVE, MAINTAIN AND PROMOTE THE NEEDS AND KNOWLEDGE OF THE  
17 RESIDENTS OF THIS STATE, WITH RESPECT TO ECONOMIC DEVELOPMENT, PUBLIC  
18 SAFETY AND ACCESS TO EDUCATIONAL OPPORTUNITIES SO THAT THE RESIDENTS OF  
19 THIS STATE CAN SERVE FOR THE PROTECTION, CONSERVATION AND PRESERVATION OF  
20 THEIR HUMAN AND NATURAL ENVIRONMENT IN AND AROUND THIS STATE.

21 F. ON NOTICE FROM THE DIRECTOR, THE STATE TREASURER SHALL INVEST AND  
22 DIVEST MONIES IN THE FUND AS PROVIDED BY SECTION 35-313, AND MONIES EARNED  
23 FROM INVESTMENT SHALL BE CREDITED TO THE FUND."
