10 SUBMITTED PURSUANT TO THIS SUBSECTION MAY NOT BE MORE THAN FIVE  
11 DOUBLE-SPACED PAGES. REVIEW HEARINGS SHALL BE CONFIDENTIAL AND CONDUCTED  
12 IN AN INFORMAL MANNER. ARTICLE 10 OF THIS CHAPTER DOES NOT APPLY TO  
13 REVIEWS REQUESTED PURSUANT TO THIS SUBSECTION.

14 C. ON RECEIPT OF A PROPERLY SUBMITTED PETITION PURSUANT TO  
15 SUBSECTION B OF THIS SECTION, THE OFFICE OF ADMINISTRATIVE HEARINGS SHALL  
16 REVIEW THE DENIAL, SUSPENSION OR REVOCATION AND DETERMINE WHETHER THE  
17 OFFENSE IS SUBSTANTIALLY RELATED TO THE APPLICANT'S, LICENSEE'S,  
18 REGISTRANT'S OR CERTIFICATE HOLDER'S OCCUPATION OR IF APPROVING OR NOT  
19 IMPOSING A DISCIPLINARY ACTION AGAINST THE LICENSE, REGISTRATION OR  
20 CERTIFICATE WOULD POSE A REASONABLE THREAT TO PUBLIC HEALTH AND SAFETY.  
21 QUESTIONS FROM THE OFFICE OF ADMINISTRATIVE HEARINGS SHALL BE LIMITED TO  
22 ONLY MATTERS SPECIFIED IN THE PETITION.

1           D. EACH OCCUPATIONAL OR PROFESSIONAL LICENSING BOARD OR HEALTH  
2           PROFESSION REGULATORY BOARD SHALL POST PROMINENTLY ON THE BOARD'S WEBSITE  
3           AND ON EACH LICENSE, REGISTRATION OR CERTIFICATE DENIAL A NOTICE OF AN  
4           INDIVIDUAL'S RIGHT TO PETITION THE OFFICE OF ADMINISTRATIVE HEARINGS FOR  
5           REVIEW PURSUANT TO THIS SECTION."
