SENATE AMENDMENTS TO H.B. 2373
(Reference to House engrossed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Section 15-217.03, Arizona Revised Statutes, is amended
3 to read:

4 15-217.03. Community college adult education workforce
5 development program; fund; program schools;
6 student eligibility; annual reports

7 A. The community college adult education workforce development
8 program is established within the state board of education, to be
9 administered by the department of education, to provide adult learners with
10 integrated education and training ~~programs~~ AS DEFINED IN THE WORKFORCE
11 INNOVATION AND OPPORTUNITY ACT (P.L. 113-128; 128 STAT. 1425; 29 UNITED
12 STATES CODE 3272), and additional study and support services, ~~that lead to~~
13 ~~the issuance of~~ INCLUDING both of the following:

14 1. ACADEMIC INSTRUCTION THAT IS ALIGNED WITH ADULT EDUCATION AND
15 LITERACY ACTIVITIES AS DEFINED IN THE WORKFORCE INNOVATION AND OPPORTUNITY
16 ACT, INCLUDING INSTRUCTION THAT LEADS TO THE ISSUANCE OF a high school
17 diploma or high school equivalency diploma.

18 2. An industry-recognized credential, COMMUNITY COLLEGE CERTIFICATE
19 or community college degree.

20 B. To be eligible to participate in the program, the program
21 applicant must be a community college district that is established pursuant
22 to section 15-1402, that provides high school diplomas or high school
23 equivalency diplomas and that provides workforce training that leads to
24 industry-recognized credentials or workforce or degree programs, including
25 workforce programs accredited by a regional accrediting body recognized by

1 the United States department of education. If a program applicant meets
2 the requirements of this subsection, the department of education shall
3 distribute monies to the program applicant as prescribed in subsection ~~C~~ D
4 of this section.

5 C. A PROGRAM SCHOOL MAY RECEIVE MONIES UNDER SUBSECTION D OF THIS
6 SECTION FOR EACH ADULT LEARNER WHO IS A STUDENT IN THE PROGRAM, REGARDLESS
7 OF WHETHER THE ADULT LEARNER HAS A HIGH SCHOOL DIPLOMA OR HIGH SCHOOL
8 EQUIVALENCY DIPLOMA, IF THE ADULT LEARNER MEETS ALL OF THE FOLLOWING
9 REQUIREMENTS:

10 1. ENROLLS IN A COMMUNITY COLLEGE ADULT EDUCATION PROGRAM.

11 2. PARTICIPATES IN INTEGRATED EDUCATION AND TRAINING AS DEFINED IN
12 THE WORKFORCE INNOVATION AND OPPORTUNITY ACT, OR ITS SUCCESSOR.

13 3. PURSUES ACADEMIC SKILLS DEVELOPMENT RELATED TO ADULT EDUCATION
14 AND LITERACY ACTIVITIES AS DEFINED IN THE WORKFORCE INNOVATION AND
15 OPPORTUNITY ACT.

16 ~~C~~ D. The community college adult education workforce development
17 program fund is established consisting of legislative appropriations and
18 any other monies. The department of education shall administer the fund.
19 Monies in the fund are continuously appropriated and are exempt from the
20 provisions of section 35-190 relating to lapsing of appropriations.
21 Notwithstanding any other law, a program school shall be funded as follows:

22 1. The program school may receive up to \$3,000 per full-time student
23 in the program each fiscal year. Part-time students shall be funded in
24 proportion to the number of enrolled courses or hours of instruction.

25 2. The department of education shall distribute fund monies to all
26 program schools that meet the criteria prescribed in subsection B of this
27 section in a proportional manner based on the number of adult learners each
28 program school serves.

29 ~~D~~ E. A program school shall use monies received under this section
30 to ~~supplement and not supplant current program offerings~~ ENHANCE OR EXPAND
31 EXISTING ADULT EDUCATION PROGRAMS AND SERVICES. In addition to any monies
32 received from the fund, a program school may accept and spend federal

monies and private grants, gifts, contributions and devises to assist the program school in carrying out the purposes of this section. A program school shall use monies received under subsection ~~E~~ D of this section for adult learners to participate in ~~a high school diploma or high school equivalency diploma~~ AN ADULT EDUCATION program that ~~also~~ offers ACADEMIC INSTRUCTION AND an industry-recognized credential, A COMMUNITY COLLEGE CERTIFICATE or A community college degree. A portion of monies may be used for additional support services to ensure the success of adult learners in the program, including the following:

1. Transportation assistance for adult learners with a demonstrated need.
2. Child care services for dependents of adult learners while the adult learner is on-site.
3. College and career counseling.
4. Job placement assistance.

~~E~~. F. For each year that monies are appropriated by the legislature to the fund established by subsection ~~E~~ D of this section, on or before October 30, each participating community college shall submit a report regarding the community college adult education workforce development program to the department of education. The department of education shall compile the reports received from each participating community college and, on or before December 15 of each year, shall provide an annual report to the governor, the president of the senate, the speaker of the house of representatives and the state board of education and shall provide a copy of this report to the secretary of state. Each report shall include, at a minimum, all of the following information for each participating community college for the preceding school year:

1. The number of adult learners enrolled in the program.
2. The completion rate of high school diplomas and high school equivalency diplomas earned by adult learners enrolled in the program.
3. The average progress of adult learners toward meeting completion criteria.

1 4. The number and type of industry-recognized credentials, **COMMUNITY**
2 **COLLEGE CERTIFICATES**, community college degree credits and community
3 college degrees earned by adult learners enrolled in the program.

4 5. A descriptive summary of the community college adult education
5 workforce development program offered.

6 6. The number of adult learners who have newly acquired proficiency
7 in the English language.

8 7. The information required by the performance measures adopted by
9 the state board of education pursuant to section 15-217.

10 ~~F.~~ **G.** The state board of education, in cooperation with the
11 department of education, may request information from any program applicant
12 or program school for the purposes of determining program eligibility and
13 funding distributions under this section.

14 ~~G.~~ **H.** The state board of education, in cooperation with the
15 department of education, may develop a process to bring a program school
16 into compliance or revoke the program school's authorization to participate
17 in the program, at the discretion of the state board of education.

18 ~~H.~~ **I.** The department of education shall provide adequate staff
19 support for the state board of education to comply with this section."
