AN ACT

AMENDING TITLE 13, CHAPTER 35, ARIZONA REVISED STATUTES, BY ADDING SECTION 13-3508; RELATING TO OBSCENITY.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 13, chapter 35, Arizona Revised Statutes, is
3 amended by adding section 13-3508, to read:

4 13-3508. Unlawful dissemination of deep fake recordings or
5 images depicting intimate parts or sexual acts;
6 classification; definitions

7 A. IT IS UNLAWFUL TO INTENTIONALLY DISSEMINATE A DEEP FAKE
8 RECORDING OR IMAGE IF ALL OF THE FOLLOWING APPLY:

9 1. THE PERSON THAT DISSEMINATES THE DEEP FAKE RECORDING OR IMAGE
10 KNOWS OR REASONABLY SHOULD KNOW THAT THE DEPICTED INDIVIDUAL DOES NOT
11 CONSENT TO THE DISSEMINATION.

12 2. THE DEEP FAKE RECORDING OR IMAGE REALISTICALLY DEPICTS ANY OF
13 THE FOLLOWING:

14 (a) THE INTIMATE PARTS OF ANOTHER INDIVIDUAL THAT ARE PRESENTED AS
15 THE INTIMATE PARTS OF THE DEPICTED INDIVIDUAL.

16 (b) ARTIFICIALLY GENERATED INTIMATE PARTS PRESENTED THAT ARE AS THE
17 INTIMATE PARTS OF THE DEPICTED INDIVIDUAL.

18 (c) THE DEPICTED INDIVIDUAL ENGAGING IN A SEXUAL ACT.

19 3. THE DEPICTED INDIVIDUAL IS IDENTIFIABLE BY ANY OF THE FOLLOWING:

20 (a) FROM THE DEEP FAKE RECORDING OR IMAGE ITSELF.

21 (b) BY THE DEPICTED INDIVIDUAL OR BY ANOTHER PERSON.

22 (c) FROM THE PERSONAL INFORMATION THAT IS DISPLAYED IN CONNECTION
23 WITH THE DEEP FAKE RECORDING OR IMAGE.

24 B. A VIOLATION OF THIS SECTION IS A CLASS 6 FELONY, EXCEPT THAT IT
25 IS A CLASS 4 FELONY IF ANY OF THE FOLLOWING APPLIES:

26 1. THE DEPICTED PERSON SUFFERS ANY FINANCIAL LOSS DUE TO THE
27 DISSEMINATION OF THE DEEP FAKE RECORDING OR IMAGE.

28 2. THE PERSON DISSEMINATES THE DEEP FAKE RECORDING OR IMAGE WITH
29 THE INTENT TO PROFIT FROM THE DISSEMINATION.

30 3. THE PERSON MAINTAINS AN INTERNET WEBSITE, ONLINE SERVICE, ONLINE
31 APPLICATION OR MOBILE APPLICATION TO DISSEMINATE THE DEEP FAKE RECORDING
32 OR IMAGE.

33 4. THE PERSON POSTS THE DEEP FAKE RECORDING OR IMAGE ON AN INTERNET
34 WEBSITE.

35 5. THE PERSON DISSEMINATES THE DEEP FAKE RECORDING OR IMAGE WITH
36 INTENT TO HARASS THE DEPICTED PERSON.

37 6. THE PERSON OBTAINS THE DEEP FAKE RECORDING OR IMAGE BY
38 COMMITTING A THEFT, A CRIMINAL TRESPASS OR COMPUTER TAMPERING OR
39 UNAUTHORIZED COMPUTER ACCESS.

40 7. THE PERSON HAS PREVIOUSLY BEEN CONVICTED OF A VIOLATION OF THIS
41 SECTION.

42 C. FOR THE PURPOSES OF THIS SECTION:

43 1. "DEEP FAKE RECORDING OR IMAGE" MEANS ANY VIDEO RECORDING, MOTION
44 PICTURE FILM, SOUND RECORDING, ELECTRONIC IMAGE OR PHOTOGRAPH OR ANY

1 TECHNOLOGICAL REPRESENTATION OF SPEECH OR CONDUCT SUBSTANTIALLY DERIVATIVE
2 THEREOF AND THAT BOTH:

3 (a) APPEARS TO AUTHENTICALLY DEPICT ANY SPEECH OR CONDUCT OF AN
4 INDIVIDUAL WHO DID NOT IN FACT ENGAGE IN THE SPEECH OR CONDUCT.

5 (b) THE PRODUCTION OF WHICH WAS SUBSTANTIALLY DEPENDENT ON
6 TECHNICAL MEANS RATHER THAN THE ABILITY OF ANOTHER INDIVIDUAL TO
7 PHYSICALLY OR VERBALLY IMPERSONATE THE INDIVIDUAL.

8 2. "DEPICTED INDIVIDUAL" MEANS AN INDIVIDUAL IN A DEEP FAKE
9 RECORDING OR IMAGE WHO APPEARS TO BE ENGAGING IN SPEECH OR CONDUCT THAT
10 THE INDIVIDUAL DID NOT ENGAGE IN.

11 3. "DISSEMINATION" MEANS DISTRIBUTION TO ONE OR MORE PERSONS, OTHER
12 THAN THE PERSON DEPICTED IN THE DEEP FAKE RECORDING OR IMAGE OR
13 PUBLICATION BY ANY PUBLICLY AVAILABLE MEDIUM.

14 4. "HARASS" MEANS AN ACT THAT WOULD CAUSE A SUBSTANTIAL ADVERSE
15 EFFECT ON THE SAFETY, SECURITY OR PRIVACY OF A REASONABLE PERSON.

16 5. "INTIMATE PARTS" MEANS THE GENITALS, PUBIC AREA OR ANUS OF AN
17 INDIVIDUAL, OR IF THE INDIVIDUAL IS FEMALE, A PARTIALLY OR FULLY EXPOSED
18 NIPPLE.

19 6. "PERSONAL INFORMATION" MEANS ANY IDENTIFIER THAT PERMITS
20 COMMUNICATION OR IN-PERSON CONTACT WITH A PERSON, INCLUDING ANY OF THE
21 FOLLOWING:

22 (a) A PERSON'S FIRST AND LAST NAMES, FIRST INITIAL AND LAST NAME,
23 FIRST NAME AND LAST INITIAL OR NICKNAME.

24 (b) A PERSON'S HOME, SCHOOL OR WORK ADDRESS.

25 (c) A PERSON'S TELEPHONE NUMBER, EMAIL ADDRESS OR SOCIAL MEDIA
26 ACCOUNT INFORMATION.

27 (d) A PERSON'S GEOLOCATION DATA.

28 7. "SEXUAL ACT" MEANS EITHER SEXUAL CONTACT OR SEXUAL PENETRATION.

29 8. "SEXUAL CONTACT" MEANS THE INTENTIONAL TOUCHING OF INTIMATE
30 PARTS OR INTENTIONAL TOUCHING WITH SEMINAL FLUID OR SPERM ONTO ANOTHER
31 INDIVIDUAL'S BODY.

32 9. "SEXUAL PENETRATION" MEANS EITHER OF THE FOLLOWING ACTS:

33 (a) SEXUAL INTERCOURSE, CUNNILINGUS, FELLATIO OR ANAL INTERCOURSE.

34 (b) ANY INTRUSION, HOWEVER SLIGHT, INTO THE GENITAL OR ANAL OPENING
35 OF AN INDIVIDUAL BY ANOTHER'S BODY PART OR AN OBJECT USED BY ANOTHER FOR
36 THIS PURPOSE.

37 10. "SOCIAL MEDIA" MEANS ANY ELECTRONIC MEDIUM, INCLUDING AN
38 INTERACTIVE COMPUTER SERVICE, TELEPHONE NETWORK OR DATA NETWORK, THAT
39 ALLOWS USERS TO CREATE, SHARE AND VIEW USER-GENERATED CONTENT.
