HOUSE OF REPRESENTATIVES AMENDMENTS TO H.B. 2168

(Reference to printed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Section 11-811, Arizona Revised Statutes, is amended to
3 read:

4 11-811. Zoning ordinance; zoning districts; definitions

5 A. Pursuant to this article, the board of supervisors may adopt a
6 zoning ordinance in order to conserve and promote the public health,
7 safety, convenience and general welfare. The zoning ordinance and all
8 rezonings and zoning regulations amendments adopted under this article
9 shall be consistent with and conform to the adopted comprehensive plan. In
10 addition to the other matters that are required or authorized under this
11 section and article 1 of this chapter, the zoning ordinance:

12 1. Shall show the zoning districts designated as appropriate for
13 various classes of residential, business and industrial uses and shall
14 provide for the establishment of setback lines and other plans providing
15 for adequate light, air and parking facilities and for expediting traffic
16 within the districts.

17 2. May establish the percentage of a lot or parcel that may be
18 covered by buildings and the size of yards, courts and other open spaces.

19 3. Shall consider access to incident solar energy.

20 4. May provide for retirement community zoning districts.

21 5. May provide for the regulation and use of business licenses,
22 adult oriented business manager permits and adult service provider permits
23 in conjunction with the establishment or operation of adult oriented
24 businesses and facilities, including adult arcades, adult bookstores or
25 video stores, cabarets, adult live entertainment establishments, adult

1 motion picture theaters, adult theaters, massage establishments and nude
2 model studios. With respect to cabarets, the ordinance shall not conflict
3 with specific statutory or valid regulatory requirements applicable to
4 persons licensed to dispense alcoholic beverages, but the ordinance may
5 include regulation of the age and conduct of erotic entertainers in a
6 manner at least as restrictive as rules adopted under title 4.
7 Notwithstanding section 11-812, a county in regulating or licensing
8 businesses and facilities pursuant to this paragraph may impose reasonable
9 operating requirements that affect the existing uses of businesses and
10 facilities.

11 6. Shall designate and zone appropriate areas of reasonable size in
12 which there may be established with reasonable permanency canneries,
13 fertilizer plants, refineries, commercial feedlots, meat packing plants,
14 tallow works and other like businesses. A dairy operation, including areas
15 designated for the raising of replacement heifers or bulls owned by the
16 same dairy operation, is not subject to this paragraph, and is a general
17 agricultural purpose under subsection D, paragraph 2 of this section and
18 section 11-812, subsection A, paragraph 2. A replacement heifer or bull
19 raising operation of a dairy that is not on contiguous property of the
20 dairy is subject to this paragraph unless the operation begins within
21 one-quarter mile of the dairy.

22 B. To carry out the purposes of this article, the board may adopt
23 overlay zoning districts and regulations applicable to particular
24 buildings, structures and land within individual zones. For the purposes
25 of this subsection, "overlay zoning district" means a special zoning
26 district that includes regulations that modify regulations in another
27 zoning district with which the overlay zoning district is combined.
28 Overlay zoning districts and regulations shall be adopted pursuant to
29 section 11-813. The provisions of overlay zoning shall apply retroactively
30 to authorize overlay zoning districts and regulations adopted before April
31 20, 1993.

32 C. In accordance with article II, sections 1 and 2, Constitution of
33 Arizona, the board shall consider the individual property rights and

1 personal liberties of the residents of the county before adopting any
2 zoning ordinance.

3 D. This section does not authorize:

4 1. The imposition of dedications, exactions, fees or other
5 requirements that are not otherwise authorized by law.

6 2. The regulation or restriction of the use or occupation of land or
7 improvements for railroad, mining, metallurgical, grazing or general
8 agricultural purposes, if the tract concerned is five or more contiguous
9 commercial acres. For the purposes of this paragraph, general agricultural
10 purposes do not include the cultivation of cannabis as defined in section
11 13-3401 or marijuana as defined in section 13-3401 or 36-2801.

12 E. For the purposes of this section:

13 1. "Adult arcade" means any place to which the public is ~~permitted~~
14 **ALLOWED** or invited and in which coin-operated or slug-operated or
15 electronically, electrically or mechanically controlled still or motion
16 picture machines, projectors or other ~~image-producing~~ **IMAGE-PRODUCING**
17 devices are maintained to show images involving specific sexual activities
18 or specific anatomical areas to persons in booths or viewing rooms.

19 2. "Adult bookstore or video store" means a commercial establishment
20 that offers for sale or rent any of the following as one of its principal
21 business purposes:

22 (a) Books, magazines, periodicals or other printed matter,
23 photographs, films, motion pictures, videocassettes or reproductions or
24 slides or other visual representations that depict or describe specific
25 sexual activities or specific anatomical areas.

26 (b) Instruments, devices or paraphernalia that are designed for use
27 in connection with specific sexual activities.

28 3. "Adult live entertainment establishment" means an establishment
29 that features either:

30 (a) Persons who appear in a state of nudity.

31 (b) Live performances that are characterized by the exposure of
32 specific anatomical areas or specific sexual activities.

1 4. "Adult motion picture theater" means a commercial establishment
2 in which for any form of consideration films, motion pictures,
3 videocassettes, slides or other similar photographic reproductions that are
4 characterized by the depiction or description of specific sexual activities
5 or specific anatomical areas are predominantly shown.

6 5. "Adult oriented business" means adult arcades, adult bookstores
7 or video stores, cabarets, adult live entertainment establishments, adult
8 motion picture theaters, adult theaters, massage establishments that offer
9 adult service or nude model studios.

10 6. "Adult oriented business manager" means a person on the premises
11 of an adult oriented business who is authorized to exercise overall
12 operational control of the business.

13 7. "Adult service" means dancing, serving food or beverages,
14 modeling, posing, wrestling, singing, reading, talking, listening or other
15 performances or activities conducted for any consideration in an adult
16 oriented business by a person who is nude or seminude during all or part of
17 the time that the person is providing the service.

18 8. "Adult service provider" or "erotic entertainer" means any
19 natural person who provides an adult service.

20 9. "Adult theater" means a theater, concert hall, auditorium or
21 similar commercial establishment that predominantly features persons who
22 appear in a state of nudity or who engage in live performances that are
23 characterized by the exposure of specific anatomical areas or specific
24 sexual activities.

25 10. "Cabaret" means an adult oriented business licensed to provide
26 alcoholic beverages pursuant to title 4, chapter 2, article 1.

27 11. "Discernibly turgid state" means the state of being visibly
28 swollen, bloated, inflated or distended.

29 12. "Massage establishment" means an establishment in which a
30 person, firm, association or corporation engages in or permits massage
31 activities, including any method of pressure on, friction against,
32 stroking, kneading, rubbing, tapping, pounding, vibrating or stimulating of
33 external soft parts of the body with the hands or with the aid of any

1 mechanical apparatus or electrical apparatus or appliance. This paragraph
2 does not apply to:

3 (a) Persons who are licensed pursuant to title 32, chapter 7, 8, 13,
4 14 or 17.

5 (b) Registered nurses, licensed practical nurses or technicians who
6 are acting under the supervision of a physician who is licensed pursuant to
7 title 32, chapter 13 or 17.

8 (c) Registered nurse practitioners who are licensed pursuant to
9 title 32, chapter 15.

10 (d) Persons who are employed or acting as trainers for a bona fide
11 amateur, semiprofessional or professional athlete or athletic team.

12 (e) Persons who are licensed pursuant to title 32, chapter ~~3 or~~ 5 if
13 the activity is limited to the head, face or neck.

14 13. "Nude model studio" means a place in which a person who appears
15 in a state of nudity or who displays specific anatomical areas is observed,
16 sketched, drawn, painted, sculptured, photographed or otherwise depicted by
17 other persons who pay money or other consideration. Nude model studio does
18 not include a proprietary school that is licensed by this state, a college,
19 community college or university that is supported entirely or in part by
20 taxation, a private college or university that maintains and operates
21 educational programs in which credits are transferable to a college,
22 community college or university that is supported entirely or in part by
23 taxation or a structure to which the following apply:

24 (a) A sign is not visible from the exterior of the structure and no
25 other advertising appears indicating that a nude person is available for
26 viewing.

27 (b) A student must enroll at least three days in advance of a class
28 in order to participate.

29 (c) No more than one nude or seminude model is on the premises at
30 any time.

31 14. "Nude", "nudity" or "state of nudity" means any of the
32 following:

1 (a) The appearance of a human anus, genitals or a female breast
2 below a point immediately above the top of the areola.

3 (b) A state of dress that fails to opaquely cover a human anus,
4 genitals or a female breast below a point immediately above the top of the
5 areola.

6 15. "Principal business purposes" means that a commercial
7 establishment derives fifty percent or more of its gross income from the
8 sale or rental of items listed in paragraph 2 of this subsection.

9 16. "Seminude" means a state of dress in which clothing covers no
10 more than the genitals, pubic region and female breast below a point
11 immediately above the top of the areola, as well as portions of the body
12 that are covered by supporting straps or devices.

13 17. "Specific anatomical areas" means any of the following:

14 (a) A human anus, genitals, the pubic region or a female breast
15 below a point immediately above the top of the areola that is less than
16 completely and opaquely covered.

17 (b) Male genitals in a discernibly turgid state even if completely
18 and opaquely covered.

19 18. "Specific sexual activities" means any of the following:

20 (a) Human genitals in a state of sexual stimulation or arousal.

21 (b) Sex acts, normal or perverted, actual or simulated, including
22 acts of human masturbation, sexual intercourse, oral copulation or sodomy.

23 (c) Fondling or other erotic touching of the human genitals, pubic
24 region, buttocks, anus or female breast.

25 (d) Excretory functions as part of or in connection with any of the
26 activities under subdivision (a), (b) or (c) of this paragraph.

27 Sec. 2. Repeal

28 Title 32, chapter 3, Arizona Revised Statutes, is repealed.

29 Sec. 3. Heading change

30 A. The chapter heading of title 32, chapter 5, Arizona Revised
31 Statutes, is changed from "COSMETOLOGY" to "BARBERING AND COSMETOLOGY".

32 B. The article heading of title 32, chapter 5, article 2, Arizona
33 Revised Statutes, is changed from "COSMETOLOGISTS, AESTHETICIANS, NAIL

1 TECHNICIANS, HAIRSTYLISTS AND EYELASH TECHNICIANS" to "BARBERING AND
2 COSMETOLOGY PROFESSIONALS".

3 Sec. 4. Section 32-501, Arizona Revised Statutes, is amended to
4 read:

5 32-501. Definitions

6 In this chapter, unless the context otherwise requires:

7 1. "Aesthetician":

8 (a) Means a person who is licensed to practice skin care pursuant to
9 this chapter.

10 (b) Does not include an eyelash technician.

11 2. "Aesthetics" means any one or a combination of the following
12 practices if they are performed for cosmetic purposes:

13 (a) Massaging, cleansing, stimulating, manipulating, exercising,
14 beautifying or applying oils, creams, antiseptics, clays, lotions or other
15 preparations, either by hand or by mechanical or electrical appliances.

16 (b) Arching eyebrows or tinting eyebrows and eyelashes.

17 (c) Removing superfluous hair by means other than electrolysis or
18 threading.

19 3. "BARBER" MEANS A PERSON WHO IS LICENSED TO PRACTICE BARBERING
20 PURSUANT TO THIS CHAPTER.

21 ~~3.~~ 4. "Barbering" ~~has the same meaning prescribed in section~~
22 ~~32-301.~~ MEANS ANY ONE OR A COMBINATION OF THE FOLLOWING PRACTICES IF THEY
23 ARE PERFORMED ON A PERSON'S HEAD, FACE, NECK OR SHOULDERS FOR COSMETIC
24 PURPOSES:

25 (a) CUTTING, CLIPPING OR TRIMMING HAIR.

26 (b) MASSAGING, CLEANSING, STIMULATING, MANIPULATING, EXERCISING,
27 BEAUTIFYING OR APPLYING OILS, CREAMS, ANTISEPTICS, CLAYS, LOTIONS OR OTHER
28 PREPARATIONS, EITHER BY HAND OR BY MECHANICAL OR ELECTRICAL APPLIANCES.

29 (c) STYLING, ARRANGING, DRESSING, CURLING, WAVING, PERMANENT WAVING,
30 STRAIGHTENING, CLEANSING, SINGEING, BLEACHING, DYEING, TINTING, COLORING OR
31 SIMILARLY TREATING HAIR.

32 (d) PROVIDING HAIR ATTACHMENTS, EXTENSIONS, HAIRPIECES AND WIGS WHEN
33 PERFORMED BY A BARBER.

1 (e) SHAVING OR TRIMMING A BEARD.

2 (f) PROVIDING SKIN CARE, INCLUDING FACIALS, CORRECTIVE TREATMENTS,
3 BLACKHEAD AND ACNE REMOVAL AND MASKS AND TREATMENT CREAMS.

4 (g) REMOVING UNWANTED HAIR BY MEANS OTHER THAN ELECTROLYSIS OR
5 THREADING.

6 ~~4.~~ 5. "Board" means the barbering and cosmetology board.

7 ~~5.~~ 6. "Cosmetic purposes" means for the purpose of beautifying,
8 preserving or conferring comeliness, excluding therapeutic massage and
9 manipulations.

10 ~~6.~~ 7. "Cosmetologist" means a person who is licensed to practice
11 cosmetology pursuant to this chapter.

12 ~~7.~~ 8. "Cosmetology":

13 (a) Means any one or a combination of the following practices if
14 they are performed for cosmetic purposes:

15 (i) Massaging, cleansing, stimulating, manipulating, exercising,
16 beautifying or applying oils, creams, antiseptics, clays, lotions or other
17 preparations, either by hand or by mechanical or electrical appliances.

18 (ii) Arching eyebrows or tinting eyebrows and eyelashes.

19 (iii) Removing superfluous hair by means other than electrolysis or
20 threading.

21 (iv) Nail technology.

22 (v) Hairstyling.

23 (b) Does not include performing personal services related to eyelash
24 extensions.

25 ~~8.~~ 9. "Electrical appliances" means devices that use electrical
26 current and includes lasers and IPL devices as defined in section 32-516.

27 10. "ESTABLISHMENT" MEANS ANY OF THE FOLLOWING:

28 (a) AN ESTABLISHMENT OR SHOP THAT IS OPERATED FOR THE PURPOSE OF
29 ENGAGING IN THE PRACTICE OF BARBERING, COSMETOLOGY, AESTHETICS, NAIL
30 TECHNOLOGY, HAIRSTYLING OR EYELASH EXTENSIONS OR ANY COMBINATION OF THE
31 PRACTICES LISTED IN THIS SUBDIVISION.

32 (b) AN ESTABLISHMENT OR SHOP TOGETHER WITH A RETROFITTED MOTOR
33 VEHICLE THAT IS USED EXCLUSIVELY AS A MOBILE FACILITY FOR THE PURPOSE OF

1 ENGAGING IN THE PRACTICE OF BARBERING, COSMETOLOGY, AESTHETICS, NAIL
2 TECHNOLOGY OR HAIRSTYLING OR ANY COMBINATION OF THE PRACTICES LISTED IN
3 THIS SUBDIVISION AND THAT IS OPERATED AND DISPATCHED THROUGH THE
4 ESTABLISHMENT.

5 (c) A RETROFITTED MOTOR VEHICLE THAT IS EXCLUSIVELY USED AS A MOBILE
6 FACILITY FOR THE PURPOSE OF ENGAGING IN THE PRACTICE OF BARBERING,
7 COSMETOLOGY, AESTHETICS, NAIL TECHNOLOGY OR HAIRSTYLING OR ANY COMBINATION
8 OF THE PRACTICES LISTED IN THIS SUBDIVISION AND THAT IS OPERATED AND
9 DISPATCHED FROM A BUSINESS THAT HAS A PHYSICAL STREET ADDRESS ON FILE WITH
10 THE BOARD.

11 ~~9.~~ 11. "Eyelash extensions":

12 (a) Means applying, removing and trimming threadlike natural or
13 synthetic fibers to an eyelash.

14 (b) Includes cleansing the eye area and lashes.

15 (c) Does not include applying eyelash enhancements that are tattoos,
16 color agents, straightening agents, permanent wave solutions or bleaching
17 agents to the eyebrow or any other cosmetology service.

18 ~~10.~~ 12. "Eyelash technician" means a person who is not licensed as
19 a cosmetologist or aesthetician and who for compensation performs personal
20 services limited to eyelash extensions.

21 ~~11.~~ 13. "Hairstyling" means any of the following:

22 (a) Cutting, clipping or trimming hair.

23 (b) Styling, arranging, dressing, curling, waving, permanent waving,
24 straightening, cleansing, singeing, bleaching, dyeing, tinting, coloring or
25 similarly treating hair.

26 (c) Removing superfluous hair from the neck up by means other than
27 electrolysis or threading.

28 ~~12.~~ 14. "Hairstylist" means a person who is licensed to practice
29 hairstyling pursuant to this chapter.

30 ~~13.~~ 15. "Instructor" means a person who is licensed to teach
31 BARBERING, cosmetology, aesthetics, nail technology or hairstyling, or any
32 combination ~~thereof~~ OF THESE PRACTICES, pursuant to this chapter.

1 ~~14.~~ 16. "Mentor" means a cosmetologist, AESTHETICIAN, BARBER,
2 HAIRSTYLIST OR NAIL TECHNICIAN who is approved by the board to train a
3 person in a department of economic security-approved apprenticeship program
4 in cosmetology OR BARBERING in an establishment that is licensed by the
5 board.

6 ~~15.~~ 17. "Nail technician" means a person who is licensed to
7 practice nail technology pursuant to this chapter.

8 ~~16.~~ 18. "Nail technology" means any of the following:

9 (a) Cutting, trimming, polishing, coloring, tinting, cleansing or
10 otherwise treating a person's nails.

11 (b) Applying artificial nails.

12 (c) Massaging and cleaning a person's hands, arms, legs and feet.

13 ~~17. "Salon" means any of the following:~~

14 ~~(a) An establishment that is operated for the purpose of engaging in~~
15 ~~the practice of cosmetology, aesthetics, nail technology or hairstyling, or~~
16 ~~any combination of the listed practices.~~

17 ~~(b) An establishment together with a retrofitted motor vehicle for~~
18 ~~exclusive use as a mobile facility for the purpose of engaging in the~~
19 ~~practice of cosmetology, aesthetics, nail technology or hairstyling, or any~~

21 ~~through the establishment.~~

22 ~~(c) A retrofitted motor vehicle that is exclusively used as a mobile~~
23 ~~facility for the purpose of engaging in the practice of cosmetology,~~
24 ~~aesthetics, nail technology or hairstyling, or any combination of the~~
25 ~~listed practices, and that is operated and dispatched from a business that~~
26 ~~has a physical street address on file with the board.~~

27 ~~18.~~ 19. "School" means an establishment that is operated for the
28 purpose of teaching barbering, cosmetology, aesthetics, nail technology or
29 hairstyling, or any combination of ~~the listed~~ THESE practices.

30 ~~19.~~ 20. "Threading" means a service that results in the removal of
31 hair from its follicle from around the eyebrows and from other parts of the
32 face with the use of a single strand of cotton thread and an

1 over-the-counter astringent, if the service does not use chemicals of any
2 kind, wax or any implements, instruments or tools to remove hair.

3 Sec. 5. Section 32-503, Arizona Revised Statutes, is amended to
4 read:

5 32-503. Organization; meetings; personnel; compensation

6 A. The board shall annually elect a ~~chairman~~ CHAIRPERSON, vice
7 ~~chairman~~ CHAIRPERSON and secretary-treasurer from among its membership.

8 B. The board shall hold at least one regular meeting monthly and may
9 hold other meetings at times and places it designates.

10 C. Subject to title 41, chapter 4, article 4, the board may employ
11 the following personnel as it deems necessary to carry out the purposes of
12 this chapter ~~and chapter 3 of this title~~ and designate their duties:

13 1. An executive director.

14 ~~2. A supervisor of examinations who is an instructor licensed~~
15 ~~pursuant to this chapter or chapter 3 of this title and who has worked at~~

30 32-504. Powers and duties

31 A. The board shall:

1 (a) Sanitary and safety requirements for ~~salons~~ ESTABLISHMENTS and
2 schools. ~~And~~

3 (b) Sanitary and safety standards for the ~~practice~~ PRACTICES of
4 BARBERING, cosmetology, aesthetics, nail technology and hairstyling.

5 (c) MOBILE FACILITY REQUIREMENTS.

6 2. Administer and enforce this chapter and rules adopted pursuant to
7 this chapter.

8 3. Either prepare, administer and grade practical and written
9 examinations or contract with a national professional organization for
10 AESTHETICS, BARBERING, cosmetology, HAIRSTYLING AND NAIL TECHNOLOGY THAT IS

8 Sec. 7. Section 32-506, Arizona Revised Statutes, is amended to
9 read:

10 32-506. Nonapplicability of chapter

11 This chapter does not apply to the following persons while in the
12 proper discharge of their professional duties:

13 1. Medical practitioners who are licensed pursuant to this title if
14 the practices treat physical or mental ailments or disease.

15 2. Commissioned physicians and surgeons who are serving in the armed
16 forces of the United States or other federal agencies.

17 3. Persons who are licensed pursuant to ~~chapter 3 of this title or~~
18 ~~who work in a profession that is regulated under~~ chapter 12 of this title.

19 4. Students who are attending schools licensed by the board while
20 they are on school premises during school hours or off campus at a
21 school-sponsored event.

22 5. Persons employed by theatrical groups who apply makeup, oils and
23 cosmetics.

24 6. Persons who sell makeup, oils and cosmetics and who apply such
25 products during the process of selling such products.

26 7. Shampoo assistants who shampoo hair under the direction of a
27 BARBER, cosmetologist or hairstylist licensed pursuant to this chapter.

28 8. Services performed by and for persons who are in the custody of
29 the state department of corrections.

30 9. Persons who apply makeup, oils and cosmetics to patients in a
31 hospital, nursing home or residential care institution with the consent of
32 the patient and the hospital, nursing home or residential care institution.

1 10. Persons who provide a service that results in tension on hair
