HOUSE OF REPRESENTATIVES AMENDMENTS TO H.B. 2587

 - 8 "Sec. 4. Vulnerable adult system study committee; membership;
duties; report; delayed repeal
 - 10 A. The vulnerable adult system study committee is established
11 consisting of the following members:
 - 12 1. Two members of the house of representatives who are appointed by
13 the speaker of the house of representatives and who are members of
14 different political parties. The speaker of the house of representatives
15 shall designate one of these members to serve as cochairperson of the
16 committee.
 - 17 2. Two members of the senate who are appointed by the president of
18 the senate and who are members of different political parties. The
19 president of the senate shall designate one of these members to serve as
20 cochairperson of the committee.
 - 21 3. The director of the department of health services or the
22 director's designee.

1 4. The director of the department of economic security or the
2 director's designee.

3 5. The director of the Arizona health care cost containment system
4 or the director's designee.

5 6. One member who represents the governor's office and who is
6 appointed by the governor.

7 7. One member who represents the attorney general's office and who
8 is appointed by the attorney general.

9 8. One member who currently serves as the department of economic
10 security's long-term care ombudsman or the ombudsman's designee.

11 9. One member who currently serves as a public fiduciary and who is
12 appointed by the governor.

13 10. Two members who are employed by a local law enforcement agency
14 or who are employed by a statewide organization that represents law
15 enforcement and who are appointed by the governor.

16 11. The executive director of the Navajo area agency on aging or the
17 executive director's designee.

18 12. The executive director of the intertribal council of Arizona or
19 the executive director's designee.

20 13. One member who is currently employed at a licensed assisted
21 living facility and who is appointed by the speaker of the house of
22 representatives.

23 14. One member who is currently employed at a licensed nursing care
24 institution and who is appointed by the governor.

25 15. Two members who represent different statewide organizations that
26 advocate for elderly vulnerable adults and who are appointed by the
27 president of the senate.

1 16. One health care professional who is appointed by the speaker of
2 the house of representatives and who both:

- 3 (a) Is licensed pursuant to title 32, Arizona Revised Statutes.
4 (b) Provides health care services to elderly vulnerable adults.

5 B. The vulnerable adult system study committee shall:

6 1. Develop and implement a coordinated vulnerable adult delivery
7 system that ensures the health and safety of vulnerable adults.

8 2. Recommend best practices relating to responding and investigating
9 complaints.

10 3. Research best practices related to adult protective services at
11 the state, municipality and community levels.

12 4. Research and make recommendations on how the vulnerable adult
13 system can ensure that vulnerable adults receive services they require
14 after the vulnerable adult system completes its investigatory duties,
15 including assigning a specific agency the responsibility to provide or
16 coordinate case management.

17 5. Research and identify common, statewide outcomes.

18 6. Identify best practices for data collection and data sharing by
19 various entities involved in providing vulnerable adult services.

20 7. Review and recommend changes to the statutes and rules that
21 govern vulnerable adult services.

22 C. The cochairpersons may designate work groups to research, study
23 and make recommendations to the study committee.

24 D. Once a strategic direction is established, the department of
25 economic security, in conjunction with the work groups, shall develop an
26 action plan for implementation.

27 E. Public members are eligible to receive reimbursement of expenses
28 pursuant to title 38, chapter 4, article 2, Arizona Revised Statutes.

1 F. On or before October 1, 2025, the study committee shall submit a
2 report of its findings and recommendations to the governor, the president
3 of the senate and the speaker of the house of representatives and shall
4 provide a copy of this report to the secretary of state.

5 G. This section is repealed from and after December 31, 2025."
