4 INCLUDE INFORMATION RELEVANT TO CLASS G LICENSURE IN THIS STATE, INCLUDING
5 THE RESTRICTIONS PRESCRIBED IN SECTION 28-3174 TO ENSURE STUDENTS ARE WELL
6 PREPARED FOR THE STAGES AND REQUIREMENTS OF CLASS G LICENSURE. IF THE

11 3. PROGRESS TRACKING FEATURES TO MONITOR A STUDENT'S ADVANCEMENT
12 THROUGH THE COURSE MATERIAL.

13 4. REGULAR ASSESSMENTS TO EVALUATE A STUDENT'S UNDERSTANDING AND
14 RETENTION OF THE MATERIAL.

15 5. A COMPREHENSIVE FINAL EXAMINATION THAT ASSESSES THE STUDENT'S
16 READINESS AND KNOWLEDGE.
