3 "Sec. 15. Section 32-519, Arizona Revised Statutes, is amended to

5 32-519. Eyelash technicians; registration; renewal; register;
6 exception

7 A. EXCEPT AS PROVIDED IN SUBSECTION D OF THIS SECTION, an eyelash
8 technician must be registered by the board. A person is entitled to
9 receive an eyelash technician registration if the person does all of the
10 following:

11 1. Submits to the board an application for an eyelash technician
12 registration on a form supplied by the board.

13 2. Either:

14 (a) Completes and receives appropriate credits for at least two
15 years of high school education or its equivalent as prescribed by the board
16 in its rules and submits satisfactory evidence that the person is at least
17 sixteen years of age.

18 (b) Submits to the board satisfactory evidence that the person is at
19 least eighteen years of age.

20 3. Submits to the board satisfactory evidence that the person
21 successfully completed a board-approved training program. The board shall
22 require ~~no~~ NOT more than thirty hours of training. A training program
23 ~~shall~~ IS not ~~be~~ required to be licensed as a school by the board to be
24 approved. The board-approved training program shall provide a provisional
25 registration to the person verifying the successful completion of the
26 training. Any person who satisfactorily demonstrates training received
27 ~~prior to~~ BEFORE October 30, 2023 ~~shall be~~ IS eligible for registration.

28 4. Pays the prescribed fees.

29 B. Except as provided in section 32-4301, an eyelash technician
30 shall renew the person's registration on or before the person's birthday
31 once every two years. An eyelash technician shall submit TO THE BOARD an
32 application for renewal accompanied by the prescribed renewal fee to renew

1 the person's registration. An eyelash technician who fails to renew the
2 person's registration on or before the person's birthday shall also pay the
3 prescribed delinquent renewal penalty to renew the registration.

4 C. The board shall maintain a current register of registered eyelash
5 technicians who are in good standing with the board.

6 D. AN AESTHETICIAN OR COSMETOLOGIST MAY PERFORM EYELASH EXTENSIONS
7 WITHOUT REGISTERING AS AN EYELASH TECHNICIAN PURSUANT TO THIS SECTION."
