AN ACT

AMENDING SECTIONS 28-2351, 28-2403 AND 28-2416, ARIZONA REVISED STATUTES; AMENDING TITLE 28, CHAPTER 7, ARTICLE 12, ARIZONA REVISED STATUTES, BY ADDING SECTIONS 28-2470.27, 28-2470.28, 28-2470.29, 28-2470.30, 28-2470.31, 28-2470.32, 28-2470.33, 28-2470.34, 28-2470.35, 28-2470.36 AND 28-2470.37; AMENDING SECTIONS 28-6501, 28-6991 AND 28-6993, ARIZONA REVISED STATUTES; AMENDING TITLE 36, CHAPTER 1, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 36-123.04; AMENDING SECTION 41-151.06, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 10, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-1506.03; RELATING TO SPECIAL PLATES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 28-2351, Arizona Revised Statutes, is amended to
3 read:

4 28-2351. License plate provided; design

5 A. Notwithstanding any other law, the department shall provide to
6 every owner one license plate for each vehicle registered. At the request
7 of the owner and on payment of a fee in an amount prescribed by the
8 director by rule, the department shall provide one additional license
9 plate for a vehicle for which a special plate is requested pursuant to
10 this chapter.

11 B. The license plate shall display the number assigned to the
12 vehicle and to the owner of the vehicle and the name of this state, which
13 may be abbreviated. The director shall coat the license plate with a
14 reflective material that is consistent with the determination of the
15 department regarding the color and design of license plates and special
16 plates. The director shall design the license plate and the letters and
17 numerals on the license plate to be of sufficient size to be plainly
18 readable during daylight from a distance of one hundred feet. In addition
19 to the standard license plate issued for a trailer before August 12, 2005,
20 the director shall issue a license plate for trailers that has a design
21 that is similar to the standard size license plate for trailers but that
22 is the same size as the license plate for motorcycles. The trailer owner
23 shall notify the department which size license plate the owner wants for
24 the trailer.

25 C. In addition to the requirements prescribed in subsection B of
26 this section, for all license plates, including all special plates, that
27 are designed or redesigned on or after September 24, 2022:

28 1. The background color of the license plate shall contrast
29 significantly with the color of the letters and numerals on the license
30 plate and with the name of this state on the license plate.

31 2. The name of this state shall appear on the license plate in
32 capital letters in sans serif font and be three-fourths of an inch in
33 height.

34 D. Notwithstanding any other law, the department shall not contract
35 with a nongovernmental entity to purchase or secure reflective material
36 for the plates issued by the department unless the department has made a
37 reasonable effort to secure qualified bids or proposals from as many
38 individual responsible respondents as possible.

39 E. The department shall determine the color and design of the
40 license plate subject to the requirements prescribed by subsections B and
41 C of this section. All plates issued by the department, except the plates
42 that are issued pursuant to sections 28-2404, 28-2412, 28-2413, 28-2414,
43 28-2416, 28-2416.01, 28-2417 through ~~28-2470.26~~ 28-2470.37, 28-2472,
44 28-2473, 28-2474, 28-2475, 28-2476 and 28-4533 and article 14 of this

1 chapter, shall be the same color as and similar in design to the license
2 plate as determined by the department.

3 F. A passenger motor vehicle that is rented without a driver shall
4 receive the same type of license plate as is issued for a private
5 passenger motor vehicle.

6 Sec. 2. Section 28-2403, Arizona Revised Statutes, is amended to
7 read:

8 **28-2403. Special plates; transfers; violation; classification**

9 A. Except as otherwise provided in this article, the department
10 shall issue or renew special plates in lieu of the regular license plates
11 pursuant to the following conditions and procedures and only if the
12 requirements prescribed by this article for the requested special plates
13 are met:

14 1. Except as provided in sections 28-2416 and 28-2416.01, a person
15 who is the registered owner of a vehicle registered with the department or
16 who applies for an original or renewal registration of a vehicle may
17 submit to the department a completed application form as prescribed by the
18 department with the fee prescribed by section 28-2402 for special plates
19 in addition to the registration fee prescribed by section 28-2003.

20 2. Except for plates issued pursuant to sections 28-2404, 28-2412,
21 28-2413, 28-2414, 28-2416, 28-2416.01, 28-2417 through ~~28-2470.26~~
22 **28-2470.37**, 28-2472, 28-2473, 28-2474, 28-2475 and 28-2476 and article 14
23 of this chapter, the special plates shall be the same color as and similar
24 to the design of the regular license plates that is determined by the
25 department.

26 3. Except as provided in section 28-2416, the department shall
27 issue special plates only to the owner or lessee of a vehicle that is
28 currently registered, including any vehicle that has a declared gross
29 weight, as defined in section 28-5431, of twenty-six thousand pounds or
30 less.

31 4. Except as provided in sections 28-2416 and 28-2416.01, the
32 department shall charge the fee prescribed by section 28-2402 for each
33 annual renewal of special plates in addition to the registration fee
34 prescribed by section 28-2003.

35 B. Except as provided in sections 28-2416 and 28-2416.01, on
36 notification to the department and on payment of the transfer fee
37 prescribed by section 28-2402, a person who is issued special plates may
38 transfer the special plates to another vehicle the person owns or leases.
39 Persons who are issued special plates for hearing impaired persons
40 pursuant to section 28-2408 and international symbol of access special
41 plates pursuant to section 28-2409 are exempt from the transfer fee. If a
42 person who is issued special plates sells, trades or otherwise releases
43 ownership of the vehicle on which the plates have been displayed, the
44 person shall immediately report the transfer of the plates to the
45 department or the person shall surrender the plates to the department as

1 prescribed by the director. It is unlawful for a person to whom the
2 plates have been issued to knowingly allow them to be displayed on a
3 vehicle except the vehicle authorized by the department.

4 C. The special plates shall be affixed to the vehicle for which
5 registration is sought in lieu of the regular license plates.

6 D. A person is guilty of a class 3 misdemeanor who:

7 1. Violates subsection B of this section.

8 2. Fraudulently gives false or fictitious information in the
9 application for or renewal of special plates or placards issued pursuant
10 to this article.

11 3. Conceals a material fact or otherwise commits fraud in the
12 application for or renewal of special plates or placards issued pursuant
13 to this article.

14 Sec. 3. Section 28-2416, Arizona Revised Statutes, is amended to
15 read:

16 28-2416. Alternative fuel vehicle special plates; stickers;
17 use of high occupancy vehicle lanes; civil
18 penalty; definition

19 A. A person who owns a motor vehicle that has either been converted
20 or manufactured to use an alternative fuel as the vehicle's exclusive fuel
21 source and that is incapable of operating on any other type of fuel and
22 the alternative fuel was subject to the use fuel tax imposed pursuant to
23 chapter 16 of this title before April 1, 1997 shall apply for alternative
24 fuel vehicle special plates pursuant to this section.

25 B. The department shall issue alternative fuel vehicle special
26 plates, or an alternative fuel vehicle sticker as provided in subsection D
27 of this section, to a person who satisfies all of the following:

28 1. Owns a motor vehicle that is exclusively powered by an
29 alternative fuel and that is incapable of operating on any other type of
30 fuel.

31 2. Provides proof as follows:

32 (a) For an original equipment manufactured alternative fuel
33 vehicle, the dealer who sells the motor vehicle shall provide to the
34 department of transportation and the owner of the motor vehicle a
35 certificate indicating:

36 (i) That the motor vehicle is exclusively powered by an alternative
37 fuel and is incapable of operating on any other type of fuel.

38 (ii) The emission classification of the motor vehicle as low,
39 inherently low, ultralow or zero.

40 (b) For a converted motor vehicle or a motor vehicle that is
41 assembled by the owner, the department of environmental quality or an
42 agent of the department of environmental quality shall provide a
43 certificate to the department of transportation and the owner of the motor
44 vehicle indicating that the motor vehicle is exclusively powered by an
45 alternative fuel and is incapable of operating on any other type of fuel.

1 3. Pays an ~~eight dollar~~ \$8 special plate administration fee, except
2 that vehicles that are registered pursuant to section 28-2511 are exempt
3 from that fee. The department shall deposit, pursuant to sections 35-146
4 and 35-147, all special plate administration fees in the state highway
5 fund established by section 28-6991.

6 C. The color and design of the alternative fuel vehicle special
7 plates are subject to the approval of the governor's energy office. The
8 director may allow a request for alternative fuel vehicle special plates
9 to be combined with a request for personalized special plates. If the
10 director allows such a combination, the request shall be in a form
11 prescribed by the director and is subject to the fees for the personalized
12 special plates in addition to the fees required for alternative fuel
13 vehicle special plates. Alternative fuel vehicle special plates are not
14 transferable, except that if the director allows alternative fuel vehicle
15 special plates to be personalized a person who is issued personalized
16 alternative fuel vehicle special plates may transfer those plates to
17 another alternative fuel vehicle for which the person is the registered
18 owner or lessee.

19 D. If a motor vehicle qualifies pursuant to this section and any
20 other special plates are issued pursuant to article 7, 8 or 13 of this
21 chapter or section 28-2414, [28-2470.29](#) or 28-2514 for the motor vehicle,
22 the department may issue an alternative fuel vehicle sticker to the person
23 who owns the motor vehicle. The alternative fuel vehicle sticker shall be
24 diamond-shaped, shall indicate the type of alternative fuel used by the
25 vehicle and shall be placed on the motor vehicle as prescribed by the
26 department.

27 E. Except as provided in section 28-337, a person may drive a motor
28 vehicle with alternative fuel vehicle special plates or an alternative
29 fuel vehicle sticker in high occupancy vehicle lanes at any time,
30 regardless of occupancy level, without penalty.

31 F. A person shall not drive a motor vehicle in a high occupancy
32 vehicle lane with an alternative fuel vehicle sticker if the motor vehicle
33 is not an alternative fuel vehicle for which an alternative fuel vehicle
34 sticker has been issued pursuant to this section. A person who violates
35 this subsection is subject to a civil penalty of ~~three hundred fifty~~
36 ~~dollars~~ \$350. Notwithstanding section 28-1554, the civil penalty
37 collected pursuant to this subsection shall be deposited in the state
38 general fund.

39 G. For the purposes of section 28-337, the department shall:
40 1. Limit or suspend the issuance of alternative fuel vehicle
41 special plates.

42 2. Remove the privilege of operating in the high occupancy vehicle
43 lane with a single occupant, including the driver.

44 H. If the department publishes maps of the state highway system
45 that are distributed to the general public, the department shall indicate

1 on those maps the approximate location of alternative fuel delivery
2 facilities that are open to the public.

3 I. For the purposes of this section, "alternative fuel" has the
4 same meaning prescribed in section 1-215.

9 28-2470.27. 988 suicide awareness special plates

10 A. IF, BY DECEMBER 31, 2025, A PERSON PAYS \$32,000 TO THE
11 DEPARTMENT FOR THE IMPLEMENTATION OF THIS SECTION, THE DEPARTMENT SHALL
12 ISSUE 988 SUICIDE AWARENESS SPECIAL PLATES. THE PERSON THAT PROVIDES THE
13 \$32,000 SHALL DESIGN THE 988 SUICIDE AWARENESS SPECIAL PLATES. THE DESIGN
14 AND COLOR OF THE 988 SUICIDE AWARENESS SPECIAL PLATES ARE SUBJECT TO
15 APPROVAL OF THE DEPARTMENT.

16 B. THE DIRECTOR MAY ALLOW A REQUEST FOR 988 SUICIDE AWARENESS
17 SPECIAL PLATES TO BE COMBINED WITH A REQUEST FOR PERSONALIZED SPECIAL
18 PLATES. IF THE DIRECTOR Allows SUCH A COMBINATION, THE REQUEST SHALL BE
19 IN A FORM PRESCRIBED BY THE DIRECTOR AND IS SUBJECT TO THE FEES FOR THE
20 PERSONALIZED SPECIAL PLATES IN ADDITION TO THE FEES REQUIRED FOR THE 988
21 SUICIDE AWARENESS SPECIAL PLATES.

22 C. OF THE \$25 FEE REQUIRED BY SECTION 28-2402 FOR THE ORIGINAL
23 SPECIAL PLATES AND FOR THE RENEWAL OF SPECIAL PLATES, \$8 IS A SPECIAL
24 PLATE ADMINISTRATION FEE AND \$17 IS AN ANNUAL DONATION.

25 D. THE DEPARTMENT SHALL DEPOSIT, PURSUANT TO SECTIONS 35-146 AND
26 35-147, ALL SPECIAL PLATE ADMINISTRATION FEES IN THE STATE HIGHWAY FUND
27 ESTABLISHED BY SECTION 28-6991 AND SHALL TRANSMIT ALL DONATIONS COLLECTED
28 PURSUANT TO THIS SECTION TO THE 988 SUICIDE AWARENESS SPECIAL PLATE FUND
29 ESTABLISHED BY SECTION 36-123.04.

30 28-2470.28. Youth charities organization special plate; fund

31 A. IF, BY DECEMBER 31, 2025, A PERSON PAYS \$32,000 TO THE
32 DEPARTMENT FOR THE IMPLEMENTATION OF THIS SECTION, THE DEPARTMENT SHALL
33 ISSUE YOUTH CHARITIES ORGANIZATION SPECIAL PLATES. THE PERSON THAT
34 PROVIDES THE \$32,000 SHALL DESIGN THE YOUTH CHARITIES ORGANIZATION SPECIAL
35 PLATES. THE COLOR AND DESIGN OF THE YOUTH CHARITIES ORGANIZATION SPECIAL
36 PLATES ARE SUBJECT TO APPROVAL OF THE DEPARTMENT. THE DIRECTOR MAY ALLOW
37 A REQUEST FOR YOUTH CHARITIES ORGANIZATION SPECIAL PLATES TO BE COMBINED
38 WITH A REQUEST FOR PERSONALIZED SPECIAL PLATES. IF THE DIRECTOR Allows
39 SUCH A COMBINATION, THE REQUEST SHALL BE IN A FORM PRESCRIBED BY THE
40 DIRECTOR AND IS SUBJECT TO THE FEES FOR THE PERSONALIZED SPECIAL PLATES IN
41 ADDITION TO THE FEES REQUIRED FOR THE YOUTH CHARITIES ORGANIZATION SPECIAL

1 C. THE DEPARTMENT SHALL DEPOSIT, PURSUANT TO SECTIONS 35-146 AND
2 35-147, ALL SPECIAL PLATE ADMINISTRATION FEES IN THE STATE HIGHWAY FUND
3 ESTABLISHED BY SECTION 28-6991 AND SHALL TRANSMIT ALL DONATIONS COLLECTED

18 2. HAVE BEEN INCORPORATED IN THIS STATE IN MARCH 1996.

19 3. EXCLUSIVELY SUPPORT ARIZONA CHILDREN'S CHARITIES THROUGH AT
20 LEAST TWO ANNUAL FUNDRAISING EVENTS.

21 4. BE AFFILIATED WITH A MEMBERSHIP-BASED ORGANIZATION THAT IS
22 HEADQUARTERED IN SCOTTSDALE, ARIZONA THAT CONSISTS OF AN ACTIVE MEMBERSHIP
23 OF NOT MORE THAN SIXTY-FIVE MEMBERS UNDER FORTY YEARS OF AGE.

24 F. ON NOTICE FROM THE DIRECTOR, THE STATE TREASURER SHALL INVEST
25 AND DIVEST MONIES IN THE FUND AS PROVIDED BY SECTION 35-313, AND MONIES
26 EARNED FROM INVESTMENT SHALL BE CREDITED TO THE FUND.

28 A. IF, BY DECEMBER 31, 2025, A PERSON PAYS \$32,000 TO THE

30 ISSUE MADE IN ARIZONA SPECIAL PLATES. THE PERSON THAT PROVIDES THE
31 \$32,000 SHALL DESIGN THE MADE IN ARIZONA SPECIAL PLATES. THE DESIGN AND
32 COLOR OF THE MADE IN ARIZONA SPECIAL PLATES ARE SUBJECT TO APPROVAL OF THE
33 DEPARTMENT.

34 B. THE DIRECTOR MAY ALLOW A REQUEST FOR MADE IN ARIZONA SPECIAL
35 PLATES TO BE COMBINED WITH:

36 1. A REQUEST FOR PERSONALIZED SPECIAL PLATES. IF THE DIRECTOR
37 ALLOWS SUCH A COMBINATION, THE REQUEST SHALL BE IN A FORM PRESCRIBED BY
38 THE DIRECTOR AND IS SUBJECT TO THE FEES FOR THE PERSONALIZED SPECIAL

13 A. IF, BY DECEMBER 31, 2025, A PERSON PAYS \$32,000 TO THE
14 DEPARTMENT FOR THE IMPLEMENTATION OF THIS SECTION, THE DEPARTMENT SHALL
15 ISSUE EDUCATION FUNDRAISING SPECIAL PLATES. THE PERSON THAT PROVIDES THE
16 \$32,000 SHALL DESIGN THE EDUCATION FUNDRAISING SPECIAL PLATES. THE DESIGN
17 AND COLOR OF THE EDUCATION FUNDRAISING SPECIAL PLATES ARE SUBJECT TO
18 APPROVAL OF THE DEPARTMENT. THE DIRECTOR MAY ALLOW A REQUEST FOR
19 EDUCATION FUNDRAISING SPECIAL PLATES TO BE COMBINED WITH A REQUEST FOR
20 PERSONALIZED SPECIAL PLATES. IF THE DIRECTOR Allows SUCH A COMBINATION,
21 THE REQUEST SHALL BE IN A FORM PRESCRIBED BY THE DIRECTOR AND IS SUBJECT

40 E. THE DIRECTOR SHALL ANNUALLY ALLOCATE MONIES FROM THE FUND TO AN

42 INTERNAL REVENUE CODE FOR FEDERAL INCOME TAX PURPOSES. THE ENTITY MUST:

43 1. HAVE A MISSION OF COMMUNITY FUNDRAISING TO FUEL ACCESS,
44 INNOVATION AND EXCELLENCE WITHIN ONE UNIFIED SCHOOL DISTRICT IN THIS
45 STATE.

1 2. ACHIEVE THIS MISSION THROUGH EVENTS, CAMPAIGNS AND PARTNERSHIPS.
2 3. USE ANY MONIES RAISED THROUGH FUNDRAISING TO PROMOTE EQUITABLE
