CHAPTER 20

HOUSE BILL 2057

AN ACT

AMENDING SECTION 28-2448, ARIZONA REVISED STATUTES; RELATING TO ARIZONA
CENTENNIAL SPECIAL PLATES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 28-2448, Arizona Revised Statutes, is amended to
3 read:

4 28-2448. Arizona centennial special plates; fund

5 A. The department shall issue Arizona centennial special
6 plates. The department shall use ~~thirty-two thousand dollars~~ \$32,000 from
7 the state highway fund, established by section 28-6991, to implement this
8 section. The office of tourism shall design the Arizona centennial
9 special plates. The design and color of the Arizona centennial special
10 plates are subject to the approval of the department. The director of the
11 department of transportation may allow a request for Arizona centennial
12 special plates to be combined with a request for personalized special
13 plates. If the director of the department of transportation allows such a
14 combination, the request shall be in a form prescribed by the director of
15 the department of transportation and is subject to the fees for the
16 personalized special plates in addition to the fees required for the
17 Arizona centennial special plates.

18 B. Of the ~~twenty-five dollar~~ \$25 fee required by section 28-2402
19 for the original special plates and for renewal of special plates, ~~eight~~
20 ~~dollars~~ \$8 is a special plate administration fee and ~~seventeen dollars~~ \$17
21 is an annual donation.

22 C. NOTWITHSTANDING SECTION 28-2402, THE FEE FOR ARIZONA CENTENNIAL
23 SPECIAL PLATES AND FOR RENEWAL OF ARIZONA CENTENNIAL SPECIAL PLATES IS \$20
24 IF THE ARIZONA CENTENNIAL SPECIAL PLATES ARE ISSUED TO A COMMERCIAL
25 VEHICLE IN A FLEET AS DEFINED IN SECTION 28-2201 AND REGISTERED PURSUANT
26 TO ARTICLE 6 OF THIS CHAPTER. OF THE \$20 FEE REQUIRED BY THIS SUBSECTION,
27 \$8 IS A SPECIAL PLATE ADMINISTRATION FEE AND \$12 IS AN ANNUAL DONATION.

28 ~~C.~~ D. The department shall deposit, pursuant to sections 35-146
29 and 35-147, all special plate administration fees in the state highway
30 fund established by section 28-6991 and all donations collected pursuant
31 to this section in the Arizona centennial special plate fund established
32 by this section.

33 ~~D.~~ E. The Arizona centennial special plate fund is established
34 consisting of monies deposited pursuant to this section. The director
35 shall administer the fund. The first ~~thirty-two thousand dollars~~ \$32,000
36 in the fund shall be reimbursed to the state highway fund established by
37 section 28-6991. Not more than ten percent of monies deposited in the
38 fund annually shall be used for the cost of administering the fund. Monies
39 in the fund are continuously appropriated.

40 ~~E.~~ F. The director shall annually allocate monies in the fund to
41 the university of Arizona to pay costs related to the maintenance and
42 operations of the mining, mineral and natural resources educational
43 museum.

44 ~~F.~~ G. On notice from the director, the state treasurer shall
45 invest and divest monies in the fund as provided by section 35-313, and
46 monies earned from investment shall be credited to the fund.
