CHAPTER 44

HOUSE BILL 2122

AN ACT

AMENDING SECTION 32-122.03, ARIZONA REVISED STATUTES; RELATING TO THE BOARD OF TECHNICAL REGISTRATION.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 32-122.03, Arizona Revised Statutes, is amended
3 to read:

4 32-122.03. Qualifications for registration; reciprocity or
5 endorsement

6 A. Notwithstanding section 32-122.01, a person who meets the
7 qualifications for registration pursuant to this section is eligible for
8 registration.

9 B. An applicant for professional registration as a professional
10 engineer, architect, land surveyor or landscape architect in this state
11 through reciprocity or endorsement shall hold both of the following:

12 1. A valid license, registration or certification **IN THE PROFESSION**
13 **IN WHICH REGISTRATION IS SOUGHT THAT IS** issued by the proper authority of
14 either:

15 (a) Another state, territory, district or possession **OF THE UNITED**
16 **STATES.**

17 (b) A country participating in the applicable profession's national
18 council mutual recognition agreement.

19 2. A ~~certification or model law designation~~ **VALID RECORD** from the
20 applicable profession's national council **CERTIFYING THAT THE INDIVIDUAL**
21 **SATISFIES THAT NATIONAL COUNCIL'S REQUIREMENTS FOR CERTIFICATION, MODEL**
22 **LAW DESIGNATION OR MUTUAL RECOGNITION AGREEMENT.**

23 C. In addition to the requirements prescribed by subsection B of
24 this section, an applicant for registration as a:

25 1. Professional engineer through reciprocity or endorsement shall
26 hold a record from the profession's national council verifying that the
27 person meets at least one of the following in the branch of engineering in
28 which registration is sought:

29 (a) Has at least four years of experience ~~following the person's~~
30 ~~licensure, registration or certification by the other jurisdiction.~~

31 (b) Passed a professional national examination.

32 (c) Earned a baccalaureate or equivalent degree or a postgraduate
33 degree.

34 2. Land surveyor through reciprocity or endorsement shall pass the
35 examination relating to surveying methods and legal principles in this
36 state as prescribed by the board in rule.
