# **CHAPTER 139**

## **HOUSE BILL 4167**

AN ACT

RELATING TO THE MANAGEMENT OF STATE PROPERTIES.

(TEXT OF BILL BEGINS ON NEXT PAGE)

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Rental rates; state-owned buildings; fiscal year  
3 2026-2027

4 Notwithstanding section 41-792.01, subsection D, Arizona Revised  
5 Statutes, in fiscal year 2026-2027, the capital outlay stabilization fund  
6 rental rates for state-owned buildings are \$17.87 per square foot for  
7 office space and \$6.43 per square foot for storage space.

8 Sec. 2. Reporting the sale of state buildings in the  
9 governmental mall; fiscal year 2026-2027

10 In fiscal year 2026-2027, within ten days after the sale of real  
11 property that is owned by this state and that is located within the  
12 boundaries of the governmental mall described in section 41-1362, Arizona  
13 Revised Statutes, the department of administration shall submit a report  
14 to the president of the senate, the speaker of the house of  
15 representatives, and the director of the joint legislative budget  
16 committee that includes all of the following:

- 17 1. The address of the real property.
- 18 2. The square footage of the real property.
- 19 3. The purchase price of the real property.
- 20 4. The name of the fund in which the proceeds from the sale of the  
21 real property are being deposited.

22 Sec. 3. Arizona America 250 commission commemorative plaque;  
23 procedures; delayed repeal

24 A. Pursuant to section 41-1363, subsection A, Arizona Revised  
25 Statutes, the legislative council is authorized to provide for the  
26 placement in the governmental mall of a commemorative plaque that  
27 recognizes the service of the Arizona America 250 commission and that may  
28 include the names of the members who served on the commission and the  
29 years of the members' service on the commission.

30 B. The procedures prescribed in section 41-1363, Arizona Revised  
31 Statutes, apply to the establishment of the commemorative plaque.

32 C. Public monies are not authorized for the costs of the plaque.  
33 All fundraising and contracts for artistic design and construction of the  
34 plaque are the sole responsibility of the proponents. This state may not  
35 facilitate fundraising or establish a state fund for the deposit of the  
36 monies.

37 D. This section is repealed from and after September 30, 2029.
