## **CHAPTER 152**

# **SENATE BILL 1167**

AN ACT

AMENDING TITLE 9, CHAPTER 4, ARTICLE 8, ARIZONA REVISED STATUTES, BY ADDING SECTION 9-500.54; AMENDING TITLE 11, CHAPTER 2, ARTICLE 4, ARIZONA REVISED STATUTES, BY ADDING SECTION 11-269.31; RELATING TO PUBLICATION OF NOTICES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 9, chapter 4, article 8, Arizona Revised Statutes,  
3 is amended by adding section 9-500.54, to read:

4 9-500.54. Notices; posting requirements; official website;  
5 applicability

6 A. NOTWITHSTANDING ANY OTHER LAW, A CITY OR TOWN MAY SATISFY ANY  
7 STATUTORY REQUIREMENT FOR ADVERTISING, PUBLISHING OR PRINTING REQUIRED BY  
8 THIS TITLE BY POSTING THE ADVERTISEMENT, PUBLICATION OR PRINTING ON THE  
9 OFFICIAL WEBSITE OF THE CITY OR TOWN AND ON THE OFFICIAL WEBSITE OF A  
10 NEWSPAPER THAT IS QUALIFIED TO PUBLISH NOTICES UNDER THIS TITLE.

11 B. TO SATISFY THE POSTING REQUIREMENTS PRESCRIBED BY SUBSECTION A  
12 OF THIS SECTION, A CITY OR TOWN SHALL ELECTRONICALLY PROVIDE THE NEWSPAPER  
13 WITH THE NOTICE THAT IS TO BE POSTED ON THE OFFICIAL WEBSITE OF THE  
14 NEWSPAPER AT LEAST ONE FULL BUSINESS DAY BEFORE THE REQUIRED NOTICE DATE.  
15 THE CITY OR TOWN SHALL POST THE NOTICE ON THE OFFICIAL WEBSITE OF THE CITY  
16 OR TOWN BY THE REQUIRED NOTICE DATE.

17 C. A CITY OR TOWN THAT POSTS PUBLIC NOTICES ON THE OFFICIAL WEBSITE  
18 OF THE CITY OR TOWN SHALL INCLUDE A PUBLIC NOTICES LINK ON THE HOME PAGE  
19 OF THE WEBSITE OF THE CITY OR TOWN THAT LINKS TO ALL STATUTORILY REQUIRED  
20 ADVERTISING, PUBLISHING OR PRINTING, LISTED BY CATEGORY.

21 D. THIS SECTION DOES NOT APPLY TO PUBLISHING A NOTICE OF A PROPOSED  
22 CHARTER AS REQUIRED BY SECTION 9-282.

23 Sec. 2. Title 11, chapter 2, article 4, Arizona Revised Statutes,  
24 is amended by adding section 11-269.31, to read:

25 11-269.31. Notices; posting requirements; official website

26 A. NOTWITHSTANDING ANY OTHER LAW, A COUNTY MAY SATISFY ANY  
27 STATUTORY REQUIREMENT FOR ADVERTISING, PUBLISHING OR PRINTING REQUIRED BY  
28 THIS TITLE BY POSTING THE ADVERTISEMENT, PUBLICATION OR PRINTING ON THE  
29 OFFICIAL WEBSITE OF THE COUNTY AND ON THE OFFICIAL WEBSITE OF A NEWSPAPER  
30 THAT IS QUALIFIED TO PUBLISH NOTICES UNDER THIS TITLE.

31 B. TO SATISFY THE POSTING REQUIREMENTS PRESCRIBED BY SUBSECTION A  
32 OF THIS SECTION, A COUNTY SHALL ELECTRONICALLY PROVIDE THE NEWSPAPER WITH  
33 THE NOTICE THAT IS TO BE POSTED ON THE OFFICIAL WEBSITE OF THE NEWSPAPER  
34 AT LEAST ONE FULL BUSINESS DAY BEFORE THE REQUIRED NOTICE DATE. THE  
35 COUNTY SHALL POST THE NOTICE ON THE OFFICIAL WEBSITE OF THE COUNTY BY THE  
36 REQUIRED NOTICE DATE.

37 C. A COUNTY THAT POSTS PUBLIC NOTICES ON THE OFFICIAL WEBSITE OF  
38 THE COUNTY SHALL INCLUDE A PUBLIC NOTICES LINK ON THE HOME PAGE OF THE  
39 WEBSITE OF THE COUNTY THAT LINKS TO ALL STATUTORILY REQUIRED ADVERTISING,  
40 PUBLISHING OR PRINTING, LISTED BY CATEGORY.
