AN ACT

AMENDING TITLE 36, CHAPTER 1, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 36-104.01; AMENDING TITLE 36, CHAPTER 21.1, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 36-2202.02; RELATING TO PERSONAL IDENTIFYING INFORMATION.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 36, chapter 1, article 1, Arizona Revised
3 Statutes, is amended by adding section 36-104.01, to read:

4 36-104.01. Sale of information; prohibition; definition

5 A. THE DEPARTMENT MAY NOT SELL ANY PERSONAL IDENTIFYING INFORMATION
6 OF ANY INDIVIDUAL WHOM THE DEPARTMENT LICENSES OR CERTIFICATES PURSUANT TO
7 THIS TITLE OR TITLE 32. THE PERSONAL IDENTIFYING INFORMATION OF A
8 LICENSEE OR CERTIFICATE HOLDER IS CONFIDENTIAL AND, IF A REQUEST FOR THE
9 PERSONAL IDENTIFYING INFORMATION IS MADE FOR A COMMERCIAL PURPOSE, THE
10 PERSONAL IDENTIFYING INFORMATION IS EXEMPT FROM TITLE 39, CHAPTER 1,
11 ARTICLE 2.

12 B. FOR THE PURPOSES OF THIS SECTION, "PERSONAL IDENTIFYING
13 INFORMATION" INCLUDES:

14 1. A SOCIAL SECURITY NUMBER, PASSPORT NUMBER, DRIVER LICENSE NUMBER
15 OR TAXPAYER IDENTIFICATION NUMBER.

16 2. A PERSONAL ADDRESS, PERSONAL EMAIL ADDRESS OR PERSONAL TELEPHONE
17 NUMBER.

18 3. A BIOMETRIC RECORD, INCLUDING A PHOTOGRAPHIC IMAGE, A
19 FINGERPRINT, A RETINAL SCAN, A VOICE SIGNATURE OR FACIAL GEOMETRY.

20 4. BULK INFORMATION THAT WHEN COMBINED WITH OTHER REQUEST DETAILS
21 MAY POSE A PRIVACY RISK, INCLUDING:

22 (a) DATE OF BIRTH.

23 (b) PLACE OF BIRTH.

24 (c) RACE.

25 (d) RELIGION.

26 (e) GEOGRAPHIC INDICATORS.

27 (f) EMPLOYMENT INFORMATION.

28 (g) EDUCATION INFORMATION.

29 Sec. 2. Title 36, chapter 21.1, article 1, Arizona Revised
30 Statutes, is amended by adding section 36-2202.02, to read:

31 36-2202.02. Sale or disclosure of information; prohibition;
32 exception; definition

33 A. THE DEPARTMENT MAY NOT SELL OR DISCLOSE ANY PERSONAL IDENTIFYING
34 INFORMATION OF AN EMERGENCY MEDICAL CARE TECHNICIAN. THE PERSONAL
35 IDENTIFYING INFORMATION OF AN EMERGENCY MEDICAL CARE TECHNICIAN IS
36 CONFIDENTIAL AND, IF A REQUEST FOR THE PERSONAL IDENTIFYING INFORMATION IS
37 MADE FOR A COMMERCIAL PURPOSE, THE PERSONAL IDENTIFYING INFORMATION IS
38 EXEMPT FROM TITLE 39, CHAPTER 1, ARTICLE 2. THE DEPARTMENT MAY DISCLOSE
39 PERSONAL IDENTIFYING INFORMATION OF AN EMERGENCY MEDICAL CARE TECHNICIAN
40 WITH THE EMERGENCY MEDICAL CARE TECHNICIAN'S CONSENT THAT INCLUDES THE
41 INFORMATION THAT MAY BE DISCLOSED AND THE PURPOSES FOR THE DISCLOSURE.

1 B. THE DEPARTMENT MAY DISCLOSE INFORMATION THAT HAS BEEN
2 DE-IDENTIFIED OR THAT IS IN AN AGGREGATED FORM AND THAT DOES NOT
3 REASONABLY ALLOW THE IDENTIFICATION OF AN EMERGENCY MEDICAL CARE
4 TECHNICIAN.

5 C. THIS SECTION DOES NOT PROHIBIT THE DEPARTMENT FROM SHARING
6 INFORMATION RELATING TO THE APPLICATION FOR LICENSURE OR THE LICENSURE OF
7 AN EMERGENCY MEDICAL CARE TECHNICIAN WITH ANOTHER REGULATORY ENTITY,
8 INCLUDING A COMMISSION THAT ADMINISTERS A LICENSURE COMPACT.

9 D. THIS SECTION DOES NOT PREVENT THE DEPARTMENT FROM DISCLOSING
10 INFORMATION PERTAINING TO AN EMERGENCY MEDICAL TECHNICIAN'S LICENSING
11 HISTORY OR RECORD OF DISCIPLINARY ACTIONS PURSUANT TO SECTION 36-2220.

12 E. FOR THE PURPOSES OF THIS SECTION, "PERSONAL IDENTIFYING
13 INFORMATION" INCLUDES:

14 1. A SOCIAL SECURITY NUMBER, PASSPORT NUMBER, DRIVER LICENSE NUMBER
15 OR TAXPAYER IDENTIFICATION NUMBER.

16 2. A PERSONAL ADDRESS, PERSONAL EMAIL ADDRESS OR PERSONAL TELEPHONE
17 NUMBER.

18 3. A BIOMETRIC RECORD, INCLUDING A PHOTOGRAPHIC IMAGE, A
19 FINGERPRINT, A RETINAL SCAN, A VOICE SIGNATURE OR FACIAL GEOMETRY.

20 4. BULK INFORMATION THAT WHEN COMBINED WITH OTHER REQUEST DETAILS
21 MAY POSE A PRIVACY RISK, INCLUDING:

22 (a) DATE OF BIRTH.

23 (b) PLACE OF BIRTH.

24 (c) RACE.

25 (d) RELIGION.

26 (e) GEOGRAPHIC INDICATORS.

27 (f) EMPLOYMENT INFORMATION.

28 (g) EDUCATION INFORMATION.
