# SENATE BILL 1269

AN ACT

AMENDING TITLE 15, CHAPTER 1, ARTICLE 1, ARIZONA REVISED STATUTES, BY  
ADDING SECTION 15-120.05; RELATING TO PUBLIC SCHOOLS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 15, chapter 1, article 1, Arizona Revised  
3 Statutes, is amended by adding section 15-120.05, to read:

4 15-120.05. Volunteer school chaplains; school policies;  
5 posting; parental consent; fingerprinting  
6 requirement

7 A. SCHOOL DISTRICT GOVERNING BOARDS AND CHARTER SCHOOL GOVERNING  
8 BODIES MAY ALLOW VOLUNTEER SCHOOL CHAPLAINS TO PROVIDE SUPPORT, SERVICES  
9 OR PROGRAMS, OR ANY COMBINATION OF SUPPORT, SERVICES AND PROGRAMS, TO  
10 STUDENTS. EACH SCHOOL DISTRICT GOVERNING BOARD AND CHARTER SCHOOL  
11 GOVERNING BODY THAT ALLOWS VOLUNTEER SCHOOL CHAPLAINS SHALL ADOPT A POLICY  
12 THAT INCLUDES ALL OF THE FOLLOWING:

13 1. A DESCRIPTION OF THE SUPPORT, SERVICES OR PROGRAMS, OR  
14 COMBINATION OF SUPPORT, SERVICES AND PROGRAMS, THAT THE VOLUNTEER SCHOOL  
15 CHAPLAIN MAY PROVIDE TO STUDENTS.

16 2. PROCEDURES FOR THE SCHOOL DISTRICT OR CHARTER SCHOOL TO DEVELOP  
17 AND MAINTAIN A LIST OF VOLUNTEER SCHOOL CHAPLAINS WHO MAY PROVIDE SUPPORT,  
18 SERVICES OR PROGRAMS, OR COMBINATION OF SUPPORT, SERVICES AND PROGRAMS, TO  
19 STUDENTS ENROLLED IN THE SCHOOL DISTRICT OR CHARTER SCHOOL. A LIST  
20 DEVELOPED PURSUANT TO THIS PARAGRAPH MUST INCLUDE THE RELIGIOUS  
21 AFFILIATION, IF ANY, OF EACH VOLUNTEER SCHOOL CHAPLAIN. THE SCHOOL  
22 DISTRICT OR CHARTER SCHOOL SHALL POST THE LIST DEVELOPED PURSUANT TO THIS  
23 PARAGRAPH ON THE WEBSITE OF THE SCHOOL DISTRICT OR CHARTER SCHOOL.

24 3. A REQUIREMENT THAT EACH INDIVIDUAL SCHOOL AT WHICH A VOLUNTEER  
25 SCHOOL CHAPLAIN PROVIDES SUPPORT, SERVICES OR PROGRAMS, OR COMBINATION OF  
26 SUPPORT, SERVICES AND PROGRAMS, DO ALL OF THE FOLLOWING:

27 (a) NOTIFY ALL PARENTS AND GUARDIANS OF STUDENTS THAT THE SUPPORT,  
28 SERVICES OR PROGRAMS ARE AVAILABLE.

29 (b) OBTAIN WRITTEN CONSENT FROM A STUDENT'S PARENT OR GUARDIAN  
30 BEFORE THE STUDENT MAY RECEIVE SUPPORT OR SERVICES FROM A VOLUNTEER SCHOOL  
31 CHAPLAIN OR PARTICIPATE IN A PROGRAM PROVIDED BY A VOLUNTEER SCHOOL  
32 CHAPLAIN.

33 (c) PROVIDE EACH STUDENT'S PARENT OR GUARDIAN AN OPPORTUNITY TO  
34 SELECT A VOLUNTEER SCHOOL CHAPLAIN FROM THE LIST DEVELOPED PURSUANT TO  
35 PARAGRAPH 2 OF THIS SUBSECTION AT THE TIME THE PARENT OR GUARDIAN PROVIDES  
36 WRITTEN CONSENT PURSUANT TO SUBDIVISION (b) OF THIS PARAGRAPH.

37 B. A VOLUNTEER SCHOOL CHAPLAIN WHO PROVIDES SUPPORT, SERVICES OR  
38 PROGRAMS, OR COMBINATION OF SUPPORT, SERVICES AND PROGRAMS, PURSUANT TO  
39 THIS SECTION IS SUBJECT TO THE REQUIREMENTS PRESCRIBED IN SECTION 15-512  
40 FOR SCHOOL PERSONNEL WHO ARE NOT PAID EMPLOYEES.
