**CHAPTER 188**  
**SENATE BILL 1383**

AN ACT

AMENDING TITLE 15, CHAPTER 1, ARTICLE 5, ARIZONA REVISED STATUTES, BY  
ADDING SECTION 15-160.03; RELATING TO SCHOOL HEALTH CARE SERVICES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 15, chapter 1, article 5, Arizona Revised  
3 Statutes, is amended by adding section 15-160.03, to read:

4 15-160.03. Routine health care services; employee  
5 credentials; training requirements; definition

6 A. ON REQUEST BY A STUDENT'S PARENT OR GUARDIAN, EACH SCHOOL  
7 DISTRICT OR CHARTER SCHOOL THAT PROVIDES ROUTINE HEALTH CARE SERVICES TO  
8 STUDENTS IN THE SCHOOL'S HEALTH OFFICE SHALL PROVIDE THE HEALTH CARE  
9 CREDENTIALS, IF ANY, OF EACH INDIVIDUAL WHO PROVIDES ROUTINE HEALTH CARE  
10 SERVICES TO STUDENTS IN THE SCHOOL'S HEALTH OFFICE.

11 B. ON REQUEST BY A STUDENT'S PARENT OR GUARDIAN, EACH SCHOOL  
12 DISTRICT OR CHARTER SCHOOL SHALL PROVIDE INFORMATION DESCRIBING THE TYPES  
13 OF EMERGENCY RESPONSE TRAINING, INCLUDING CARDIOPULMONARY RESUSCITATION  
14 TRAINING, THAT THE SCHOOL DISTRICT OR CHARTER SCHOOL REQUIRES SCHOOL  
15 EMPLOYEES TO COMPLETE.

16 C. THIS SECTION DOES NOT REQUIRE A SCHOOL DISTRICT OR CHARTER  
17 SCHOOL TO RELEASE THE PERSONALLY IDENTIFIABLE INFORMATION OF A SCHOOL  
18 EMPLOYEE OR AN INDIVIDUAL WHO PROVIDES ROUTINE HEALTH CARE SERVICES TO  
19 STUDENTS, INCLUDING THE EMPLOYEE'S OR INDIVIDUAL'S ADDRESS, SALARY, SOCIAL  
20 SECURITY NUMBER OR TELEPHONE NUMBER.

21 D. FOR THE PURPOSES OF THIS SECTION, "HEALTH CARE CREDENTIALS"  
22 MEANS A LICENSE, CERTIFICATE, PERMIT OR REGISTRATION TO PRACTICE A HEALTH  
23 CARE PROFESSION UNDER TITLE 32.
