HOUSE OF REPRESENTATIVES AMENDMENTS TO H.B. 2058

(Reference to printed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Title 15, chapter 14, article 2, Arizona Revised
3 Statutes, is amended by adding section 15-1825, to read:

4 15-1825. Proof of immunizations: exemptions: definitions

5 A. IF A HIGHER EDUCATION INSTITUTION REQUIRES STUDENTS TO SUBMIT
6 DOCUMENTARY PROOF TO ENROLL IN OR ATTEND THE HIGHER EDUCATION INSTITUTION,
7 THE HIGHER EDUCATION INSTITUTION SHALL DO BOTH OF THE FOLLOWING:

8 1. FULLY DISCLOSE TO PROSPECTIVE STUDENTS THE REQUIREMENTS AND
9 EXEMPTIONS PRESCRIBED IN THIS SECTION.

10 2. EXEMPT ANY STUDENT WHO IS AT LEAST EIGHTEEN YEARS OF AGE FROM THE
11 REQUIREMENT IF THE STUDENT SUBMITS EITHER OF THE FOLLOWING:

12 (a) A SIGNED STATEMENT THAT THE STUDENT BOTH:

13 (i) HAS RECEIVED INFORMATION ABOUT IMMUNIZATIONS PROVIDED BY THE
14 DEPARTMENT OF HEALTH SERVICES AND UNDERSTANDS THE RISKS AND BENEFITS OF
15 IMMUNIZATIONS AND THE POTENTIAL RISKS OF NONIMMUNIZATION.

16 (ii) DOES NOT CONSENT TO THE IMMUNIZATIONS DUE TO PERSONAL BELIEFS,
17 INCLUDING RELIGIOUS BELIEFS.

18 (b) A WRITTEN CERTIFICATION THAT IS SIGNED BY THE STUDENT AND BY A
19 PHYSICIAN OR A REGISTERED NURSE PRACTITIONER, THAT STATES THAT ONE OR MORE
20 OF THE REQUIRED IMMUNIZATIONS MAY BE DETRIMENTAL TO THE STUDENT'S HEALTH
21 AND THAT INDICATES THE SPECIFIC NATURE AND PROBABLE DURATION OF THE MEDICAL
22 CONDITION OR CIRCUMSTANCE THAT PRECLUDES IMMUNIZATION. AN EXEMPTION UNDER

1 THIS SUBDIVISION IS VALID ONLY DURING THE DURATION OF THE CIRCUMSTANCE OR
2 CONDITION THAT PRECLUDES IMMUNIZATION.

3 B. FOR THE PURPOSES OF THIS SECTION:

4 1. "DOCUMENTARY PROOF" HAS THE SAME MEANING PRESCRIBED IN SECTION
5 15-871.

6 2. "HIGHER EDUCATION INSTITUTION" INCLUDES ANY OF THE FOLLOWING:

7 (a) A UNIVERSITY UNDER THE JURISDICTION OF THE ARIZONA BOARD OF
8 REGENTS.

9 (b) A COMMUNITY COLLEGE AS DEFINED IN SECTION 15-1401.

10 (c) A CAREER TECHNICAL EDUCATION DISTRICT THAT PROVIDES INSTRUCTION
11 TO ADULT STUDENTS."
