1 Strike everything after the enacting clause and insert:

29 A. NOTWITHSTANDING ANY OTHER LAW, A CITY SHALL SATISFY ANY STATUTORY
30 REQUIREMENT FOR ADVERTISING, PUBLISHING OR PRINTING BY PLACING THE
31 ADVERTISING, PUBLISHING OR PRINTING ON THE OFFICIAL WEBSITE OF THE CITY.

32 B. A CITY THAT POSTS PUBLIC NOTICES ON THE OFFICIAL WEBSITE OF THE

3 11-225. Counties; advertising; publishing; printing; official
4 website

5 A. NOTWITHSTANDING ANY OTHER LAW, A COUNTY SHALL SATISFY ANY
6 STATUTORY REQUIREMENT FOR ADVERTISING, PUBLISHING OR PRINTING BY PLACING
7 THE ADVERTISING, PUBLISHING OR PRINTING ON THE OFFICIAL WEBSITE OF THE
8 COUNTY.

9 B. A COUNTY THAT POSTS PUBLIC NOTICES ON THE OFFICIAL WEBSITE OF THE
10 COUNTY SHALL INCLUDE A PUBLIC NOTICES LINK AT THE TOP OF THE HOME PAGE OF
11 THE WEBSITE OF THE COUNTY THAT LINKS TO ALL STATUTORILY REQUIRED
12 ADVERTISING, PUBLISHING OR PRINTING, LISTED BY CATEGORY.

13 Sec. 5. Repeal

14 Section 11-255, Arizona Revised Statutes, is repealed.

15 Sec. 6. Conforming legislation

16 The legislative council staff shall prepare proposed legislation
17 conforming the Arizona Revised Statutes to the provisions of this act for
18 consideration in the fifty-seventh legislature, second regular session."
