

PROPOSED
SENATE AMENDMENTS TO S.B. 1693
(Reference to printed bill)

Amendment instruction key:

1 The bill as proposed to be amended is reprinted as follows:

2 Section 1. Title 15, chapter 8, article 1, Arizona Revised
3 Statutes, is amended by adding sections 15-802.02 and 15-802.03, to read:

4 15-802.02. Interscholastic activities; private school
5 students; eligibility to participate;
6 prohibition; definition

7 A. NOTWITHSTANDING ANY OTHER LAW, A PRIVATE SCHOOL STUDENT WHO
8 RESIDES IN THE ATTENDANCE AREA OF A PUBLIC SCHOOL SHALL BE ALLOWED TO TRY
9 OUT FOR INTERSCHOLASTIC ACTIVITIES ON BEHALF OF THE PUBLIC SCHOOL IN THE
10 SAME MANNER AS A STUDENT WHO IS ENROLLED IN THE PUBLIC SCHOOL. EXCEPT AS
11 PROVIDED IN SECTION 15-802.03, THE POLICIES AND REQUIREMENTS RELATING TO
12 REGISTRATION, AGE ELIGIBILITY, FEES, INSURANCE, TRANSPORTATION, PHYSICAL
13 CONDITION, QUALIFICATIONS, RESPONSIBILITIES, EVENT SCHEDULES, STANDARDS OF
14 BEHAVIOR AND PERFORMANCE FOR PRIVATE SCHOOL STUDENTS PARTICIPATING IN OR
15 TRYING OUT FOR INTERSCHOLASTIC ACTIVITIES SHALL BE CONSISTENT WITH THE
16 POLICIES AND REQUIREMENTS ESTABLISHED FOR STUDENTS ENROLLED IN THE PUBLIC
17 SCHOOL.

18 B. THE PARENT OF A PRIVATE SCHOOL STUDENT WHO TRIES OUT FOR AN
19 INTERSCHOLASTIC ACTIVITY PURSUANT TO THIS SECTION SHALL SUBMIT WRITTEN
20 VERIFICATION TO THE PUBLIC SCHOOL THAT THE STUDENT IS BOTH:

21 1. RECEIVING A PASSING GRADE IN EACH COURSE OR SUBJECT THE STUDENT
22 IS BEING TAUGHT.

23 2. MAINTAINING SATISFACTORY PROGRESS TOWARDS ADVANCEMENT OR
24 PROMOTION.

25 C. A PRIVATE SCHOOL STUDENT WHO WAS PREVIOUSLY ENROLLED IN A SCHOOL
26 DISTRICT, CHARTER SCHOOL OR DIFFERENT PRIVATE SCHOOL IS INELIGIBLE TO
27 PARTICIPATE IN INTERSCHOLASTIC ACTIVITIES FOR THE REMAINDER OF THE SCHOOL
28 YEAR DURING WHICH THE STUDENT WAS PREVIOUSLY ENROLLED.

1 D. A SCHOOL DISTRICT MAY NOT CONTRACT WITH ANY PRIVATE ENTITY THAT
2 SUPERVISES INTERSCHOLASTIC ACTIVITIES IF THE PRIVATE ENTITY PROHIBITS
3 PRIVATE SCHOOL STUDENTS FROM PARTICIPATING IN INTERSCHOLASTIC ACTIVITIES
4 AT PUBLIC, PRIVATE OR CHARTER SCHOOLS.

5 E. FOR THE PURPOSES OF THIS SECTION, "PRIVATE SCHOOL STUDENT" MEANS
6 A STUDENT WHO RESIDES WITHIN THE ATTENDANCE AREA OF A PUBLIC SCHOOL AND
7 WHO IS EDUCATED IN A PRIVATE SCHOOL AS DEFINED IN SECTION 15-802 THAT DOES
8 NOT OFFER THE INTERSCHOLASTIC ACTIVITY FOR WHICH THE STUDENT IS TRYING
9 OUT.

10 15-802.03. Interscholastic activities; nonpublic school
11 students; maximum participation fees

12 A. NOTWITHSTANDING ANY OTHER LAW, A PUBLIC SCHOOL MAY NOT CHARGE A
13 PARTICIPATION FEE FOR A STUDENT WHO IS NOT ENROLLED IN THE PUBLIC SCHOOL
14 TO PARTICIPATE IN ONE OR MORE INTERSCHOLASTIC ACTIVITIES PURSUANT TO
15 SECTION ~~[15-802.01 OR]~~ 15-802.02 THAT EXCEEDS THE STUDENT'S PRO RATA SHARE
16 OF THE PROGRAM COSTS. FOR THE PURPOSES OF THIS SECTION, A STUDENT'S PRO
17 RATA SHARE IS CALCULATED BY DIVIDING THE TOTAL AMOUNT THAT THE PUBLIC
18 SCHOOL HAS BUDGETED FOR THE INTERSCHOLASTIC ACTIVITY BY THE TOTAL NUMBER
19 OF STUDENTS WHO ARE PARTICIPATING IN THE INTERSCHOLASTIC ACTIVITY DURING
20 THE BUDGET YEAR.

21 B. THIS SECTION DOES NOT PREVENT A PUBLIC SCHOOL FROM REQUIRING
22 STUDENTS WHO PARTICIPATE IN ONE OR MORE INTERSCHOLASTIC ACTIVITIES
23 PURSUANT TO SECTION ~~[15-802.01 OR]~~ 15-802.02 TO PAY FOR EXPENSES RELATED
24 TO THE INTERSCHOLASTIC ACTIVITY IF THE PUBLIC SCHOOL REQUIRES ALL
25 PARTICIPATING STUDENTS, INCLUDING STUDENTS WHO ARE ENROLLED IN THE PUBLIC
26 SCHOOL, TO PAY FOR THOSE EXPENSES.

27 Enroll and engross to conform
