AN ACT

AMENDING TITLE 16, CHAPTER 1, ARTICLE 1.1, ARIZONA REVISED STATUTES, BY
ADDING SECTION 16-112.01; RELATING TO QUALIFICATION AND REGISTRATION OF
ELECTORS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 16, chapter 1, article 1.1, Arizona Revised
3 Statutes, is amended by adding section 16-112.01, to read:

4 16-112.01. Voter registration information; department of
5 transportation

6 A. NOTWITHSTANDING ANY OTHER LAW AND FOR THE PURPOSES OF ENSURING
7 COMPLIANCE WITH THE NATIONAL VOTER REGISTRATION ACT OF 1993 (P.L. 103-31;
8 107 STAT. 77; 52 UNITED STATES CODE SECTIONS 20501 THROUGH 20511), WHEN
9 THE DEPARTMENT OF TRANSPORTATION RECEIVES VOTER REGISTRATION INFORMATION
10 FROM A REGISTRANT PURSUANT TO SECTION 16-112, THE DEPARTMENT OF
11 TRANSPORTATION SHALL SIMULTANEOUSLY TRANSMIT THAT INFORMATION DIRECTLY TO
12 BOTH THE SECRETARY OF STATE AND THE COUNTY RECORDER OF THE COUNTY IN WHICH
13 THE REGISTRANT RESIDES AND SHALL NOT TRANSMIT THAT INFORMATION THROUGH THE
14 SECRETARY OF STATE.

15 B. THE DEPARTMENT OF TRANSPORTATION SHALL ENSURE THAT ALL VOTER
16 REGISTRATION INFORMATION THAT IS COLLECTED AT DRIVER LICENSE OFFICES,
17 INCLUDING THE REGISTRANT'S NAME, ADDRESS, DATE OF BIRTH AND DIGITIZED
18 SIGNATURE, IS SENT TO THE APPROPRIATE COUNTY RECORDER WITHIN FIVE BUSINESS
19 DAYS AFTER RECEIPT OF A COMPLETED REGISTRATION APPLICATION, REQUEST FOR
20 RENEWAL OR REVISION TO THE REGISTRATION INFORMATION.

21 C. EXCEPT FOR VOTER REGISTRATION PURPOSES, THIS SECTION DOES NOT
22 PRECLUDE THE DEPARTMENT OF TRANSPORTATION FROM PROVIDING VOTER
23 REGISTRATION INFORMATION TO THE SECRETARY OF STATE FOR PURPOSES OTHER THAN
24 THOSE PRESCRIBED IN SUBSECTION A OF THIS SECTION.

25 D. THIS SECTION DOES NOT DIMINISH OR ALTER THE DUTIES OF THE
26 SECRETARY OF STATE UNDER STATE OR FEDERAL LAW REGARDING VOTER REGISTRATION
27 AND ELECTION ADMINISTRATION.

28 Sec. 2. Effective date

29 Section 16-112.01, Arizona Revised Statutes, as added by this act,
30 is effective from and after December 31, 2025.

31 Sec. 3. Severability

32 If a provision of this act or its application to any person or
33 circumstance is held invalid, the invalidity does not affect other
34 provisions or applications of the act that can be given effect without the
35 invalid provision or application, and to this end the provisions of this
36 act are severable.
