AN ACT

AMENDING TITLE 9, CHAPTER 4, ARTICLE 8, ARIZONA REVISED STATUTES, BY ADDING SECTION 9-500.52; AMENDING TITLE 11, CHAPTER 2, ARTICLE 4, ARIZONA REVISED STATUTES, BY ADDING SECTION 11-269.30; AMENDING TITLE 15, CHAPTER 1, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 15-120.05; AMENDING TITLE 41, CHAPTER 23, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-2505; RELATING TO GOVERNMENT CONTRACTS.

1 Be it enacted by the Legislature of the State of Arizona:

9 B. A CONTRACTOR THAT ENTERS INTO A TASK ORDER CONTRACT WITH A CITY
10 OR TOWN MAY REDACT ANY PERSONAL OR PROPRIETARY INFORMATION FROM THE
11 CONTRACT BEFORE THE CONTRACT IS POSTED ON THE CITY'S OR TOWN'S WEBSITE
12 PURSUANT TO SUBSECTION A OF THIS SECTION.

13 C. NOTWITHSTANDING SUBSECTION B OF THIS SECTION, THE FOLLOWING MAY
14 NOT BE REDACTED:
