SENATE BILL 1028

AN ACT

AMENDING SECTIONS 15-701.01, 15-702 AND 15-808, ARIZONA REVISED STATUTES;
RELATING TO HIGH SCHOOL GRADUATION REQUIREMENTS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 15-701.01, Arizona Revised Statutes, is amended
3 to read:

4 15-701.01. High schools; graduation; requirements; community
5 college or university courses; transfer from
6 other schools; academic credit; report

7 A. The state board of education shall:

8 1. Prescribe a minimum course of study that incorporates the
9 academic standards adopted by the state board for the graduation of pupils
10 from high school.

11 2. Prescribe competency requirements for the graduation of pupils
12 from high school incorporating the academic standards in at least the
13 areas of reading, writing, mathematics, science and social studies **AND THE**
14 **MINIMUM PERFORMANCE LEVEL REQUIREMENT DETERMINED PURSUANT TO SUBSECTION B,**
15 **PARAGRAPH 1 OF THIS SECTION.** The academic standards prescribed by the
16 state board in social studies shall include personal finance, American
17 civics education and a comparative discussion of political ideologies,
18 such as communism and totalitarianism, that conflict with the principles
19 of freedom and democracy that are essential to the founding principles of
20 the United States. The state board may consider establishing a required
21 separate personal finance course for the purpose of the graduation of
22 pupils from high school. The state board shall require at least one-half
23 of a course credit in economics, which shall include financial literacy
24 and personal financial management.

25 3. Through the graduating class of 2025, include in the competency
26 requirements for social studies prescribed in paragraph 2 of this
27 subsection a requirement that, in order to graduate from high school or
28 obtain a high school equivalency diploma, a pupil must correctly answer at
29 least sixty of the one hundred questions listed on a test that is
30 identical to the civics portion of the naturalization test used by the
31 United States citizenship and immigration services. Beginning with the
32 graduating class of 2026, the state board shall include in the competency
33 requirements for social studies prescribed in paragraph 2 of this
34 subsection a requirement that, in order to graduate from high school or
35 obtain a high school equivalency diploma, a pupil must correctly answer at
36 least seventy of the one hundred questions listed on a test that is
37 identical to the civics portion of the naturalization test used by the
38 United States citizenship and immigration services. A district school or
39 charter school shall document on the pupil's transcript only a pass or
40 fail designation that the pupil has passed or failed the test required by
41 this paragraph. A pupil in grade seven or eight may take the test
42 described in this paragraph, and if the pupil correctly answers at least
43 seventy of the one hundred questions on the test:

1 (a) The district school or charter school shall document on the
2 pupil's transcript only a pass or fail designation that the pupil has
3 passed or failed the test required by this paragraph.

4 (b) The pupil is not required to take the test required by this
5 paragraph again in high school.

6 4. Develop and adopt competency tests pursuant to section 15-741.
7 English language learners who are subject to article 3.1 of this chapter
8 are subject to the assessments prescribed in section 15-741.

9 B. THE DEPARTMENT OF EDUCATION SHALL:

10 1. ESTABLISH A METHOD AND STANDARD FOR DETERMINING THE MINIMUM
11 PERFORMANCE LEVEL ON THE STATEWIDE ASSESSMENT ADOPTED PURSUANT TO SECTION
12 15-741 REQUIRED FOR GRADUATION FROM HIGH SCHOOL.

13 2. NOTWITHSTANDING SECTION 15-741, SUBSECTION B, PRESCRIBE A
14 SCHEDULE FOR ADMINISTERING THE STATEWIDE ASSESSMENT ADOPTED PURSUANT TO
15 SECTION 15-741 TO PUPILS IN HIGH SCHOOL. THE SCHEDULE PRESCRIBED PURSUANT
16 TO THIS PARAGRAPH MUST PROVIDE AT LEAST TWO OPPORTUNITIES FOR PUPILS TO
17 TAKE THE STATEWIDE ASSESSMENT IN EACH OF GRADES ELEVEN AND TWELVE.

18 C. NOTWITHSTANDING CHAPTER 7, ARTICLE 3 OF THIS TITLE AND
19 SUBSECTION A OF THIS SECTION, A PUPIL IS NOT REQUIRED TO PASS AN
20 ASSESSMENT ADOPTED PURSUANT TO SECTION 15-741 OR 15-741.02 IN GRADE ELEVEN
21 OR TWELVE TO GRADUATE FROM HIGH SCHOOL IF THE PUPIL EITHER:

22 1. OBTAINS A PASSING SCORE ON A TECHNICAL SKILLS ASSESSMENT TEST
23 FOR A CAREER AND TECHNICAL EDUCATION PROGRAM THAT IS APPROVED BY THE
24 DEPARTMENT.

25 2. OBTAINS AN INDUSTRY CERTIFICATION THROUGH A CAREER AND TECHNICAL
26 EDUCATION PROGRAM THAT IS APPROVED BY THE DEPARTMENT.

27 D. A PUPIL WHO HAS AN INDIVIDUALIZED EDUCATION PROGRAM OR A SECTION
28 504 PLAN AS DEFINED IN SECTION 15-731 IS NOT REQUIRED TO PASS THE
29 STATEWIDE ASSESSMENT TO GRADUATE FROM HIGH SCHOOL. THE PUPIL'S
30 INDIVIDUALIZED EDUCATION PROGRAM OR SECTION 504 PLAN SHALL INCLUDE ANY
31 NECESSARY TESTING ACCOMMODATIONS AS REQUIRED BY SECTION 15-763.

32 ~~B.~~ E. The governing board of a school district shall:

33 1. Prescribe curricula that include the academic standards in the
34 required subject areas pursuant to subsection A, paragraph 1 of this
35 section.

36 2. Prescribe criteria for the graduation of pupils from the high
37 schools in the school district. These criteria shall include
38 accomplishment of the academic standards in at least reading, writing,
39 mathematics, science and social studies, as determined by district
40 assessment AND BY EITHER THE MINIMUM PERFORMANCE LEVEL ON THE STATEWIDE
41 ASSESSMENT DETERMINED PURSUANT TO SUBSECTION B, PARAGRAPH 1 OF THIS
42 SECTION OR SATISFACTION OF THE REQUIREMENTS UNDER SUBSECTION C OF THIS
43 SECTION. Other criteria may include additional measures of academic
44 achievement and attendance. Pursuant to the prescribed graduation
45 requirements adopted by the state board of education, the governing board

1 may approve a rigorous computer science course that would fulfill a
 2 mathematics course required for graduation from high school. The
 3 governing board may approve a rigorous computer science course only if the
 4 rigorous computer science course includes significant mathematics content
 5 and the governing board determines the high school where the rigorous
 6 computer science course is offered has sufficient capacity, infrastructure
 7 and qualified staff, including competent teachers of computer science.
 8 The school district governing board or charter school governing body may
 9 determine the method and manner in which to administer a test that is
 10 identical to the civics portion of the naturalization test used by the
 11 United States citizenship and immigration services. A pupil who does not
 12 obtain a passing score on the test that is identical to the civics portion
 13 of the naturalization test may retake the test until the pupil obtains a
 14 passing score.

15 ~~E.~~ F. The governing board OF A SCHOOL DISTRICT may:

16 1. Prescribe the course of study and competency requirements for
 17 the graduation of pupils from high school that are in addition to or
 18 higher than the course of study and competency requirements ~~that the state~~
 19 ~~board prescribes~~ PRESCRIBED BY THE STATE BOARD OF EDUCATION.

20 2. PROVIDE TO PUPILS IN GRADE NINE OR TEN, OR BOTH, ANY
 21 INSTRUCTION, MATERIALS OR OTHER SERVICES NECESSARY TO PREPARE FOR THE
 22 STATEWIDE ASSESSMENT ADOPTED PURSUANT TO SECTION 15-741.

23 ~~D.~~ G. The governing board may prescribe competency requirements
 24 for the passage of pupils in courses that are required for graduation from
 25 high school.

26 ~~E.~~ H. A teacher shall determine whether to pass or fail a pupil in
 27 a course in high school on the basis of the competency requirements, if
 28 any have been prescribed. The governing board, if it reviews the decision
 29 of a teacher to pass or fail a pupil in a course in high school as
 30 provided in section 15-342, paragraph 11, shall base its decision on the
 31 competency requirements, if any have been prescribed.

32 ~~F.~~ I. Graduation requirements established by the governing board
 33 may be met by a pupil who passes courses in the required or elective
 34 subjects at a community college or university, if the course is at a
 35 higher level than the course taught in the high school attended by the
 36 pupil or, if the course is not taught in the high school, the level of the
 37 course is equal to or higher than the level of a high school course. The
 38 governing board shall determine whether the subject matter of the
 39 community college or university course is appropriate to the specific
 40 requirement the pupil intends it to fulfill and whether the level of the
 41 community college or university course is less than, equal to or higher
 42 than a high school course, and the governing board shall award at least
 43 one-half of a Carnegie unit and up to and including one Carnegie unit for
 44 each three semester hours of credit that the pupil earns in an appropriate
 45 community college or university course. If a pupil is not satisfied with

1 the decision of the governing board regarding the amount of credit granted
2 or the subjects for which credit is granted, the pupil may request that
3 the state board of education review the decision of the governing board,
4 and the state board shall make the final determination of the amount of
5 credit to be given the pupil and for which subjects. The governing board
6 shall not limit the number of credits that is required for high school
7 graduation and that may be met by taking community college or university
8 courses. For the purposes of this subsection:

9 1. "Community college" means an educational institution that is
10 operated by a community college district as defined in section 15-1401 or
11 a postsecondary educational institution under the jurisdiction of an
12 Indian tribe recognized by the United States department of the interior.

13 2. "University" means a university under the jurisdiction of the
14 Arizona board of regents.

15 ~~H.~~ J. A pupil who transfers from a private school shall be
16 provided with a list that indicates those credits that have been accepted
17 and denied by the school district. A pupil may request to take an
18 examination in each particular course in which credit has been denied.
19 The school district shall accept the credit for each particular course in
20 which the pupil takes an examination and receives a passing score on a
21 test designed and evaluated by a teacher in the school district who
22 teaches the subject matter on which the examination is based. In addition
23 to the above requirements, the governing board of a school district may
24 prescribe requirements for the acceptance of the credits of pupils who
25 transfer from a private school.

26 ~~H.~~ K. If a pupil who was previously enrolled in a charter school
27 or school district enrolls in a school district in this state, the school
28 district shall accept credits earned by the pupil in courses or
29 instructional programs at the charter school or school district. The
30 governing board of a school district may adopt a policy concerning the
31 application of transfer credits for the purpose of determining whether a
32 credit earned by a pupil who was previously enrolled in a school district
33 or charter school will be assigned as an elective or core credit. A
34 school district or charter school may note the learning outcomes that a
35 student mastered as prescribed in the rules adopted pursuant to section
36 15-203, subsection A, paragraph 38 to provide a record of the demonstrated
37 competencies and award partial credit.

38 ~~H.~~ L. A pupil who transfers credit from a charter school, a school
39 district or Arizona online instruction shall be provided with a list that
40 indicates which credits have been accepted as elective credits and which
41 credits have been accepted as core credits by the school district or
42 charter school. Within ten school days after receiving the list, the
43 pupil may request to take an examination in each particular course in
44 which core credit has been denied. The school district or charter school
45 shall accept the credit as a core credit for each particular course in

1 which the pupil takes an examination and receives a passing score on a
2 test that is aligned to the competency requirements adopted pursuant to
3 this section and that is designed and evaluated by a teacher in the school
4 district or charter school who teaches the subject matter on which the
5 examination is based. If a pupil is enrolled in a school district or
6 charter school and that pupil also participates in Arizona online
7 instruction between May 1 and July 31, the school district or charter
8 school shall not require proof of payment as a condition of the school
9 district or charter school accepting credits earned from the online course
10 provider.

11 ~~J.~~ M. The state board of education shall adopt rules to allow high
12 school pupils who can demonstrate competency in a particular academic
13 course or subject to obtain academic credit for the course or subject
14 without enrolling in the course or subject.

15 ~~K.~~ N. Pupils who earn a Grand Canyon diploma pursuant to article 6
16 of this chapter are exempt from the graduation requirements prescribed in
17 this section. Pupils who earn a Grand Canyon diploma are entitled to all
18 the rights and privileges of persons who graduate with a high school
19 diploma issued pursuant to this section, including access to postsecondary
20 scholarships and other forms of student financial aid and access to all
21 forms of postsecondary education. Notwithstanding any other law, a pupil
22 who is eligible for a Grand Canyon diploma may elect to remain in high
23 school through grade twelve and shall not be prevented from enrolling at a
24 high school after the pupil becomes eligible for a Grand Canyon diploma.
25 A pupil who is eligible for a Grand Canyon diploma and who elects not to
26 pursue one of the options prescribed in section 15-792.03 may only be
27 readmitted to that high school or another high school in this state
28 pursuant to policies adopted by the school district of readmission.

29 ~~L.~~ O. Each school district and charter school shall report to the
30 department of education all of the following aggregate data, organized by
31 grade level, relating to the test that is identical to the civics portion
32 of the naturalization test used by the United States citizenship and
33 immigration services required by subsection A, paragraph 3 of this
34 section:

- 35 1. The median score.
- 36 2. The percentage of pupils who passed by correctly answering the
37 minimum number of questions required to pass the test pursuant to
38 subsection A, paragraph 3 of this section.
- 39 3. The percentage of pupils who failed by correctly answering fewer
40 than the minimum number of questions required to pass the test pursuant to
41 subsection A, paragraph 3 of this section.
- 42 4. Any other data required by the department relating to the test.

1 ~~M.~~ P. A school district or charter school may not include the
2 personally identifiable information of any pupil in the data reported to
3 the department of education under subsection ~~0~~ of this section. The
4 department of education shall make the data publicly available, organized
5 at a minimum by school district or charter school and grade level, on the
6 website that includes the school report cards required by section 15-746.

7 Sec. 2. Section 15-702, Arizona Revised Statutes, is amended to
8 read:

9 15-702. High school equivalency diploma; fees; rules

10 A. Any person who is sixteen years of age or older and who passes
11 an equivalency test adopted by the state board of education shall be
12 awarded an Arizona high school equivalency diploma by the state board of
13 education and the state superintendent of public instruction. The state
14 board of education may establish eligibility requirements for persons
15 wishing to take ~~an~~ THE equivalency test adopted by the state board of
16 education, except that the minimum age required to take the test may not
17 be older than sixteen ~~nor shall~~ AND the board MAY NOT require the
18 completion of any high school credits.

19 B. A person who meets the minimum course of study and competency
20 requirements prescribed by the state board of education for graduation
21 from high school through a combination of high school credits and
22 community college and university credits, which are converted to high
23 school credits in the same manner as provided in section 15-701.01,
24 subsection ~~F~~ I by the SCHOOL DISTRICT governing board or the state board
25 of education, shall be awarded an Arizona high school equivalency diploma.

26 C. The state board of education may establish and collect fees for
27 ~~the issuance~~ ISSUING and ~~reissuance of~~ REISSUING the following:

- 28 1. A high school equivalency diploma.
- 29 2. A high school equivalency transcript.

30 D. The state board of education shall adopt rules for fee waivers
31 for the high school equivalency diploma and high school equivalency
32 transcripts.

33 Sec. 3. Section 15-808, Arizona Revised Statutes, is amended to
34 read:

35 15-808. Arizona online instruction; reports; definitions

36 A. Arizona online instruction shall be instituted to meet the needs
37 of pupils in the information age. The state board of education shall
38 select district public schools and state-approved charter authorizers
39 shall sponsor charter schools to be online course providers or online
40 schools. The state board of education and state-approved charter
41 authorizers shall develop standards for the approval of online course
42 providers and online schools based on the following criteria:

- 43 1. The depth and breadth of curriculum choices.
 - 44 2. The variety of educational methodologies employed by the school
- 45 and the means of addressing the unique needs and learning styles of

1 targeted pupil populations, including computer-assisted learning systems,
2 virtual classrooms, virtual laboratories, electronic field trips, ~~e-mail~~
3 EMAIL, virtual tutoring, online help desk, group chat sessions and
4 noncomputer-based activities performed under the direction of a
5 certificated teacher.

6 3. The availability of an intranet or private network to safeguard
7 pupils against predatory and pornographic elements of the internet.

8 4. The availability of filtered research access to the internet.

9 5. The availability of private individual ~~e-mail~~ EMAIL between
10 pupils, teachers, administrators and parents in order to protect the
11 confidentiality of pupil records and information.

12 6. The availability of faculty members who are experienced with
13 computer networks, the internet and computer animation.

14 7. The extent to which the school intends to develop partnerships
15 with universities, community colleges and private businesses.

16 8. The services offered to populations with developmental
17 disabilities.

18 9. The grade levels that will be served.

19 B. Each new school that provides online instruction shall provide
20 online instruction on a probationary status. After a new school that
21 provides online instruction has clearly demonstrated the academic
22 integrity of its instruction through the actual improvement of the
23 academic performance of its students, the school may apply to be removed
24 from probationary status. The state board of education or the
25 state-approved charter authorizer that sponsored the charter school shall
26 remove from Arizona online instruction any probationary school that fails
27 to clearly demonstrate improvement in academic performance within three
28 years measured against goals in the approved application and the state's
29 accountability system. All pupils who participate in Arizona online
30 instruction shall reside in this state. Pupils who participate in Arizona
31 online instruction are subject to the testing requirements prescribed in
32 chapter 7, article 3 of this title. On enrollment, the school shall
33 notify the parents or guardians of the pupil of the state testing
34 requirements. If a pupil fails to comply with the testing requirements
35 and the school administers the tests pursuant to this subsection to less
36 than ninety-five percent of the pupils in Arizona online instruction, the
37 pupil shall not be allowed to participate in Arizona online instruction.

38 C. The state board of education and state-approved charter
39 authorizers shall develop annual reporting mechanisms for schools that
40 participate in Arizona online instruction.

41 D. The department of education shall compile the information
42 submitted in the annual reports by schools participating in Arizona online
43 instruction. The department of education shall submit the compiled report
44 to the governor, the speaker of the house of representatives and the
45 president of the senate by November 15 of each year.

1 E. Each school selected for Arizona online instruction shall ensure
2 that a daily log is maintained for each pupil who participates in Arizona
3 online instruction. The daily log shall describe the amount of time spent
4 by each pupil participating in Arizona online instruction pursuant to this
5 section on academic tasks. The daily log shall be used by the school
6 district or charter school to qualify the pupils who participate in
7 Arizona online instruction in the school's average daily attendance
8 calculations pursuant to subsection F of this section.

9 F. If a pupil is enrolled in a school district or charter school
10 and also participates in Arizona online instruction, the sum of the
11 average daily membership, which includes enrollment as prescribed in
12 section 15-901, subsection A, paragraph 1, subdivisions (a) and (b) and
13 daily attendance as prescribed in section 15-901, subsection A, paragraph
14 5, for that pupil in the school district or charter school and in Arizona
15 online instruction shall not exceed 1.0. If the pupil is enrolled in a
16 school district or a charter school and also participates in Arizona
17 online instruction and the sum of the daily membership or daily attendance
18 for that pupil is greater than 1.0, the sum shall be reduced to 1.0 and
19 shall be apportioned between the school district, unless the school
20 district is a career technical education district subject to the
21 apportionment requirements of section 15-393, or charter school and
22 Arizona online instruction based on the percentage of total time that the
23 pupil is enrolled or in attendance in the school district or charter
24 school and Arizona online instruction. The uniform system of financial
25 records shall include guidelines for the apportionment of the pupil
26 enrollment and attendance as provided in this subsection. Pupils in
27 Arizona online instruction do not incur absences for purposes of this
28 subsection and may generate an average daily attendance of 1.0 for
29 attendance hours during any hour of the day, during any day of the week
30 and at any time between July 1 and June 30 of each fiscal year. For
31 kindergarten programs and grades one through eight, average daily
32 membership shall be calculated by dividing the instructional hours as
33 reported in the daily log required in subsection E of this section by the
34 applicable hourly requirements prescribed in section 15-901. For grades
35 nine through twelve, average daily membership shall be calculated by
36 dividing the instructional hours as reported in the daily log required in
37 subsection E of this section by nine hundred. The average daily
38 membership of a pupil who participates in online instruction shall not
39 exceed 1.0. Average daily membership shall not be calculated on the one
40 hundredth day of instruction for the purposes of this section. Funding
41 shall be determined as follows:

42 1. A pupil who is enrolled ~~full-time~~ FULL TIME in Arizona online
43 instruction shall be funded for online instruction at ninety-five percent
44 of the base support level that would be calculated for that pupil if that
45 pupil were enrolled as a full-time student in a school district or charter

1 school that does not participate in Arizona online instruction. Charter
2 additional assistance and district additional assistance shall be
3 calculated in the same manner they would be calculated if the student were
4 enrolled in a district or charter school that does not participate in
5 Arizona online instruction.

6 2. A pupil who is enrolled ~~part-time~~ PART TIME in Arizona online
7 instruction shall be funded for online instruction at eighty-five percent
8 of the base support level that would be calculated for that pupil if that
9 pupil were enrolled as a part-time student in a school district or charter
10 school that does not participate in Arizona online instruction. Charter
11 additional assistance and district additional assistance shall be
12 calculated in the same manner they would be calculated if the student were
13 enrolled in a district or charter school that does not participate in
14 Arizona online instruction.

15 G. If the academic achievement of a pupil declines while the pupil
16 is participating in Arizona online instruction, the pupil's parents, the
17 pupil's teachers and the principal or head teacher of the school shall
18 confer to evaluate whether the pupil should be allowed to continue to
19 participate in Arizona online instruction.

20 H. To ensure the academic integrity of pupils who participate in
21 online instruction, Arizona online instruction shall include multiple
22 diverse assessment measures and the proctored administration of required
23 state standardized tests.

24 I. A school district or charter school may not charge a fee to a
25 pupil who takes an examination in a particular course to obtain academic
26 credit, pursuant to section 15-701.01, subsection ~~F~~ L, from the school
27 district or charter school if the academic credit for a course was
28 previously earned in an Arizona online instruction course or at any public
29 school in this state. Any test administered pursuant to this subsection
30 shall be an assessment that is aligned to the course-relevant state
31 academic standards.

32 J. For the purposes of this section:

33 1. "Full-time student" means:

34 (a) A student who is at least five years of age before September 1
35 of a school year and who is enrolled in a school kindergarten program that
36 meets at least three hundred forty-six hours during the school year.

37 (b) A student who is at least six years of age before September 1
38 of a school year, who has not graduated from the highest grade taught in
39 the school and who is regularly enrolled in a course of study required by
40 the state board of education. For first, second and third grade students,
41 the instructional program shall meet at least seven hundred twelve hours.
42 For fourth, fifth and sixth grade students, the instructional program
43 shall meet at least eight hundred ninety hours during the school year.

1 (c) Seventh and eighth grade students or ungraded students who are
2 at least twelve, but under fourteen, years of age on or before September 1
3 and who are enrolled in an instructional program of courses that meets at
4 least one thousand sixty-eight hours during the school year.

5 (d) For high schools, a student who has not graduated from the
6 highest grade taught in the school district, or an ungraded student who is
7 at least fourteen years of age on or before September 1, and who is
8 enrolled in at least four courses throughout the year that meet at least
9 nine hundred hours during the school year. A full-time student shall not
10 be counted more than once for computation of average daily membership.

11 2. "Online course provider" means a school other than an online
12 school that is selected by the state board of education or a
13 state-approved charter authorizer to participate in Arizona online
14 instruction pursuant to this section and that provides at least one online
15 academic course that is approved by the state board of education.

16 3. "Online school" means a school that provides at least four
17 online academic courses or one or more online courses for the equivalent
18 of at least five hours each day for one hundred eighty school days and
19 that is a charter school that is sponsored by a state-approved charter
20 authorizer or a district public school that is selected by the state board
21 of education to participate in Arizona online instruction.

22 4. "Part-time student" means:

23 (a) Any student who is enrolled in a program that does not meet the
24 definition in paragraph 1 of this subsection shall be funded at
25 eighty-five percent of the base support level that would be calculated for
26 that pupil if that pupil were enrolled as a part-time student in a school
27 district or charter school that does not participate in Arizona online
28 instruction.

29 (b) A part-time student of seventy-five percent average daily
30 membership shall be enrolled in at least three subjects throughout the
31 year that offer for first, second and third grade students at least five
32 hundred thirty-four instructional hours in a school year and for fourth,
33 fifth and sixth grade students at least six hundred sixty-eight
34 instructional hours in a school year. A part-time student of fifty
35 percent average daily membership shall be enrolled in at least two
36 subjects throughout the year that offer for first, second and third grade
37 students at least three hundred fifty-six instructional hours in a school
38 year and for fourth, fifth and sixth grade students at least four hundred
39 forty-five instructional hours in a school year. A part-time student of
40 twenty-five percent average daily membership shall be enrolled in at least
41 one subject throughout the year that offers for first, second and third
42 grade students at least one hundred seventy-eight instructional hours in a
43 school year and for fourth, fifth and sixth grade students at least two
44 hundred twenty-three instructional hours in a school year.

1 (c) For seventh and eighth grade students, a part-time student of
2 seventy-five percent average daily membership shall be enrolled in at
3 least three subjects throughout the year that offer at least eight hundred
4 one instructional hours in a school year. A part-time student of fifty
5 percent average daily membership shall be enrolled in at least two
6 subjects throughout the year that offer at least five hundred thirty-four
7 instructional hours in a school year. A part-time student of twenty-five
8 percent average daily membership shall be enrolled in at least one subject
9 throughout the year that offers at least two hundred sixty-seven
10 instructional hours in a school year.

11 (d) For high school students, a part-time student of seventy-five
12 percent average daily membership shall be enrolled in at least three
13 subjects throughout the year that offer at least six hundred seventy-five
14 instructional hours in a school year. A part-time student of fifty
15 percent average daily membership shall be enrolled in at least two
16 subjects throughout the year that offer at least four hundred fifty
17 instructional hours in a school year. A part-time student of twenty-five
18 percent average daily membership shall be enrolled in at least one subject
19 throughout the year that offers at least two hundred twenty-five
20 instructional hours in a school year.

21 5. "State-approved charter authorizer" means any charter school
