SENATE BILL 1092

AN ACT

AMENDING TITLE 1, CHAPTER 8, ARTICLE 1, ARIZONA REVISED STATUTES, BY
ADDING SECTIONS 1-802, 1-803 AND 1-804, ARIZONA REVISED STATUTES; RELATING
TO GOVERNMENTAL OPERATIONS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 1, chapter 8, article 1, Arizona Revised Statutes,
3 is amended by adding sections 1-802, 1-803 and 1-804, to read:

4 1-802. Planning; vehicle miles of travel reduction goals
5 prohibited; exception

6 A. THIS STATE OR A CITY, TOWN, COUNTY OR POLITICAL SUBDIVISION OF
7 THIS STATE MAY NOT CONSIDER OR ESTABLISH ANY VEHICLE MILES OF TRAVEL
8 REDUCTION GOALS OR TARGETS IN DEVELOPING ANY TRANSPORTATION OR LAND USE
9 PLANNING OR SELECTING TRANSPORTATION OR TRANSIT PROJECTS.

10 B. THIS SECTION DOES NOT APPLY TO EITHER OF THE FOLLOWING:

11 1. AN INTERSTATE AGREEMENT THAT IS ESTABLISHED TO ADMINISTER THE
12 PAYMENT OR REPORTING OF FUEL TAXES OR REGISTRATION FEES FOR COMMERCIAL
13 VEHICLES THAT OPERATE IN MORE THAN ONE STATE.

14 2. A MOTOR VEHICLE OWNED AND OPERATED BY ANY ENTITY LISTED IN
15 SUBSECTION A OF THIS SECTION.

16 1-803. Vehicle miles of travel; tracking prohibited;
17 exception

18 A. THIS STATE OR A CITY, TOWN, COUNTY OR POLITICAL SUBDIVISION OF
19 THIS STATE MAY NOT TRACK OR MAINTAIN A RECORD OF A PERSON'S VEHICLE MILES
20 OF TRAVEL BY RECORDING THE ODOMETER READING ON THE PERSON'S MOTOR VEHICLE,
21 THROUGH THE USE OF TRAFFIC OR OTHER CAMERAS THAT TRACK A PERSON'S MOVEMENT
22 BY CAPTURING THE PERSON'S LICENSE PLATE OR USING THIRD-PARTY DATA OR BY
23 ANY OTHER MEANS THAT WOULD ALLOW THIS STATE OR THE CITY, TOWN, COUNTY OR
24 POLITICAL SUBDIVISION OF THIS STATE TO KNOW HOW MANY VEHICLE MILES A
25 PERSON HAS TRAVELED.

26 B. THIS SECTION DOES NOT APPLY TO EITHER OF THE FOLLOWING:

27 1. AN INTERSTATE AGREEMENT THAT IS ESTABLISHED TO ADMINISTER THE
28 PAYMENT OR REPORTING OF FUEL TAXES OR REGISTRATION FEES FOR COMMERCIAL
29 VEHICLES THAT OPERATE IN MORE THAN ONE STATE.

30 2. A MOTOR VEHICLE OWNED AND OPERATED BY ANY ENTITY LISTED IN
31 SUBSECTION A OF THIS SECTION.

32 1-804. Vehicle miles of travel; tax prohibited; exception

33 A. THIS STATE OR A CITY, TOWN, COUNTY OR POLITICAL SUBDIVISION OF
34 THIS STATE MAY NOT IMPOSE OR COLLECT ANY MILEAGE FEE OR TAX, A PER-MILE
35 CHARGE, FEE OR TAX OR ANY TAX OR FEE BASED ON VEHICLE MILES TRAVELED BY AN
36 INDIVIDUAL IN A MOTOR VEHICLE.

37 B. THIS SECTION DOES NOT APPLY TO EITHER OF THE FOLLOWING:

38 1. AN INTERSTATE AGREEMENT THAT IS ESTABLISHED TO ADMINISTER THE
39 PAYMENT OR REPORTING OF FUEL TAXES OR REGISTRATION FEES FOR COMMERCIAL
40 VEHICLES THAT OPERATE IN MORE THAN ONE STATE.
