AN ACT

AMENDING TITLE 11, CHAPTER 7, ARTICLE 8, ARIZONA REVISED STATUTES, BY
ADDING SECTION 11-1052; RELATING TO THE ENFORCEMENT OF IMMIGRATION LAWS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 11, chapter 7, article 8, Arizona Revised
3 Statutes, is amended by adding section 11-1052, to read:

4 11-1052. County detention facilities; arrestee identifying
5 information; federal immigration and customs
6 authorities; applicability; definition

7 A. ON A DAILY BASIS OR ON REQUEST OF THE UNITED STATES IMMIGRATION
8 AND CUSTOMS ENFORCEMENT, A COUNTY DETENTION FACILITY SHALL TRANSMIT THE
9 NAME, ADDRESS, DATE OF BIRTH, GENDER AND SOCIAL SECURITY NUMBER OF A
10 PERSON ARRESTED FOR ANY OF THE FOLLOWING OFFENSES:

- 11 1. BURGLARY PURSUANT TO TITLE 13, CHAPTER 15.
- 12 2. THEFT PURSUANT TO SECTION 13-1802.
- 13 3. LARCENY.
- 14 3. SHOPLIFTING PURSUANT TO SECTION 13-1805.
- 15 4. ASSAULT ON A LAW ENFORCEMENT OFFICER PURSUANT TO SECTION
16 13-1204.
- 17 5. ANY OTHER OFFENSE THAT RESULTS IN DEATH OR SERIOUS BODILY INJURY
18 TO ANOTHER PERSON.

19 B. ON REQUEST OF THE UNITED STATES IMMIGRATION AND CUSTOMS
20 ENFORCEMENT, A COUNTY DETENTION FACILITY SHALL PROVIDE THE UNITED STATES
21 IMMIGRATION AND CUSTOMS ENFORCEMENT WITH A PHOTOGRAPH AND ANY OTHER
22 PHYSICAL DESCRIPTORS OF A PERSON ARRESTED FOR ANY OF THE OFFENSES
23 DESCRIBED IN SUBSECTION A OF THIS SECTION. ON REQUEST OF THE UNITED
24 STATES IMMIGRATION AND CUSTOMS ENFORCEMENT, A COUNTY DETENTION FACILITY
25 SHALL PROVIDE THE UNITED STATES IMMIGRATION AND CUSTOMS ENFORCEMENT ACCESS
26 TO THE PERSON FOR AN INTERVIEW.

27 C. A COUNTY DETENTION FACILITY SHALL COMPLY WITH AND HONOR ANY
28 REQUESTS MADE BY THE UNITED STATES IMMIGRATION AND CUSTOMS ENFORCEMENT.

29 D. THIS SECTION DOES NOT APPLY TO A COUNTY DETENTION FACILITY WHERE
30 A UNITED STATES IMMIGRATION AND CUSTOMS ENFORCEMENT AGENT IS STATIONED OR
31 IF THE COUNTY DETENTION FACILITY HAS AN EMPLOYEE WHO IS APPROVED BY THE
32 UNITED STATES IMMIGRATION AND CUSTOMS ENFORCEMENT TO CONDUCT IMMIGRATION
33 AND CUSTOMS SCREENING OF PERSONS WHO HAVE BEEN DETAINED.

34 E. FOR THE PURPOSES OF THIS SECTION, "COUNTY DETENTION FACILITY"
35 MEANS ANY PLACE USED BY A COUNTY SHERIFF'S OFFICE FOR THE CONFINEMENT OR
36 CONTROL OF A PERSON FOR THE OFFENSES PRESCRIBED IN SUBSECTION A OF THIS
37 SECTION.
