SENATE BILL 1727

AN ACT

AMENDING SECTION 15-1751, ARIZONA REVISED STATUTES; RELATING TO MEDICAL PROGRAMS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 15-1751, Arizona Revised Statutes, is amended to
3 read:

4 15-1751. Medical schools; applicants; admissions information;
5 posting; priority consideration; annual report

6 A. IF A UNIVERSITY UNDER THE JURISDICTION OF THE ARIZONA BOARD OF
7 REGENTS HAS A MEDICAL SCHOOL, THE MEDICAL SCHOOL, CONSISTENT WITH ANY
8 STANDARDS SET BY THE NATIONAL ACCREDITING ORGANIZATION FOR THE MEDICAL
9 SCHOOL, SHALL DO ALL OF THE FOLLOWING:

10 1. POST ADMISSIONS INFORMATION ON THE MEDICAL SCHOOL'S WEBSITE AND
11 INCLUDE THE ADMISSIONS INFORMATION IN ANY PROMOTIONAL MATERIALS THAT ARE
12 DISTRIBUTED TO PROSPECTIVE STUDENTS. THE ADMISSIONS INFORMATION REQUIRED
13 PURSUANT TO THIS PARAGRAPH SHALL INCLUDE ALL OF THE FOLLOWING:

14 (a) MINIMUM QUALIFICATIONS AND REQUIREMENTS FOR ADMISSION TO THE
15 MEDICAL SCHOOL.

16 (b) THE AMOUNT OF ALL APPLICATION FEES.

17 (c) DEADLINE DATES AND PROCEDURES FOR PROSPECTIVE STUDENTS TO APPLY
18 FOR ADMISSION TO THE MEDICAL SCHOOL.

19 (d) IF APPLICABLE, THE DATES ON WHICH THE MEDICAL SCHOOL WILL
20 INTERVIEW APPLICANTS FOR ADMISSION TO THE MEDICAL SCHOOL.

21 2. OFFER AN INTERVIEW TO EACH APPLICANT FROM THIS STATE WHO DOES
22 ALL OF THE FOLLOWING:

23 (a) SUBMITS A TIMELY APPLICATION PURSUANT TO THE MEDICAL SCHOOL'S
24 DEADLINES AND PROCEDURES FOR STUDENT ADMISSIONS.

25 (b) MEETS OR EXCEEDS THE QUALIFICATIONS AND REQUIREMENTS FOR
26 ADMISSION TO THE MEDICAL SCHOOL.

27 (c) PAYS ALL APPLICATION FEES.

28 3. IF APPLICABLE, GIVE PRIORITY CONSIDERATION IN THE FIRST ROUND OF
29 ADMISSIONS INTERVIEWS TO ANY APPLICANT WHO IS FROM THIS STATE AND WHO
30 MEETS THE ADMISSIONS QUALIFICATIONS AND REQUIREMENTS THAT ARE PRESCRIBED
31 BY THE MEDICAL SCHOOL.

32 4. ON OR BEFORE OCTOBER 1, REPORT TO THE ARIZONA BOARD OF REGENTS
33 ALL OF THE FOLLOWING FOR THE PRIOR SCHOOL YEAR:

34 (a) THE NUMBER OF APPLICANTS FROM THIS STATE WHO:

35 (i) SUBMITTED A TIMELY APPLICATION FOR ADMISSION TO THE MEDICAL
36 SCHOOL.

37 (ii) WERE INTERVIEWED BY THE MEDICAL SCHOOL PURSUANT TO PARAGRAPH 2
38 OF THIS SUBSECTION.

39 (iii) WERE ADMITTED TO THE MEDICAL SCHOOL.

40 (b) A DESCRIPTION OF PROCEDURES THAT THE MEDICAL SCHOOL IMPLEMENTED
41 AND ACTIONS THAT THE MEDICAL SCHOOL UNDERTOOK TO COMPLY WITH THE
42 REQUIREMENTS PRESCRIBED BY THIS SUBSECTION.

43 (c) ANY OTHER INFORMATION REQUESTED BY THE ARIZONA BOARD OF REGENTS
44 FOR THE PURPOSES OF THIS SECTION.

1 B. The university of Arizona school of medicine shall give priority
2 consideration to applicants who demonstrate a willingness to practice in
3 medically underserved areas of this state.

4 C. FOR THE PURPOSES OF THIS SECTION, AN APPLICANT IS DEEMED TO BE
5 FROM THIS STATE IF THE APPLICANT EITHER:

6 1. IS CLASSIFIED AS AN IN-STATE STUDENT PURSUANT TO SECTION
7 15-1802.

8 2. GRADUATED FROM A HIGH SCHOOL IN THIS STATE.

10 Section 15-1751, Arizona Revised Statutes, as amended by this act,
11 is effective from and after December 31, 2026.
