13 B. BEFORE THE EXECUTIVE BRANCH MAY SPEND ANY OF THE MONIES IN
14 THE ARIZONA RURAL HEALTH TRANSFORMATION FUND, THE ARIZONA HEALTH
15 CARE COST CONTAINMENT SYSTEM SHALL HOLD THREE PUBLIC MEETINGS IN
16 EACH OF THE LARGEST METROPOLITAN AREAS IN NORTHERN, CENTRAL AND
17 SOUTHERN ARIZONA TO RECEIVE INPUT AND FEEDBACK REGARDING HOW THE
18 MONIES SHOULD BE SPENT. AFTER THE THREE MEETINGS HAVE BEEN HELD,
19 THE ARIZONA HEALTH CARE COST CONTAINMENT SYSTEM SHALL SUBMIT AN
20 EXPENDITURE PLAN FOR THE MONIES RECEIVED THROUGH THE RURAL HEALTH
21 TRANSFORMATION PROGRAM PRESCRIBED IN SECTION 71401 OF PUBLIC LAW
22 119-21 TO THE JOINT LEGISLATIVE BUDGET COMMITTEE FOR APPROVAL."
