AN ACT

AMENDING TITLE 15, CHAPTER 1, ARTICLE 1, ARIZONA REVISED STATUTES, BY
ADDING SECTION 15-115.02; RELATING TO PUBLIC SCHOOLS.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Title 15, chapter 1, article 1, Arizona Revised
3 Statutes, is amended by adding section 15-115.02, to read:
4 15-115.02. Health education instruction; prohibitions;
5 withholding of state monies; definition
6 A. A PUBLIC SCHOOL MAY NOT ALLOW AN ABORTION PROVIDER OR A MEDICAL
7 FACILITY OR ORGANIZATION THAT REFERS PATIENTS TO AN ABORTION CLINIC AS
8 DEFINED IN SECTION 36-449.01 TO:
9 1. PROVIDE HEALTH EDUCATION INSTRUCTION IN THE SCHOOL.
10 2. PROVIDE HEALTH EDUCATION INSTRUCTIONAL PROGRAMS OR CURRICULA TO
11 THE SCHOOL OR SCHOOL EMPLOYEES.
12 3. DISTRIBUTE OR DISPLAY ANY HEALTH EDUCATION MATERIALS OR MEDIA IN
13 THE SCHOOL IF THE MATERIALS OR MEDIA ARE CREATED, PAID FOR OR DONATED BY
14 THE ABORTION PROVIDER OR BEAR AN IDENTIFYING MARK OF THE ABORTION
15 PROVIDER.
16 B. IF THE DEPARTMENT OF EDUCATION DETERMINES THAT A PUBLIC SCHOOL
17 IS NOT IN COMPLIANCE WITH SUBSECTION A OF THIS SECTION AND IF THE PUBLIC
18 SCHOOL FAILS TO CORRECT THE DEFICIENCY WITHIN NINETY DAYS AFTER RECEIVING
19 NOTICE FROM THE DEPARTMENT OF EDUCATION, THE SUPERINTENDENT OF PUBLIC
20 INSTRUCTION MAY WITHHOLD ANY PORTION OF THE PUBLIC SCHOOL'S APPORTIONMENT
21 OF STATE AID FROM THE DATE OF THE DETERMINATION OF NONCOMPLIANCE UNTIL THE
22 DEPARTMENT OF EDUCATION DETERMINES THAT THE PUBLIC SCHOOL IS COMPLYING
23 WITH SUBSECTION A OF THIS SECTION.
24 C. FOR THE PURPOSES OF THIS SECTION, "ABORTION PROVIDER" INCLUDES
25 ANY:
26 1. AN ABORTION CLINIC AS DEFINED IN SECTION 36-449.01.
27 2. ENTITY THAT CONTROLS, IS CONTROLLED BY OR IS UNDER COMMON
28 CONTROL WITH AN ABORTION CLINIC AS DEFINED IN SECTION 36-449.01.
29 3. ENTITY THAT IS A PARTY TO A FRANCHISING, LICENSING OR SIMILAR
30 AGREEMENT WITH AN ABORTION CLINIC AS DEFINED IN SECTION 36-449.01.
31 4. INDIVIDUAL WHO IS ACTING AS AN EMPLOYEE OR REPRESENTATIVE OF AN
32 ENTITY DESCRIBED IN PARAGRAPH 1, 2 OR 3 OF THIS SUBSECTION.
