AN ACT

AMENDING TITLE 41, CHAPTER 23, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-2505; AMENDING SECTION 41-2550, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 24, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-2707; RELATING TO THE DEPARTMENT OF ADMINISTRATION.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 41, chapter 23, article 1, Arizona Revised
3 Statutes, is amended by adding section 41-2505, to read:

4 41-2505. State contracts; request for proposals; governor;
5 donations; disclosure

6 NOTWITHSTANDING ANY OTHER LAW, A COMPANY THAT CURRENTLY HAS A STATE
7 CONTRACT WITH ANY STATE AGENCY OR THAT RESPONDS TO A REQUEST FOR PROPOSALS
8 SHALL DISCLOSE ANYTHING OF VALUE THAT THE COMPANY, ITS OFFICERS OR
9 DIRECTORS OR ANY OF THEIR FAMILY MEMBERS HAVE PROVIDED, DIRECTLY OR
10 INDIRECTLY, DURING THE PRECEDING FIVE YEARS TO ANY OF THE FOLLOWING:

11 1. THE GOVERNOR.

12 2. ANY ENTITY THAT IS ESTABLISHED, FINANCED, MAINTAINED OR
13 CONTROLLED BY THE GOVERNOR OR AN AGENT OF THE GOVERNOR, INCLUDING A
14 CAMPAIGN COMMITTEE, A JOINT FUNDRAISING COMMITTEE OR AN INAUGURAL FUND.

15 3. AN ENTITY THAT ADVOCATES FOR THE ELECTION OF THE GOVERNOR OR FOR
16 THE DEFEAT OF AN ELECTORAL OPPONENT OF THE GOVERNOR, INCLUDING A POLITICAL
17 COMMITTEE OR OTHER NONPROFIT ORGANIZATION THAT MAKES ANY INDEPENDENT
18 EXPENDITURES.

19 Sec. 2. Section 41-2550, Arizona Revised Statutes, is amended to
20 read:

21 41-2550. Retention of procurement records; resolicitation of
22 contracts

23 A. All procurement records shall be retained and disposed of in
24 accordance with records retention guidelines and schedules approved by the
25 Arizona state library, archives and public records.

26 B. A STATE AGENCY OR STATE EMPLOYEE MAY NOT DESTROY ANY NOTES TAKEN
27 DURING THE EVALUATION OF A COMPANY THAT RESPONDS TO A REQUEST FOR
28 PROPOSALS. IF A STATE AGENCY OR STATE EMPLOYEE DESTROYS ANY NOTES
29 PURSUANT TO THIS SUBSECTION, ALL CONTRACTS THAT WERE RELATED TO THE
30 DESTROYED NOTES AND THAT WERE AGREED TO FROM AND AFTER THE EFFECTIVE DATE
31 OF THIS AMENDMENT TO THIS SECTION MAY BE RESOLICITED.

32 Sec. 3. Title 41, chapter 24, article 1, Arizona Revised Statutes,
33 is amended by adding section 41-2707, to read:

34 41-2707. Grants; governor; donations; disclosure

35 NOTWITHSTANDING ANY OTHER LAW, A COMPANY THAT APPLIES FOR A GRANT
36 SHALL DISCLOSE ANYTHING OF VALUE THAT THE COMPANY, ITS OFFICERS OR
37 DIRECTORS OR ANY OF THEIR FAMILY MEMBERS HAVE PROVIDED, DIRECTLY OR
38 INDIRECTLY, DURING THE PRECEDING FIVE YEARS TO ANY OF THE FOLLOWING:

39 1. THE GOVERNOR.

40 2. ANY ENTITY THAT IS ESTABLISHED, FINANCED, MAINTAINED OR
41 CONTROLLED BY THE GOVERNOR OR AN AGENT OF THE GOVERNOR, INCLUDING A
42 CAMPAIGN COMMITTEE, A JOINT FUNDRAISING COMMITTEE OR AN INAUGURAL FUND.

43 3. AN ENTITY THAT ADVOCATES FOR THE ELECTION OF THE GOVERNOR OR FOR
44 THE DEFEAT OF AN ELECTORAL OPPONENT OF THE GOVERNOR, INCLUDING A POLITICAL
45 COMMITTEE OR OTHER NONPROFIT ORGANIZATION THAT MAKES ANY INDEPENDENT
46 EXPENDITURES.
