SENATE CONCURRENT RESOLUTION 1005

A CONCURRENT RESOLUTION

ENACTING AND ORDERING THE SUBMISSION TO THE PEOPLE OF A MEASURE RELATING
TO CAMPAIGN CONTRIBUTIONS.

1 Be it resolved by the Senate of the State of Arizona, the House of
2 Representatives concurring:

3 1. Under the power of the referendum, as vested in the Legislature,
4 the following measure, relating to campaign contributions, is enacted to
5 become valid as a law if approved by the voters and on proclamation of the
6 Governor:

7 AN ACT

8 AMENDING TITLE 16, CHAPTER 6, ARTICLE 1.2, ARIZONA REVISED
9 STATUTES, BY ADDING SECTION 16-919; RELATING TO CAMPAIGN
10 CONTRIBUTIONS.

11 Be it enacted by the Legislature of the State of Arizona:

12 Section 1. Title 16, chapter 6, article 1.2, Arizona
13 Revised Statutes, is amended by adding section 16-919, to
14 read:

15 16-919. Foreign contributions prohibited; ballot
16 measures; certification; definition

17 A. A FOREIGN NATIONAL SHALL NOT GIVE AND A PERSON,
18 ENTITY OR COMMITTEE SHALL NOT ACCEPT OR USE MONIES OR IN-KIND
19 GOODS OR SERVICES THAT ARE CONTRIBUTED BY A FOREIGN NATIONAL
20 TO INFLUENCE THE OUTCOME OF AN ELECTION ON A BALLOT MEASURE,
21 QUESTION, ISSUE OR PROPOSITION, INCLUDING AN INITIATIVE OR
22 REFERENDUM.

23 B. A PERSON, ENTITY OR COMMITTEE THAT IS REQUIRED TO
24 FILE CAMPAIGN FINANCE REPORTS PURSUANT TO SECTION 16-926 SHALL
25 CERTIFY UNDER PENALTY OF PERJURY IN THOSE REPORTS THAT THE
26 PERSON, ENTITY OR COMMITTEE HAS NOT ACCEPTED OR USED MONIES OR
27 IN-KIND GOODS OR SERVICES IN VIOLATION OF SUBSECTION A OF THIS
28 SECTION.

29 C. FEDERALLY RECOGNIZED SOVEREIGN TRIBAL NATIONS ARE
30 EXEMPT FROM THIS SECTION.

31 D. FOR THE PURPOSES OF THIS SECTION, "FOREIGN NATIONAL"
32 MEANS:

33 1. AN INDIVIDUAL WHO IS NOT A CITIZEN OR NATIONAL OF
34 THE UNITED STATES OR WHO IS NOT LAWFULLY ADMITTED FOR
35 PERMANENT RESIDENCE IN THE UNITED STATES.

36 2. A FOREIGN GOVERNMENT OR FOREIGN POLITICAL PARTY.

37 3. A PARTNERSHIP, ASSOCIATION, CORPORATION,
38 ORGANIZATION OR OTHER COMBINATION OF PERSONS THAT IS ORGANIZED
39 UNDER THE LAWS OF OR HAVING ITS PRINCIPAL PLACE OF BUSINESS IN
40 A COUNTRY OTHER THAN THE UNITED STATES.

41 2. The Secretary of State shall submit this proposition to the
42 voters at the next general election as provided by article IV, part 1,
43 section 1, Constitution of Arizona.
