7 THAT ISSUES, AMENDS OR RENEWS A SUBSCRIPTION CONTRACT ON OR AFTER THE
8 EFFECTIVE DATE OF THIS SECTION MAY NOT IMPOSE A REIMBURSEMENT RATE FOR A
9 CERTIFIED REGISTERED NURSE ANESTHETIST WHO IS AUTHORIZED TO PERFORM

10 IMPOSE A REIMBURSEMENT RATE FOR A CERTIFIED REGISTERED NURSE ANESTHETIST
11 WHO IS AUTHORIZED TO PERFORM SERVICES PURSUANT TO SECTION 32-1634.04 THAT
12 DIFFERS FROM THE REIMBURSEMENT RATE FOR A PHYSICIAN WHO IS LICENSED
13 PURSUANT TO TITLE 32, CHAPTER 13 OR 17.

14 B. THIS SECTION DOES NOT PREVENT A GROUP OR BLANKET DISABILITY
15 INSURER FROM ESTABLISHING VARIABLE REIMBURSEMENT RATES THAT ARE BASED ON
16 QUALITY OR PERFORMANCE-BASED MEASURES."
