HOUSE BILL 2060

AN ACT

AMENDING SECTION 15-115.01, ARIZONA REVISED STATUTES; AMENDING TITLE 15, CHAPTER 1, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 15-115.02; AMENDING SECTION 15-1630, ARIZONA REVISED STATUTES; RELATING TO EDUCATIONAL INSTITUTIONS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 15-115.01, Arizona Revised Statutes, is amended
3 to read:

4 15-115.01. Public educational institution facilities;
5 employees; prohibition; exception; definitions

6 A. A facility that is run by or that operates on the property of a
7 public educational institution may not perform or provide an abortion,
8 unless the abortion is necessary to save the life of the woman having the
9 abortion.

10 B. A PUBLIC EDUCATIONAL INSTITUTION MAY NOT ENCOURAGE OR FACILITATE
11 ABORTIONS. AN EMPLOYEE OF A PUBLIC EDUCATIONAL INSTITUTION WHO IS ACTING
12 IN THE EMPLOYEE'S OFFICIAL CAPACITY MAY NOT ENCOURAGE OR FACILITATE
13 ABORTIONS.

15 1. "Abortion" has the same meaning prescribed in section 36-2151.

16 ~~2. "Medical emergency" has the same meaning prescribed in section~~

19 (a) A community college as defined in section 15-1401.

20 (b) A university under the jurisdiction of the Arizona board of
21 regents.

22 (c) A school district, including its schools.

23 (d) A charter school.

24 (e) An accommodation school.

25 (f) The Arizona state schools for the deaf and the blind.

26 Sec. 2. Title 15, chapter 1, article 1, Arizona Revised Statutes,
27 is amended by adding section 15-115.02, to read:

28 15-115.02. Health education instruction; prohibitions;
29 withholding of state monies; definitions

30 A. A PUBLIC SCHOOL MAY NOT ALLOW AN ABORTION PROVIDER OR A MEDICAL
31 FACILITY OR ORGANIZATION THAT REFERS PATIENTS TO AN ABORTION CLINIC TO DO
32 ANY OF THE FOLLOWING:

33 1. PROVIDE HEALTH EDUCATION INSTRUCTION IN THE SCHOOL.

34 2. PROVIDE HEALTH EDUCATION INSTRUCTIONAL PROGRAMS OR CURRICULA TO
35 THE SCHOOL OR SCHOOL EMPLOYEES.

36 3. DISTRIBUTE OR DISPLAY ANY HEALTH EDUCATION MATERIALS OR MEDIA IN
37 THE SCHOOL IF THE MATERIALS OR MEDIA ARE CREATED, PAID FOR OR DONATED BY
38 THE ABORTION PROVIDER OR BEAR AN IDENTIFYING MARK OF THE ABORTION
39 PROVIDER.

40 B. IF THE DEPARTMENT OF EDUCATION DETERMINES THAT A PUBLIC SCHOOL
41 IS NOT IN COMPLIANCE WITH SUBSECTION A OF THIS SECTION AND IF THE PUBLIC
42 SCHOOL FAILS TO CORRECT THE NONCOMPLIANCE WITHIN NINETY DAYS AFTER
43 RECEIVING NOTICE FROM THE DEPARTMENT OF EDUCATION, THE SUPERINTENDENT OF
44 PUBLIC INSTRUCTION MAY WITHHOLD ANY PORTION OF THE PUBLIC SCHOOL'S
45 APPORTIONMENT OF STATE AID FROM THE DATE OF THE DETERMINATION OF

1 NONCOMPLIANCE UNTIL THE DEPARTMENT OF EDUCATION DETERMINES THAT THE PUBLIC
2 SCHOOL IS COMPLYING WITH SUBSECTION A OF THIS SECTION.

3 C. FOR THE PURPOSES OF THIS SECTION:

4 1. "ABORTION CLINIC" HAS THE SAME MEANING PRESCRIBED IN SECTION
5 36-449.01.

6 2. "ABORTION PROVIDER" INCLUDES:

7 (a) AN ABORTION CLINIC.

8 (b) ANY ENTITY THAT CONTROLS, IS CONTROLLED BY OR IS UNDER COMMON
9 CONTROL WITH AN ABORTION CLINIC.

10 (c) ANY ENTITY THAT IS A PARTY TO A FRANCHISING, LICENSING OR
11 SIMILAR AGREEMENT WITH AN ABORTION CLINIC.

12 (d) ANY INDIVIDUAL WHO IS ACTING AS AN EMPLOYEE OR REPRESENTATIVE
13 OF AN ENTITY DESCRIBED IN SUBDIVISION (a), (b) OR (c) OF THIS PARAGRAPH.

14 Sec. 3. Section 15-1630, Arizona Revised Statutes, is amended to
15 read:

16 15-1630. Educational facilities; employees; prohibition;
17 exception

18 A. ~~NO~~ AN abortion shall NOT be performed at any facility under the
19 jurisdiction of the Arizona board of regents unless ~~such~~ THE abortion is
20 necessary to save the life of the woman having the abortion.

21 B. A UNIVERSITY UNDER THE JURISDICTION OF THE ARIZONA BOARD OF
22 REGENTS MAY NOT ENCOURAGE OR FACILITATE ABORTIONS. AN EMPLOYEE OF THE
23 ARIZONA BOARD OF REGENTS OR OF A UNIVERSITY UNDER THE JURISDICTION OF THE
24 ARIZONA BOARD OF REGENTS WHO IS ACTING IN THE EMPLOYEE'S OFFICIAL CAPACITY
25 MAY NOT ENCOURAGE OR FACILITATE ABORTIONS.
