AN ACT

AMENDING SECTION 36-2160, ARIZONA REVISED STATUTES; RELATING TO ABORTION.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Section 36-2160, Arizona Revised Statutes, is amended to
3 read:
4 36-2160. Abortion-inducing drugs; violations;
5 classifications; definition
6 A. An abortion-inducing drug may be provided only by a qualified
7 physician in accordance with the requirements of this chapter.
8 B. A manufacturer, supplier or physician or any other person is
9 prohibited from providing an abortion-inducing drug via courier, delivery
10 or mail service.
11 C. This section does not apply to drugs that may be known to cause
12 an abortion but that are prescribed for other medical indications.
13 D. A PERSON WHO KNOWINGLY VIOLATES SUBSECTION B OF THIS SECTION BY
14 SELLING, FURNISHING, MAILING, SHIPPING, DELIVERING OR CAUSING TO BE
15 MAILED, SHIPPED OR DELIVERED AN ABORTION-INDUCING DRUG IS GUILTY OF A
16 CLASS 5 FELONY.
17 E. A LICENSED HEALTH CARE PROVIDER, PHARMACIST, MANUFACTURER,
18 SUPPLIER OR CARRIER WHO VIOLATES SUBSECTION B OF THIS SECTION WHILE ACTING
19 IN THE COURSE AND SCOPE OF THE PERSON'S EMPLOYMENT IS GUILTY OF A CLASS 4
20 FELONY.
21 F. A PERSON WHO KNOWINGLY ORDERS, SOLICITS, REQUESTS, RECEIVES OR
22 ATTEMPTS TO RECEIVE AN ABORTION-INDUCING DRUG BY COURIER, DELIVERY OR MAIL
23 SERVICE IN VIOLATION OF SUBSECTION B OF THIS SECTION IS GUILTY OF A CLASS
24 1 MISDEMEANOR.
25 G. NOTWITHSTANDING ANY OTHER LAW, A CIVIL ACTION MAY NOT BE BROUGHT
26 UNDER THIS SECTION AGAINST A MOTOR CARRIER OR FREIGHT FORWARDER AS DEFINED
27 IN 49 UNITED STATES CODE SECTION 13102, AN AIR CARRIER AS DEFINED IN 49
28 UNITED STATES CODE SECTION 40102 OR A THIRD-PARTY LOGISTICS PROVIDER AS
29 DEFINED BY 21 UNITED STATES CODES SECTION 360eee.
30 ~~D.~~ H. For the purposes of this section, "abortion-inducing drug"
31 means a medicine or drug or any other substance used for a medication
32 abortion.
