AN ACT

AMENDING TITLE 23, CHAPTER 2, ARIZONA REVISED STATUTES, BY ADDING ARTICLE
6.2; RELATING TO EMPLOYMENT.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 23, chapter 2, Arizona Revised Statutes, is
3 amended by adding article 6.2, to read:

4 ARTICLE 6.2. EMPLOYMENT CONTRACTS FOR MINORS

5 23-345. Definitions

6 IN THIS ARTICLE, UNLESS THE CONTEXT OTHERWISE REQUIRES:

7 1. "ARTISTIC OR CREATIVE SERVICES":

8 (a) INCLUDES SERVICES:

9 (i) AS AN ACTOR, ACTRESS, DANCER, MUSICIAN, COMEDIAN, SINGER, STUNT
10 PERSON, VOICE-OVER ARTIST OR OTHER PERFORMER OR ENTERTAINER.

11 (ii) AS A SONGWRITER, MUSICAL PRODUCER OR ARRANGER, WRITER,
12 DIRECTOR, PRODUCER, PRODUCTION EXECUTIVE, CHOREOGRAPHER, COMPOSER,
13 CONDUCTOR OR DESIGNER.

14 (iii) PROVIDED ON AN ONLINE PLATFORM. FOR THE PURPOSES OF THIS
15 ITEM, "ONLINE PLATFORM" MEANS ANY PUBLIC FACING INTERNET WEBSITE, WEB
16 APPLICATION OR DIGITAL APPLICATION, INCLUDING SOCIAL MEDIA PLATFORMS,
17 ADVERTISING NETWORKS, MOBILE APPLICATIONS, MOBILE OPERATING SYSTEMS,
18 SEARCH ENGINES, EMAIL SERVICES AND INTERNET ACCESS SERVICES.

19 (b) DOES NOT INCLUDE SERVICES AS AN EXTRA, A BACKGROUND PERFORMER
20 OR TEMPORARY WORK IN A SIMILAR CAPACITY.

21 2. "FINANCIAL INSTITUTION":

22 (a) MEANS A FINANCIAL ENTITY THAT IS INSURED BY THE FEDERAL DEPOSIT
23 INSURANCE CORPORATION.

24 (b) INCLUDES:

25 (i) A STATE BANK.

26 (ii) A FEDERAL BANK.

27 (iii) A CREDIT UNION.

28 (iv) A SAVINGS AND LOAN ASSOCIATION.

29 (v) A TRUST COMPANY.

30 (vi) A SAVINGS BANK.

31 3. "GROSS EARNINGS" MEANS THE TOTAL COMPENSATION PAYABLE TO THE
32 MINOR UNDER THE CONTRACT OR, IF THE MINOR'S SERVICES ARE BEING PROVIDED
33 THROUGH A THIRD PARTY, THE TOTAL COMPENSATION PAYABLE TO THAT THIRD PARTY
34 FOR THE SERVICES OF THE MINOR.

35 4. "GUARDIAN":

36 (a) MEANS AN INDIVIDUAL WHO IS APPOINTED OR QUALIFIED BY A COURT AS
37 A GUARDIAN OF THE MINOR.

38 (b) INCLUDES A LIMITED GUARDIAN.

39 (c) DOES NOT INCLUDE A GUARDIAN AD LITEM.

40 5. "GUARDIAN AD LITEM" MEANS A NEUTRAL PERSON THE COURT APPOINTS TO
41 INVESTIGATE WHAT SOLUTIONS WOULD BE IN THE BEST INTERESTS OF THE CHILD.

42 6. "PARENT" MEANS THE NATURAL OR ADOPTIVE MOTHER OR FATHER OF THE
43 CHILD UNLESS PARENTAL RIGHTS WERE TERMINATED BY COURT ORDER.

44 7. "THIRD PARTY" MEANS A THIRD-PARTY INDIVIDUAL, A BUSINESS ENTITY
45 OR A CASTING AGENCY.

1 STATEMENT. ALL DOCUMENTATION SHALL BE PROVIDED AND MAINTAINED IN
2 COMPLIANCE WITH THIS ARTICLE, EVEN IF THE SAME INDIVIDUAL SERVES IN ANY OF
3 THE FOLLOWING CAPACITIES:

- 4 1. THE TRUSTEE OF THE TRUST.
- 5 2. THE MINOR'S EMPLOYER.
- 6 3. THE MINOR'S PARENT OR GUARDIAN.

7 D. WHEN MAKING THE INITIAL DEPOSIT OF MONIES PURSUANT TO SUBSECTION
8 B, PARAGRAPH 1 OF THIS SECTION, THE MINOR'S EMPLOYER SHALL PROVIDE WRITTEN
9 NOTIFICATION TO THE FINANCIAL INSTITUTION THAT THE MONIES ARE SUBJECT TO
10 THIS ARTICLE.

11 E. ONCE THE MINOR'S EMPLOYER DEPOSITS THE MONIES INTO THE TRUST,
12 THE MINOR'S EMPLOYER SHALL HAVE NO FURTHER OBLIGATION OR DUTY TO MONITOR
13 OR ACCOUNT FOR THE MONIES. THE TRUSTEE OF THE TRUST SHALL BE THE ONLY
14 INDIVIDUAL OR ENTITY WITH THE OBLIGATION OR DUTY TO MONITOR AND ACCOUNT
15 FOR THE MONIES ONCE THE MONIES HAVE BEEN DEPOSITED BY THE MINOR'S
16 EMPLOYER. THE TRUSTEE OF THE TRUST SHALL CONDUCT AN ANNUAL ACCOUNTING OF
17 THE MONIES HELD IN TRUST IN ACCORDANCE WITH GENERALLY RECOGNIZED
18 PROFESSIONAL ACCOUNTING AND AUDITING PRINCIPLES.

19 F. AT ANY TIME, A PARENT, A GUARDIAN, THE TRUSTEE OR THE MINOR,
20 THROUGH THE MINOR'S GUARDIAN AD LITEM, ON A SHOWING OF GOOD CAUSE MAY
21 REQUEST THAT THE COURT AMEND OR TERMINATE THE TRUST, NOTWITHSTANDING ANY
22 PROVISION IN THE DECLARATION OF TRUST. THE COURT MAY ONLY AMEND OR
23 TERMINATE THE TRUST AFTER THE COURT PROVIDES THE PARTIES WITH REASONABLE
24 NOTICE AND AN OPPORTUNITY TO BE HEARD.

25 G. A PARENT OR GUARDIAN SHALL PROMPTLY NOTIFY THE MINOR'S EMPLOYER,
26 IN WRITING, OF ANY CHANGE IN FACTS THAT AFFECT THE EMPLOYER'S OBLIGATION
27 OR ABILITY TO SET ASIDE THE MONIES IN ACCORDANCE WITH THE ORDER, INCLUDING
28 A CHANGE OF FINANCIAL INSTITUTION OR ACCOUNT NUMBER OR THE EXISTENCE OF A
29 NEW OR AMENDED COURT ORDER. THE WRITTEN NOTIFICATION SHALL INCLUDE A TRUE
30 AND ACCURATE COPY OF THE TRUSTEE'S WRITTEN STATEMENT PURSUANT TO SECTION
31 23-345.03 AND A CERTIFIED COPY OF ANY NEW OR AMENDED ORDER, AS APPLICABLE.

32 H. FOR A MINOR'S CONTRACT TO PERFORM ARTISTIC OR CREATIVE SERVICES
33 THAT IS NOT SUBMITTED TO THE COURT FOR APPROVAL PURSUANT TO SECTION
34 23-345.01 OR IF THE COURT DENIED APPROVAL, ALL OF THE FOLLOWING APPLY:

35 1. THE EMPLOYER SHALL SET ASIDE AND DEPOSIT FIFTEEN PERCENT OF THE
36 MINOR'S GROSS EARNINGS PURSUANT TO THE CONTRACT IN A TRUST ACCOUNT FOR THE
37 BENEFIT OF THE MINOR.

38 2. AT LEAST ONE PARENT OR GUARDIAN SHALL SERVE AS THE TRUSTEE OF
39 THE TRUST ACCOUNT. A PARENT, GUARDIAN OR TRUSTEE OR THE MINOR THROUGH THE
40 MINOR'S GUARDIAN AD LITEM MAY PETITION A COURT OF COMPETENT JURISDICTION
41 TO APPOINT ANOTHER INDIVIDUAL OR ENTITY TO SERVE AS TRUSTEE OF THE TRUST.
42 THE COURT MAY APPOINT ANOTHER INDIVIDUAL OR ENTITY TO SERVE AS THE TRUSTEE
43 OF THE TRUST IF THE COURT BELIEVES IT IS IN THE BEST INTERESTS OF THE
44 CHILD.

1 3. THE MINOR'S EMPLOYER SHALL PROVIDE WRITTEN NOTIFICATION TO THE
2 FINANCIAL INSTITUTION THAT THE MONIES ARE SUBJECT TO THIS ARTICLE.

3 I. THE RELATIONSHIP BETWEEN THE PARENT OR GUARDIAN AND THE MINOR IS
4 A FIDUCIARY RELATIONSHIP PURSUANT TO TITLE 14, IRRESPECTIVE OF WHETHER A
5 COURT HAS ISSUED A FORMAL ORDER TO THAT EFFECT. THE PARENT OR GUARDIAN
6 SERVING IN A FIDUCIARY RELATIONSHIP SHALL PAY ALL LIABILITIES INCURRED BY
7 THE MINOR UNDER THE CONTRACT WITH THE EARNINGS OF THE MINOR, WHICH
8 INCLUDES:

- 9 1. TAXES.
- 10 2. PAYMENTS FOR PERSONAL SERVICES RENDERED TO THE MINOR.
- 11 3. PAYMENTS FOR PROFESSIONAL SERVICES RENDERED TO THE MINOR.
- 12 4. OTHER REASONABLE BUSINESS-RELATED EXPENSES.

13 J. THIS SECTION DOES NOT ALTER ANY OTHER EXISTING RESPONSIBILITY OF
14 A PARENT OR LEGAL GUARDIAN TO PROVIDE FOR THE SUPPORT OF A MINOR CHILD.

15 23-345.03. Trust account; withdrawals; trustee's written
16 statement; notification; requirements

17 A. THE TRUSTEE SHALL ESTABLISH A TRUST ACCOUNT PURSUANT TO THIS
18 SECTION AT A FINANCIAL INSTITUTION THAT IS LOCATED IN THIS STATE WITHIN
19 SEVEN BUSINESS DAYS AFTER THE MINOR'S CONTRACT IS EXECUTED.

20 B. WITHDRAWALS FROM THE TRUST ARE PROHIBITED UNLESS:

21 1. THE BENEFICIARY ATTAINS EIGHTEEN YEARS OF AGE AND SUBMITS A
22 CERTIFIED COPY OF THE MINOR'S BIRTH CERTIFICATE TO THE FINANCIAL
23 INSTITUTION WHERE THE TRUST IS LOCATED.

24 2. THE MINOR BENEFICIARY IS EMANCIPATED BY THE COURT AND SUBMITS A
25 CERTIFIED COPY OF THE COURT'S EMANCIPATION ORDER TO THE FINANCIAL
26 INSTITUTION WHERE THE TRUST IS LOCATED.

27 3. ORDERED BY THE COURT.

28 C. WITHIN TEN BUSINESS DAYS AFTER THE MINOR'S CONTRACT IS EXECUTED,
29 THE TRUSTEE SHALL PREPARE A WRITTEN STATEMENT UNDER THE PENALTY OF PERJURY
30 AND PROVIDE A COPY TO THE PARENT, GUARDIAN, GUARDIAN AD LITEM, THE MINOR'S
31 EMPLOYER AND THE COURT, AS APPLICABLE, AND THAT INCLUDES THE FOLLOWING
32 ACCOUNT INFORMATION:

- 33 1. THE NAME.
- 34 2. THE ADDRESS.
- 35 3. THE TELEPHONE NUMBER.
- 36 4. THE NAME OF THE ACCOUNT.
- 37 5. THE ACCOUNT NUMBER.
- 38 6. THE NAME OF THE MINOR BENEFICIARY.
- 39 7. THE NAME OF THE TRUSTEE OF THE ACCOUNT.

40 8. ANY RELATED INFORMATION NEEDED BY THE MINOR'S EMPLOYER TO
41 DEPOSIT MONIES INTO THE ACCOUNT.

42 9. A TRUE AND ACCURATE COPY OF THE DOCUMENTS THAT CREATED THE
43 TRUST, WHICH MAY INCLUDE A DECLARATION OF TRUST, DEED OF SETTLEMENT,
44 ACCOUNT AGREEMENT, PASSBOOK OR SIMILAR DOCUMENTATION.

1 D. ON APPLICATION BY THE TRUSTEE TO THE FINANCIAL INSTITUTION, THE
2 FINANCIAL INSTITUTION MAY HANDLE THE MONIES IN ONE OR MORE OF THE
3 FOLLOWING METHODS:

4 1. TRANSFER MONIES TO ANOTHER ACCOUNT AT THE SAME FINANCIAL
5 INSTITUTION, IF THE MONIES TRANSFERRED SHALL CONTINUE TO BE HELD IN TRUST.

6 2. TRANSFER MONIES TO ANOTHER FINANCIAL INSTITUTION IF THE MONIES
7 TRANSFERRED CONTINUE TO BE HELD IN TRUST AND THE TRANSFERRING FINANCIAL
8 INSTITUTION HAS PROVIDED WRITTEN NOTIFICATION TO THE FINANCIAL INSTITUTION
9 TO WHICH THE MONIES WILL BE TRANSFERRED.

10 3. USE ALL OR PART OF THE MONIES TO PURCHASE AND HOLD IN TRUST FOR
11 THE BENEFIT OF THE MINOR THE FOLLOWING:

12 (a) INVESTMENT FUNDS OFFERED BY A COMPANY REGISTERED UNDER THE
13 INVESTMENT COMPANY ACT OF 1940 (54 STAT. 789) IF:

14 (i) THE UNDERLYING INVESTMENTS ARE EQUITY SECURITIES.

15 (ii) THE INVESTMENT FUND IS A BROAD-BASED INDEX FUND.

16 (iii) THE INVESTMENT FUND INVESTS BROADLY ACROSS THE DOMESTIC OR A
17 FOREIGN REGIONAL ECONOMY, IS NOT A SECTOR FUND AND HAS ASSETS UNDER
18 MANAGEMENT OF AT LEAST \$250,000,000.

19 (b) GOVERNMENT SECURITIES AND BONDS, CERTIFICATES OF DEPOSIT, MONEY
20 MARKET INSTRUMENTS, MONEY MARKET ACCOUNTS OR MUTUAL FUNDS INVESTING SOLELY
21 IN THOSE GOVERNMENT SECURITIES AND BONDS, CERTIFICATES, INSTRUMENTS AND
22 ACCOUNTS THAT ARE AVAILABLE AT THE FINANCIAL INSTITUTION WHERE THE TRUST
23 FUND IS HELD.

24 E. THE PURCHASES MADE PURSUANT TO THIS SECTION SHALL HAVE THE
25 MATURITY DATE ON OR BEFORE THE BENEFICIARY ATTAINS EIGHTEEN YEARS OF AGE.

26 F. ANY PROCEEDS GENERATED FROM THE TRUST ACCOUNT SHALL BE
27 REDEPOSITED INTO THE ACCOUNT OR USED TO MAKE FURTHER INVESTMENT PURCHASES.

28 Sec. 2. Applicability

29 This act applies to contracts that are entered into between an
30 unemancipated minor and any party or third party on or after January 1,
31 2027.
