# HOUSE BILL 2923

AN ACT

AMENDING SECTIONS 14-5312.01 AND 36-546, ARIZONA REVISED STATUTES;  
RELATING TO MENTAL HEALTH SERVICES.

(TEXT OF BILL BEGINS ON NEXT PAGE)

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 14-5312.01, Arizona Revised Statutes, is amended  
3 to read:

4 14-5312.01. Inpatient treatment; rights and duties of ward  
5 and guardian

6 A. Except as provided in subsection B of this section, a guardian  
7 of an incapacitated person may consent to psychiatric and psychological  
8 care and treatment, including the administration of psychotropic  
9 medications, if the care and treatment take place outside an inpatient  
10 psychiatric facility licensed by the department of health services.

11 B. On clear and convincing evidence that the ward is an  
12 incapacitated person and is likely to be in need of inpatient mental  
13 health care and treatment within the period of the authority granted  
14 pursuant to this section, the court may authorize a guardian appointed  
15 pursuant to this title to give consent for the ward to receive inpatient  
16 mental health care and treatment, including placement in an inpatient  
17 psychiatric facility licensed by the department of health services and  
18 medical, psychiatric and psychological treatment associated with that  
19 placement. The evidence shall be supported by the opinion of a mental  
20 health expert who is either a physician licensed pursuant to title 32,  
21 chapter 13 or 17 and who is a specialist in psychiatry or a psychologist  
22 who is licensed pursuant to title 32, chapter 19.1.

23 C. In making its decision to grant authority to a guardian pursuant  
24 to subsection B of this section, the court shall consider the cause of the  
25 ward's disability and the ward's foreseeable clinical needs. The court  
26 shall limit the guardian's authority to what is reasonably necessary to  
27 obtain the care required for the ward in the least restrictive treatment  
28 alternative. The court may limit the duration of the guardian's authority  
29 to consent to inpatient mental health care and treatment and include other  
30 orders the court determines necessary to protect the ward's best  
31 interests.

32 D. Within forty-eight hours after placement of the ward pursuant to  
33 this section, the guardian shall give notice of this action to the ward's  
34 attorney. When the attorney receives this notice the attorney shall assess  
35 the appropriateness of the placement pursuant to section 36-537,  
36 subsection B and section 36-546, subsection ~~H~~ L. If requested by the  
37 attorney, the court shall hold a hearing on the appropriateness of the  
38 placement within three days after receiving that request.

39 E. The inpatient psychiatric facility shall assess the  
40 appropriateness of the ward's placement every thirty days and shall  
41 provide a copy of the assessment report to the ward's attorney on request.  
42 The ward's attorney may attend the ward's evaluation, staffing, treatment  
43 team and case management meetings.

44 F. When the ward is admitted to an inpatient psychiatric facility  
45 pursuant to this section, the guardian shall provide the facility with the

1 name, address and telephone number of the ward's attorney. The facility  
2 shall include this information in the ward's treatment record.

3 G. Within twenty-four hours after the facility receives any writing  
4 in which the ward requests release from the facility, any change in  
5 placement or a change in the type or duration of treatment, the facility  
6 shall forward this information to the ward's attorney.

7 H. All health care providers, treatment facilities and regional  
8 behavioral health authorities shall allow the ward's attorney access to  
9 all of the ward's medical, psychiatric, psychological and other treatment  
10 records.

11 I. The ward's guardian shall place the ward in a least restrictive  
12 treatment alternative within five days after the guardian is notified by  
13 the medical director of the inpatient facility that the ward no longer  
14 needs inpatient care. The ward, a representative of the inpatient  
15 treatment facility, the ward's attorney, the ward's physician or any other  
16 interested person may petition the court to order the facility to  
17 discharge the ward to a least restrictive treatment alternative if the  
18 guardian does not act promptly to do so.

19 J. If the ward is in an inpatient psychiatric facility at the time  
20 of the initial hearing on the petition for appointment of a guardian, the  
21 court investigator and the ward's attorney shall advise the court of the  
22 appropriateness of the placement.

23 K. An attorney appointed pursuant to section 14-5303, subsection C  
24 remains the attorney of record until the attorney is discharged by the  
25 court. The court shall ensure that a ward whose guardian has been granted  
26 inpatient mental health treatment authority is represented by an attorney  
27 at all times the guardian has that authority. Unless the court finds that  
28 the ward has insufficient assets to meet the ward's reasonable and  
29 necessary care and living expenses, the ward shall pay the attorney's  
30 reasonable fees.

31 L. If deemed necessary to adequately assess a request for inpatient  
32 mental health treatment authority or to review the ward's placement in an  
33 inpatient psychiatric facility, the court may order an independent  
34 evaluation by either a physician who is licensed pursuant to title 32,  
35 chapter 13 or 17 and who is a specialist in psychiatry or a psychologist  
36 who is licensed pursuant to title 32, chapter 19.1. If the ward has  
37 insufficient funds to pay the total cost of this evaluation, the court may  
38 deem all or any part of the evaluator's fee to be a county expense after  
39 determining the reasonableness of that fee.

40 M. Instead of ordering an independent evaluation pursuant to  
41 subsection L of this section, the court may accept a report conducted on  
42 behalf of the inpatient psychiatric facility if the court finds that the  
43 report meets the requirements of an independent evaluation.

1 N. The court may decide that the ward's right to retain or obtain a  
2 driver license and any other civil right that may be suspended by  
3 operation of law is not affected by the appointment of a guardian.

4 O. If the court grants the guardian the authority to consent to  
5 inpatient mental health care and treatment pursuant to this section, the  
6 medical director of an inpatient psychiatric facility licensed by the  
7 department of health services may admit the ward at the guardian's  
8 request.

9 P. A guardian who is authorized by the court to consent to  
10 inpatient mental health care and treatment pursuant to this section shall  
11 file with the annual report of the guardian required pursuant to section  
12 14-5315 an evaluation report by a physician or a psychologist who meets  
13 the requirements of subsection B of this section. The evaluation report  
14 shall indicate if the ward will likely need inpatient mental health care  
15 and treatment within the period of the authority granted pursuant to this  
16 section. If the guardian does not file the evaluation report or if the  
17 report indicates that the ward will not likely need inpatient mental  
18 health care and treatment, the guardian's authority to consent to this  
19 treatment ceases on the expiration of the period specified in the prior  
20 court order. If the report supports the continuation of the guardian's  
21 authority to consent to inpatient treatment, the court may order that the  
22 guardian's authority to consent to this treatment continues. If the  
23 report supports the continuation of the guardian's authority to consent to  
24 this treatment, the ward's attorney shall review the report with the  
25 ward. The ward may contest the continuation of the guardian's authority  
26 by filing a request for a court hearing within ten business days after the  
27 report is filed. The court shall hold this hearing within thirty calendar  
28 days after it receives the request. The guardian's authority continues  
29 pending the court's ruling on the issue. At the hearing the guardian has  
30 the burden of proving by clear and convincing evidence that the ward is  
31 likely to be in need of inpatient mental health care and treatment within  
32 the period of the authority granted pursuant to this section.

33 Q. The court may discharge an attorney who was appointed pursuant  
34 to section 14-5303, subsection C subsequent to the appointment of a  
35 guardian if it clearly appears from specific facts presented by affidavit  
36 or verified petition that continued representation of the ward is no  
37 longer necessary or desirable. The factual basis must include, at a  
38 minimum, consideration of the following:

- 39 1. The nature and history of the ward's illness.
- 40 2. The ward's history of hospitalization.
- 41 3. The ward's current and anticipated living arrangements.
- 42 4. Whether the ward's inpatient treatment is anticipated to be a  
43 ~~one-time~~ ONETIME hospitalization for the purpose of stabilizing the ward's  
44 condition and further hospitalizations are not likely to be necessary.

1           5. Whether the ward's current and anticipated living arrangements  
2 are the least restrictive alternatives possible.

7           A. ~~In addition to the procedure for applying for a writ of habeas~~  
8 ~~corpus, as provided in title 13, chapter 38, article 26,~~ A patient  
9 receiving court-ordered treatment or any person acting on the patient's  
10 behalf may request ~~the patient's release pursuant to the following:~~

11           ~~1. A request in writing may be presented to any member of the~~  
12 ~~treatment staff of the agency providing the patient's treatment. The~~  
13 ~~request may be made on a prescribed form that shall be prepared by the~~  
14 ~~facility and made available for use by any person. The completed form~~  
15 ~~shall identify:~~

16           ~~(a) The patient being treated and the agency at which the patient~~  
17 ~~is being treated.~~

18           ~~(b) The person to whom the request for release was made.~~

34           B. A REQUEST FOR JUDICIAL REVIEW MAY NOT BE MADE SOONER THAN SIXTY  
35 DAYS AFTER THE ORIGINAL ORDER FOR COURT-ORDERED TREATMENT IS ENTERED.  
36 EXCEPT FOR REQUESTS FOR JUDICIAL REVIEW MADE PURSUANT TO SECTION 36-540,  
37 SUBSECTION E, PARAGRAPHS 5 AND 6 AND SECTION 36-540.01, SUBSECTION K, A  
38 REQUEST FOR A SUBSEQUENT JUDICIAL REVIEW MAY NOT BE MADE SOONER THAN SIXTY

41           ~~B.~~ C. The patient shall be informed BY THE MEDICAL DIRECTOR OF THE  
42 MENTAL HEALTH TREATMENT AGENCY of the patient's right to judicial review  
43 ~~by the medical director of the agency~~ and the patient's right to consult  
44 with ~~counsel~~ AN ATTORNEY at least once each sixty days while the patient  
45 is undergoing court-ordered treatment. The notification required by this

1 subsection shall be recorded in the clinical record of the patient by the  
2 individual who gave the notice.

3 ~~C. With the exception of requests made pursuant to section 36-540,  
4 subsection E, paragraphs 5 and 6 and section 36-540.01, subsection K for  
5 judicial review, a request for judicial review may not be made sooner than  
6 sixty days after the issuance of the order for treatment or a hearing on a  
7 previous petition for habeas corpus or the issuance of the court order or  
8 other final resolution determining a previous request for judicial review  
9 by the patient.~~

10 D. A REQUEST FOR JUDICIAL REVIEW SHALL BE MADE IN THE FOLLOWING  
11 MANNER:

12 1. A WRITTEN REQUEST FOR JUDICIAL REVIEW MAY BE PRESENTED TO ANY  
13 MEMBER OF THE TREATMENT STAFF OF THE MENTAL HEALTH TREATMENT AGENCY  
14 PROVIDING THE PATIENT'S TREATMENT. THE REQUEST MAY BE MADE BY THE  
15 PATIENT, AN ATTORNEY REPRESENTING THE PATIENT OR A HEALTH CARE  
16 DECISION-MAKER ACTING ON BEHALF OF THE PATIENT. THE REQUEST MAY BE MADE  
17 ON A PRESCRIBED FORM THAT IS PREPARED BY THE MENTAL HEALTH TREATMENT  
18 AGENCY AND MADE AVAILABLE FOR USE BY ANY PERSON. THE COMPLETED FORM SHALL  
19 IDENTIFY:

20 (a) THE NAME AND DATE OF BIRTH OF THE PATIENT BEING TREATED.

21 (b) THE MENTAL HEALTH TREATMENT AGENCY ASSIGNED TO SUPERVISE AND  
22 ADMINISTER THE PATIENT'S TREATMENT PROGRAM AND, IF THE PATIENT IS BEING  
23 TREATED AS AN INPATIENT, THE INPATIENT MENTAL HEALTH TREATMENT AGENCY AT  
24 WHICH THE PATIENT IS BEING TREATED.

25 (c) THE NAME OF THE PERSON TO WHOM THE REQUEST FOR JUDICIAL REVIEW  
26 WAS PRESENTED AND THE DATE THE REQUEST WAS RECEIVED.

27 (d) WHETHER THE PERSON MAKING THE REQUEST IS THE PATIENT BEING  
28 TREATED OR SOMEONE ACTING ON THE PATIENT'S BEHALF. IF THE REQUEST IS MADE  
29 BY SOMEONE OTHER THAN THE PATIENT, THE FORM MUST IDENTIFY THE NAME AND  
30 CONTACT INFORMATION OF THE PERSON MAKING THE REQUEST AND IN WHAT CAPACITY  
31 THE PERSON IS ACTING ON BEHALF OF THE PATIENT.

32 2. A MENTAL HEALTH TREATMENT STAFF MEMBER WHO RECEIVES A WRITTEN  
33 REQUEST FOR JUDICIAL REVIEW SHALL PROMPTLY DELIVER THE REQUEST TO THE  
34 MEDICAL DIRECTOR OF THE MENTAL HEALTH TREATMENT AGENCY. IF THE PERSON  
35 PRESENTING THE REQUEST REFUSES TO SIGN IT, THE MEDICAL DIRECTOR OF THE  
36 MENTAL HEALTH TREATMENT AGENCY SHALL PROCEED AS IF THE REQUEST HAD BEEN  
37 SIGNED AND SHALL NOTE ON THE REQUEST THE CIRCUMSTANCES WHY THE REQUEST WAS  
38 NOT SIGNED.

39 3. WITHIN THREE BUSINESS DAYS AFTER RECEIVING THE REQUEST, THE  
40 MEDICAL DIRECTOR OF THE MENTAL HEALTH TREATMENT AGENCY OR THE MEDICAL  
41 DIRECTOR'S DESIGNEE SHALL DELIVER THE REQUEST, ALONG WITH A CURRENT  
42 PSYCHIATRIC REPORT OF THE PATIENT'S CONDITION, TO BE FILED WITH THE CLERK  
43 OF THE COURT. THE CURRENT PSYCHIATRIC REPORT SHALL EXPRESS THE OPINION OF  
44 THE MEDICAL DIRECTOR OF THE MENTAL HEALTH TREATMENT AGENCY AS TO WHETHER  
45 THE PATIENT CONTINUES TO MEET THE CRITERIA FOR COURT-ORDERED TREATMENT.

1 IF THE MEDICAL DIRECTOR OF THE MENTAL HEALTH TREATMENT AGENCY IS OF THE  
2 OPINION THAT A COURT ORDER FOR TREATMENT IS NO LONGER NEEDED BECAUSE,  
3 ALTHOUGH THE PATIENT CONTINUES TO HAVE A MENTAL DISORDER, THE PATIENT IS  
4 WILLING TO ACCEPT VOLUNTARY TREATMENT, THE MEDICAL DIRECTOR OF THE MENTAL  
5 HEALTH TREATMENT AGENCY SHALL STATE AN OPINION REGARDING THE PATIENT'S  
6 ABILITY TO ACCEPT AND FOLLOW THROUGH WITH RECOMMENDED TREATMENT  
7 VOLUNTARILY. IN RENDERING SUCH AN OPINION, THE MEDICAL DIRECTOR OF THE  
8 MENTAL HEALTH TREATMENT AGENCY SHALL CONSIDER THE PATIENT'S HISTORY OF  
9 BEHAVIOR AND COMPLIANCE WITH TREATMENT BOTH BEFORE AND AFTER THE COURT  
10 ORDER WAS ENTERED.

11 E. IF THE PATIENT IS UNDER A GUARDIANSHIP, WITHIN THREE DAYS AFTER  
12 RECEIVING A REQUEST FOR JUDICIAL REVIEW, THE MEDICAL DIRECTOR OF THE  
13 MENTAL HEALTH TREATMENT AGENCY SHALL NOTIFY THE GUARDIAN THAT A REQUEST  
14 FOR JUDICIAL REVIEW HAS BEEN PRESENTED TO THE MENTAL HEALTH TREATMENT  
15 AGENCY AND IS BEING FILED WITH THE COURT FOR FURTHER ACTION.

16 F. DELIVERY OF THE NOTICE REQUIRED BY SUBSECTION E OF THIS SECTION  
17 SHALL BE ACCOMPLISHED BY ANY REASONABLE MEANS DESIGNED TO IMPART IMMEDIATE  
18 NOTICE OF THE ACTION TAKEN, SUCH AS ELECTRONIC TRANSMISSION WITH RECEIPT  
19 CONFIRMED BY THE PERSON TO WHOM IT IS SENT OR HAND DELIVERY. THE MEDICAL  
20 DIRECTOR OF THE MENTAL HEALTH TREATMENT AGENCY SHALL CERTIFY THE DELIVERY  
21 AND RECEIPT OF DELIVERY BY A STATEMENT IN THE DOCUMENTS DELIVERED TO THE  
22 COURT FOR FILING PURSUANT TO SUBSECTION D OF THIS SECTION OR BY A SEPARATE  
23 WRITTEN CERTIFICATE FILED WITH THE COURT. IF DELIVERY IS NOT  
24 ACCOMPLISHED, THE MENTAL HEALTH TREATMENT AGENCY SHALL CERTIFY ALL EFFORTS  
25 TO ACCOMPLISH DELIVERY AND STATE THE REASONS DELIVERY COULD NOT BE  
26 ACCOMPLISHED. A PERSON WHO IS ENTITLED TO NOTICE MAY WAIVE DELIVERY.

27 G. THE PATIENT SHALL BE INFORMED, AT THE TIME THE PATIENT MAKES THE  
28 REQUEST, OF THE PATIENT'S RIGHT TO CONSULT AN ATTORNEY BY THE PERSON OR  
29 COURT TO WHOM THE PATIENT MAKES THE REQUEST FOR RELEASE AND, IN THE CASE  
30 OF CONFINEMENT IN A MENTAL HEALTH TREATMENT AGENCY, BY THE REVIEWING COURT  
31 WITHIN ONE DAY AFTER THE COURT'S RECEIPT OF NOTICE FROM THE MEDICAL  
32 DIRECTOR OF THE MENTAL HEALTH TREATMENT AGENCY WHERE THE PATIENT IS BEING  
33 TREATED. THE PATIENT SHALL BE ALLOWED TO CONSULT AN ATTORNEY TO ASSIST IN  
34 PREPARATION OF A PETITION FOR THE WRIT OF HABEAS CORPUS AND TO REPRESENT  
35 THE PATIENT IN THE HEARING. IF THE PATIENT IS NOT REPRESENTED BY AN  
36 ATTORNEY, THE REVIEWING COURT, WITHIN TWO DAYS AFTER THE COURT'S NOTICE TO  
37 THE PATIENT OF THE PATIENT'S RIGHT TO COUNSEL, SHALL APPOINT AN ATTORNEY  
38 TO ASSIST THE PATIENT IN THE PREPARATION OF A PETITION AND TO REPRESENT

40 H. THE MENTAL HEALTH TREATMENT AGENCY HAS THE BURDEN OF PROVING,

42 COURT-ORDERED TREATMENT. UNLESS THE COURT FINDS THAT THE PATIENT'S  
43 TREATMENT IS ILLEGAL ON OTHER GROUNDS, THE PATIENT SHALL NOT BE RELEASED  
44 FROM COURT-ORDERED TREATMENT UNLESS THE COURT FINDS THAT COURT-ORDERED  
45 TREATMENT IS NO LONGER REQUIRED BECAUSE THE PATIENT IS NO LONGER, AS THE

1 RESULT OF A MENTAL DISORDER, A DANGER TO SELF OR A DANGER TO OTHERS OR NO  
2 LONGER HAS A PERSISTENT OR ACUTE DISABILITY OR A GRAVE DISABILITY AND IS  
3 NO LONGER IN NEED OF COURT-ORDERED TREATMENT OR IS WILLING AND ABLE TO  
4 ACCEPT AND FOLLOW THROUGH WITH ANY TREATMENT NEEDED VOLUNTARILY.

5 ~~D.~~ I. Judicial review shall be in the superior court in the county  
6 in which the patient is being treated. ~~That~~ WITHIN FIVE JUDICIAL DAYS  
7 AFTER THE REQUEST FOR JUDICIAL REVIEW IS FILED, THE court ~~may~~ SHALL review  
8 the additional material presented and MAY enter its order without  
9 necessity of ~~further~~ A hearing.

10 ~~E.~~ J. The reviewing court may order a ~~further~~ hearing ON ITS OWN  
11 MOTION, on the ~~affidavit~~ MOTION of the attorney for the patient OR ON THE  
12 MOTION OF THE PERSON FILING THE REQUEST FOR JUDICIAL REVIEW ON BEHALF OF
