SENATE BILL 1160

AN ACT

AMENDING SECTION 13-3729, ARIZONA REVISED STATUTES; RELATING TO UNMANNED AIRCRAFT.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 13-3729, Arizona Revised Statutes, is amended to
3 read:

4 13-3729. Unlawful operation of model or unmanned aircraft;
5 state preemption; classification; definitions

6 A. It is unlawful for a person to operate a model aircraft or a
7 civil unmanned aircraft if the operation:

8 1. Is prohibited by a federal law or regulation that governs
9 aeronautics, including federal aviation administration regulations.

10 2. Interferes with a law enforcement, firefighter or emergency
11 services operation.

12 B. It is unlawful for a person to operate or use an unmanned
13 aircraft or unmanned aircraft system to intentionally photograph or loiter
14 over or near a critical facility in the furtherance of any criminal
15 offense.

16 C. IT IS UNLAWFUL FOR A PERSON TO INTENTIONALLY OPERATE A CIVIL
17 UNMANNED AIRCRAFT WITHIN FIVE THOUSAND TWO HUNDRED EIGHTY FEET OF OR
18 WITHIN FIVE THOUSAND TWO HUNDRED EIGHTY FEET ABOVE A TICKETED
19 ENTERTAINMENT EVENT UNLESS THE PERSON:

20 1. OBTAINS WRITTEN CONSENT FROM ANOTHER PERSON WITH LEGAL AUTHORITY
21 OVER THE TICKETED ENTERTAINMENT EVENT.

22 2. IS AN EMPLOYEE OF THE PROPERTY WHERE THE TICKETED ENTERTAINMENT
23 EVENT IS HELD AND IS CONDUCTING OFFICIAL BUSINESS.

24 3. IS AN EMPLOYEE OF A WATER, SEWER, ELECTRIC, TELECOMMUNICATIONS,
25 CABLE OR OTHER PUBLIC OR REGULATED UTILITY AND IS CONDUCTING OFFICIAL
26 BUSINESS.

27 4. IS OPERATING THE PERSON'S OWN CIVIL UNMANNED AIRCRAFT ABOVE THE
28 PERSON'S OWN PRIVATE PROPERTY AND THE OPERATION IS CONSISTENT WITH FEDERAL
29 LAW AND IS NOT USED FOR ANY OF THE FOLLOWING:

30 (a) COMMERCIAL PURPOSES.

31 (b) TO CONVEY OR COMMUNICATE A MESSAGE OR TO RECORD FOR THE
32 PURPOSES OF COMMERCIAL BROADCASTING OR PUBLICATION.

33 (c) TO MONITOR OR OTHERWISE INTERFERE IN ANY WAY WITH A TICKETED
34 ENTERTAINMENT EVENT.

35 ~~C.~~ D. Except as authorized by law, a city, town or county may not
36 enact or adopt any ordinance, policy or rule that relates to the ownership
37 or operation of an unmanned aircraft or unmanned aircraft system or
38 otherwise engage in the regulation of the ownership or operation of an
39 unmanned aircraft or an unmanned aircraft system. Any ordinance, policy or
40 rule that violates this subsection, whether enacted or adopted by the
41 city, town or county before or after August 6, 2016, is void.

42 ~~D.~~ E. This section does not:

43 1. Apply to a person or entity that is authorized or allowed by the
44 federal aviation administration to operate or use an unmanned aircraft
45 system if the person's or entity's operation or use complies with the

1 authorization granted to the person or entity or with federal aviation
2 administration rules.

3 2. Prohibit a city, town or county from enacting or adopting
4 ordinances or rules on the operation or use of a public unmanned aircraft
5 that is owned by the city, town or county.

6 3. Prohibit a city, town or county from enacting or adopting
7 ordinances or rules that regulate the takeoff or landing of a model
8 aircraft in a park or preserve owned by the city, town or county if:

9 (a) There are other parks or preserves that are within the city,
10 town or county and that are available for model aircraft operation.

11 (b) The city, town or county only has one park or preserve that is
12 within the city, town or county.

13 4. Apply to the operation of an unmanned aircraft, including a
14 public unmanned aircraft, by a first responder as defined in section
15 36-661 while acting in the first responder's official capacity or an
16 emergency worker while engaged in or supporting authorized emergency
17 management activities or performing emergency functions pursuant to title
18 26, chapter 2.

19 ~~F.~~ F. A violation of subsection B of this section is a class 6
20 felony, except that a second or subsequent violation is a class 5 felony.
21 A violation of subsection A OR C of this section is a class 1 misdemeanor.

22 ~~F.~~ G. For the purposes of this section:

23 1. "Civil unmanned aircraft" means an unmanned aircraft or unmanned
24 aircraft system that is operated by a person for any purpose other than
25 strictly for hobby or recreational purposes, including commercial
26 purposes, or in furtherance of or incidental to any business or media
27 service or agency.

28 2. "Commercial purposes" means the use of an unmanned aircraft in
29 return for financial compensation and includes aerial photography, aerial
30 mapping or geospatial imaging.

31 3. "Critical facility" means any of the following:

32 (a) A petroleum or alumina refinery.

33 (b) A petroleum, chemical or rubber production, transportation,
34 storage or processing facility.

35 (c) A chemical manufacturing facility.

36 (d) A water or wastewater treatment facility and water development,
37 distribution or conveyance system, including a dam.

38 (e) An electric generation facility, as defined in section
39 42-14156, and any associated substation or switchyard.

40 (f) An electrical transmission or distribution substation.

41 (g) An electrical transmission line of at least sixty-nine thousand
42 volts.

43 (h) An electronic communication station or tower.

44 (i) An energy control center.

45 (j) A distribution operating center.

- 1 (k) A facility that transfers or distributes natural gas, including
2 a compressor station, regulator station, city gate station or pressure
3 limiting station or a liquefied natural gas facility or supplier tap
4 facility.
- 5 (l) Any railroad infrastructure or facility.
- 6 (m) A federal, state, county or municipal court.
- 7 (n) A public safety or emergency operation facility.
- 8 (o) A federal, state, county or municipal jail or prison or other
9 facility in which persons are incarcerated.
- 10 (p) A federal or state military installation or facility.
- 11 (q) A hospital that receives air ambulance services.
- 12 4. "Model aircraft" has the same meaning prescribed in section 336
13 of the FAA modernization and reform act of 2012 (P.L. 112-95), as amended.
- 14 5. "Person" means a corporation, firm, partnership, association,
15 individual or organization or any other group acting as a unit.
- 16 6. "Public unmanned aircraft" means an unmanned aircraft or
17 unmanned aircraft system that is operated by a public agency for a
18 government-related purpose.
- 19 7. "TICKETED ENTERTAINMENT EVENT" MEANS A MUSIC, SPORTING OR
20 PERFORMING ARTS EVENT THAT MEETS ALL OF THE FOLLOWING:
- 21 (a) THE EVENT IS HELD IN A LOCATION WITH GATED ENTRIES OR BARRIERS
22 THAT PREVENT ACCESS TO THE GENERAL PUBLIC.
- 23 (b) AN OWNER, OPERATOR OR LESSEE OF THE PROPERTY HAS ISSUED A
24 REVOCABLE LICENSE THAT IS REQUIRED FOR ATTENDANCE AT THE EVENT.
- 25 (c) THE EVENT IS HELD IN ONE OF THE FOLLOWING LOCATIONS:
- 26 (i) OUTDOORS.
- 27 (ii) AT A VENUE WITH A RETRACTABLE ROOF.
- 28 (iii) IN A FACILITY WITH A CAPACITY OF AT LEAST ONE THOUSAND
29 ATTENDEES.
- 30 ~~7.~~ 8. "Unmanned aircraft" means an aircraft, including an aircraft
31 commonly known as a drone, that is operated without the possibility of
32 direct human intervention from within or on the aircraft.
- 33 ~~8.~~ 9. "Unmanned aircraft system" means an unmanned aircraft and
34 associated elements, including any communication links and components that
35 control the unmanned aircraft.
