AN ACT

AMENDING TITLE 23, CHAPTER 2, ARIZONA REVISED STATUTES, BY ADDING ARTICLE
8.2; RELATING TO EMPLOYMENT PRACTICES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 23, chapter 2, Arizona Revised Statutes, is
3 amended by adding article 8.2, to read:

4 ARTICLE 8.2. FAMILY AND MEDICAL LEAVE

5 23-382. Definitions

6 IN THIS ARTICLE, UNLESS THE CONTEXT OTHERWISE REQUIRES:

7 1. "ABUSE" HAS THE SAME MEANING PRESCRIBED IN SECTION 13-3623.

8 2. "APPLICATION YEAR" MEANS THE TWELVE-MONTH PERIOD BEGINNING ON
9 THE FIRST DAY OF THE CALENDAR WEEK IN WHICH AN INDIVIDUAL FILES AN
10 APPLICATION FOR FAMILY AND MEDICAL LEAVE INSURANCE BENEFITS.

11 3. "AVERAGE WEEKLY WAGE" MEANS ONE-THIRTEENTH OF THE COVERED
12 INDIVIDUAL'S TOTAL WAGES FOR COVERED WORK PAID DURING THE QUARTER OF THE
13 PERSON'S BASE PERIOD IN WHICH SUCH TOTAL WAGES WERE HIGHEST.

14 4. "BASE PERIOD" HAS THE SAME MEANING PRESCRIBED IN SECTION 23-605.

15 5. "COMMISSION" MEANS THE INDUSTRIAL COMMISSION OF ARIZONA.

16 6. "COVERED INDIVIDUAL" MEANS ANY PERSON WHO MEETS ALL OF THE
17 FOLLOWING REQUIREMENTS:

18 (a) MEETS ONE OF THE FOLLOWING:

19 (i) HAS BEEN PAID WAGES FOR COVERED WORK DURING THE INDIVIDUAL'S
20 BASE PERIOD EQUAL TO AT LEAST ONE AND ONE-HALF TIMES THE WAGES PAID TO THE
21 INDIVIDUAL IN THE CALENDAR QUARTER OF THE INDIVIDUAL'S BASE PERIOD IN
22 WHICH THE WAGES WERE HIGHEST, AND THE INDIVIDUAL HAS BEEN PAID WAGES FOR
23 COVERED WORK IN ONE CALENDAR QUARTER OF THE INDIVIDUAL'S BASE PERIOD EQUAL
24 TO AN AMOUNT THAT IS EQUAL TO AT LEAST THREE HUNDRED NINETY TIMES THE
25 MINIMUM WAGE PRESCRIBED BY SECTION 23-363 THAT IS IN EFFECT WHEN THE
26 INDIVIDUAL FILES A CLAIM FOR BENEFITS.

27 (ii) HAS BEEN PAID WAGES FOR COVERED WORK DURING AT LEAST TWO
28 QUARTERS OF THE INDIVIDUAL'S BASE PERIOD AND THE AMOUNT OF THE WAGES PAID
29 IN ONE QUARTER WOULD BE SUFFICIENT TO QUALIFY THE INDIVIDUAL FOR THE
30 MAXIMUM WEEKLY BENEFIT AMOUNT PAYABLE UNDER THIS ARTICLE AND THE TOTAL OF
31 THE INDIVIDUAL'S BASE-PERIOD WAGES IS EQUAL TO OR GREATER THAN THE TAXABLE
32 LIMIT FOR UNEMPLOYMENT INSURANCE AS SPECIFIED IN SECTION 23-622,
33 SUBSECTION B, PARAGRAPH 1.

34 (iii) IS SELF-EMPLOYED, ELECTS COVERAGE AND MEETS THE REQUIREMENTS
35 OF SECTION 23-382.12.

36 (b) MEETS THE ADMINISTRATIVE REQUIREMENTS OUTLINED IN THIS ARTICLE
37 AND IN RULES ADOPTED PURSUANT TO THIS ARTICLE.

38 (c) SUBMITS AN APPLICATION.

39 7. "DIRECTOR" MEANS THE DIRECTOR OF THE COMMISSION.

40 8. "DOMESTIC VIOLENCE" HAS THE SAME MEANING PRESCRIBED IN SECTION
41 13-3601.

42 9. "EMPLOYEE" HAS THE SAME MEANING PRESCRIBED IN SECTION 23-362.

43 10. "EMPLOYER" HAS THE SAME MEANING PRESCRIBED IN SECTION 23-371,
44 EXCEPT THAT AN EMPLOYER ALSO INCLUDES THIS STATE.

1 11. "FAMILY AND MEDICAL LEAVE INSURANCE BENEFITS" MEANS THE
2 BENEFITS PROVIDED UNDER THIS ARTICLE.

3 12. "FAMILY MEMBER" HAS THE SAME MEANING PRESCRIBED IN SECTION
4 23-371.

5 13. "HEALTH CARE PROVIDER" MEANS ANY PERSON LICENSED UNDER FEDERAL
6 LAW OR THE LAWS OF THIS STATE TO PROVIDE MEDICAL OR EMERGENCY SERVICES,
7 INCLUDING DOCTORS, NURSES AND EMERGENCY ROOM PERSONNEL, OR CERTIFIED
8 MIDWIVES.

9 14. "QUALIFYING EXIGENCY LEAVE" MEANS LEAVE BASED ON A NEED ARISING
10 OUT OF A COVERED INDIVIDUAL'S FAMILY MEMBER'S ACTIVE DUTY SERVICE OR
11 NOTICE OF AN IMPENDING CALL OR ORDER TO ACTIVE DUTY IN THE ARMED FORCES,
12 INCLUDING ANY OF THE FOLLOWING:

13 (a) PROVIDING FOR THE CARE OR OTHER NEEDS OF THE MILITARY MEMBER'S
14 CHILD OR OTHER FAMILY MEMBER.

15 (b) MAKING FINANCIAL OR LEGAL ARRANGEMENTS FOR THE MILITARY MEMBER.

16 (c) ATTENDING COUNSELING.

17 (d) ATTENDING MILITARY EVENTS OR CEREMONIES.

18 (e) SPENDING TIME WITH THE MILITARY MEMBER DURING A REST AND
19 RECUPERATION LEAVE OR FOLLOWING RETURN FROM DEPLOYMENT.

20 (f) MAKING ARRANGEMENTS FOLLOWING THE DEATH OF THE MILITARY MEMBER.

21 15. "RETALIATORY PERSONNEL ACTION":

22 (a) MEANS DENIAL OF ANY RIGHT GUARANTEED UNDER THIS ARTICLE,
23 INCLUDING EITHER OF THE FOLLOWING:

24 (i) ANY THREAT, DISCHARGE, SUSPENSION, DEMOTION OR REDUCTION OF
25 HOURS OR ANY OTHER ADVERSE ACTION AGAINST AN EMPLOYEE FOR THE EXERCISE OF
26 ANY RIGHT GUARANTEED IN THIS ARTICLE.

27 (ii) REPORTING OR THREATENING TO REPORT AN EMPLOYEE'S SUSPECTED
28 CITIZENSHIP OR IMMIGRATION STATUS OR THE SUSPECTED CITIZENSHIP OR
29 IMMIGRATION STATUS OF A FAMILY MEMBER OF THE EMPLOYEE TO A FEDERAL, STATE
30 OR LOCAL AGENCY.

31 (b) INCLUDES INTERFERENCE WITH OR PUNISHMENT FOR IN ANY MANNER
32 PARTICIPATING IN OR ASSISTING AN INVESTIGATION, PROCEEDING OR HEARING
33 UNDER THIS ARTICLE.

34 16. "SAFE LEAVE" MEANS, NOTWITHSTANDING SECTION 13-4439, ABSENCE
35 NECESSARY DUE TO DOMESTIC VIOLENCE, SEXUAL VIOLENCE, ABUSE OR STALKING, IF
36 THE LEAVE IS TO ALLOW THE COVERED INDIVIDUAL TO OBTAIN FOR THE COVERED
37 INDIVIDUAL OR THE COVERED INDIVIDUAL'S FAMILY MEMBER ANY OF THE FOLLOWING:

38 (a) MEDICAL ATTENTION NEEDED TO RECOVER FROM PHYSICAL OR
39 PSYCHOLOGICAL INJURY OR DISABILITY CAUSED BY DOMESTIC VIOLENCE, SEXUAL
40 VIOLENCE, ABUSE OR STALKING.

41 (b) SERVICES FROM A DOMESTIC VIOLENCE OR SEXUAL VIOLENCE PROGRAM OR
42 VICTIM SERVICES ORGANIZATION.

43 (c) PSYCHOLOGICAL OR OTHER COUNSELING.

44 (d) RELOCATION OR TAKING STEPS TO SECURE AN EXISTING HOME DUE TO
45 THE DOMESTIC VIOLENCE, SEXUAL VIOLENCE, ABUSE OR STALKING.

1 (e) LEGAL SERVICES, INCLUDING PREPARING FOR OR PARTICIPATING IN ANY
2 CIVIL OR CRIMINAL LEGAL PROCEEDING RELATED TO OR RESULTING FROM THE
3 DOMESTIC VIOLENCE, SEXUAL VIOLENCE, ABUSE OR STALKING.

4 17. "SERIOUS HEALTH CONDITION" HAS THE SAME MEANING PRESCRIBED IN
5 SECTION 101 OF THE FAMILY AND MEDICAL LEAVE ACT OF 1993 (P.L. 103-3; 107
6 STAT. 6; 29 UNITED STATES CODE SECTION 2611).

7 18. "SEXUAL VIOLENCE" HAS THE SAME MEANING PRESCRIBED IN SECTION
8 23-371.

9 19. "STALKING" HAS THE SAME MEANING PRESCRIBED IN SECTION 23-371.

10 20. "STATE AVERAGE WEEKLY WAGE" MEANS THE AVERAGE MONTHLY WAGE, AS
11 CALCULATED UNDER SECTION 23-1041, SUBSECTION E, DIVIDED BY 4.5.

12 23-382.01. Eligibility for benefits

13 BEGINNING JANUARY 1, 2029, FAMILY AND MEDICAL LEAVE INSURANCE
14 BENEFITS ARE PAYABLE TO AN INDIVIDUAL WHO BOTH:

- 15 1. MEETS THE DEFINITION OF COVERED INDIVIDUAL UNDER THIS ARTICLE.
- 16 2. MEETS ONE OF THE FOLLOWING REQUIREMENTS:

17 (a) BECAUSE OF BIRTH, ADOPTION OR PLACEMENT THROUGH FOSTER CARE, IS
18 CARING FOR A NEW CHILD DURING THE FIRST YEAR AFTER THE BIRTH, ADOPTION OR
19 PLACEMENT OF THAT CHILD.

20 (b) IS CARING FOR A FAMILY MEMBER WITH A SERIOUS HEALTH CONDITION.

21 (c) IS PREGNANT OR RECOVERING FROM CHILDBIRTH OR HAS AN ILLNESS,
22 INJURY, IMPAIRMENT OR PHYSICAL OR MENTAL CONDITION THAT INVOLVES INPATIENT
23 CARE IN A HOSPITAL, HOSPICE OR RESIDENTIAL MEDICAL CARE FACILITY OR
24 CONTINUING TREATMENT BY A HEALTH CARE PROVIDER AND THAT MAKES THE COVERED
25 INDIVIDUAL UNABLE TO PERFORM THE FUNCTIONS OF THE EMPLOYEE'S POSITION.

26 (d) QUALIFIES FOR QUALIFYING EXIGENCY LEAVE ARISING OUT OF THE FACT
27 THAT THE FAMILY MEMBER OF THE COVERED INDIVIDUAL IS ON ACTIVE DUTY OR HAS
28 BEEN NOTIFIED OF AN IMPENDING CALL OR ORDER TO ACTIVE DUTY IN THE ARMED
29 FORCES.

30 (e) IS IN NEED OF SAFE LEAVE.

31 23-382.02. Duration of benefits

32 A. THE MAXIMUM NUMBER OF WEEKS DURING WHICH FAMILY AND MEDICAL
33 LEAVE INSURANCE BENEFITS ARE PAYABLE TO A COVERED INDIVIDUAL IN AN
34 APPLICATION YEAR IS AS FOLLOWS:

35 1. UNDER SECTION 23-382.01, PARAGRAPH 2, SUBDIVISION (c),
36 TWENTY-SIX WEEKS.

37 2. UNDER SECTION 23-382.01, PARAGRAPH 2, SUBDIVISION (a), (b), (d)
38 OR (e), TWENTY-FOUR WEEKS.

39 B. A COVERED INDIVIDUAL IS ELIGIBLE FOR TWENTY-SIX WEEKS OF LEAVE
40 UNDER SUBSECTION A, PARAGRAPH 1 OF THIS SECTION AND TWENTY-FOUR WEEKS OF
41 LEAVE UNDER SUBSECTION A, PARAGRAPH 2 OF THIS SECTION IN AN APPLICATION
42 YEAR.

43 C. IN ADDITION TO THE FAMILY AND MEDICAL LEAVE INSURANCE BENEFITS
44 THAT ARE PRESCRIBED IN SUBSECTION A OF THIS SECTION, AN EMPLOYER:

- 45 1. MAY PROVIDE ADDITIONAL LEAVE BENEFITS FOR A COVERED INDIVIDUAL.

1 2. SHALL PROVIDE A MINIMUM OF TWELVE WEEKS OF LEAVE TO A COVERED
2 INDIVIDUAL.

3 D. THE FIRST PAYMENT OF BENEFITS MUST BE MADE TO A COVERED
4 INDIVIDUAL WITHIN TWO WEEKS AFTER THE CLAIM IS FILED AND SUBSEQUENT
5 PAYMENTS MUST BE MADE EVERY TWO WEEKS THEREAFTER.

6 23-382.03. Amount of benefits

7 A. THE WEEKLY AMOUNT OF FAMILY AND MEDICAL LEAVE INSURANCE BENEFITS
8 IS DETERMINED AS FOLLOWS:

9 1. IF THE COVERED INDIVIDUAL'S AVERAGE WEEKLY WAGE IS EQUAL TO OR
10 LESS THAN ONE-HALF OF THE STATE AVERAGE WEEKLY WAGE, THE BENEFIT AMOUNT IS
11 EQUAL TO NINETY PERCENT OF THE COVERED INDIVIDUAL'S AVERAGE WEEKLY WAGE.

12 2. IF THE COVERED INDIVIDUAL'S AVERAGE WEEKLY WAGE IS GREATER THAN
13 ONE-HALF OF THE STATE AVERAGE WEEKLY WAGE, THE BENEFIT AMOUNT IS THE SUM
14 OF BOTH OF THE FOLLOWING:

15 (a) NINETY PERCENT OF ONE-HALF OF THE STATE AVERAGE WEEKLY WAGE.

16 (b) FIFTY PERCENT OF THE DIFFERENCE OF THE COVERED INDIVIDUAL'S
17 AVERAGE WEEKLY WAGE AND ONE-HALF OF THE STATE AVERAGE WEEKLY WAGE.

18 B. BEGINNING JANUARY 1, 2029, THE MAXIMUM WEEKLY BENEFIT AMOUNT
19 CALCULATED PURSUANT TO SUBSECTION A OF THIS SECTION IS NOT MORE THAN
20 \$1,000 PER WEEK, EXCEPT THAT ANNUALLY, NOT LATER THAN OCTOBER 1 OF EACH
21 YEAR THEREAFTER, THE COMMISSION SHALL ADJUST THE MAXIMUM WEEKLY BENEFIT
22 AMOUNT TO BE NINETY PERCENT OF THE STATE AVERAGE WEEKLY WAGE AND THE
23 ADJUSTED MAXIMUM WEEKLY BENEFIT AMOUNT SHALL TAKE EFFECT ON JANUARY 1 OF
24 THE YEAR FOLLOWING THE ADJUSTMENT.

25 C. THE MINIMUM WEEKLY BENEFIT MAY NOT BE LESS THAN \$100 PER WEEK,
26 EXCEPT THAT IF THE COVERED INDIVIDUAL'S AVERAGE WEEKLY WAGE IS LESS THAN
27 \$100 PER WEEK, THE WEEKLY BENEFIT SHALL BE THE COVERED INDIVIDUAL'S FULL
28 WAGE.

29 D. FAMILY AND MEDICAL LEAVE INSURANCE BENEFITS ARE NOT PAYABLE FOR
30 LESS THAN EIGHT HOURS OF FAMILY AND MEDICAL LEAVE TAKEN IN ONE WORK WEEK.

31 23-382.04. Contributions

32 A. PAYROLL CONTRIBUTIONS ARE AUTHORIZED TO FINANCE THE PAYMENT OF
33 BENEFITS UNDER THE FAMILY AND MEDICAL LEAVE INSURANCE PROGRAM.

34 B. BEGINNING JANUARY 1, 2028, PAYROLL CONTRIBUTIONS SHALL BE PAID
35 BY EMPLOYERS AND EMPLOYEES IN THE RATIO OF ONE-TO-ONE IN AN AMOUNT TO BE
36 DETERMINED BY THE COMMISSION.

37 C. NOT LATER THAN OCTOBER 1 OF EACH YEAR, THE COMMISSION SHALL FIX
38 THE CONTRIBUTION RATE FOR THE COMING CALENDAR YEAR AS FOLLOWS:

39 1. FOR CALENDAR YEARS 2028 AND 2029, THE COMMISSION SHALL DO SO
40 BASED ON SOUND ACTUARIAL PRINCIPLES.

41 2. FOR CALENDAR YEAR 2028 AND EACH CALENDAR YEAR THEREAFTER, THE
42 COMMISSION SHALL FIRST CERTIFY AND PUBLISH ALL OF THE FOLLOWING
43 INFORMATION:

44 (a) THE TOTAL AMOUNT OF FAMILY AND MEDICAL LEAVE INSURANCE BENEFITS
45 PAID BY THE COMMISSION DURING THE PREVIOUS FISCAL YEAR.

1 (b) THE TOTAL AMOUNT REMAINING IN THE FAMILY AND MEDICAL LEAVE
2 INSURANCE FUND ESTABLISHED BY SECTION 23-382.15 AT THE CLOSE OF THE FISCAL
3 YEAR.

4 (c) THE TOTAL AMOUNT EQUAL TO ONE HUNDRED FORTY PERCENT OF THE
5 PREVIOUS FISCAL YEAR'S EXPENDITURES FOR FAMILY AND MEDICAL LEAVE INSURANCE
6 BENEFITS PAID AND FOR THE ADMINISTRATION OF THE FAMILY AND MEDICAL LEAVE
7 INSURANCE PROGRAM.

8 (d) THE AMOUNT BY WHICH THE TOTAL AMOUNT REMAINING IN THE FAMILY
9 AND MEDICAL LEAVE INSURANCE FUND ESTABLISHED BY SECTION 23-382.15 AT THE
10 CLOSE OF THE PREVIOUS FISCAL YEAR IS LESS THAN OR GREATER THAN ONE HUNDRED
11 FORTY PERCENT OF THE PREVIOUS FISCAL YEAR'S EXPENDITURES FOR FAMILY AND
12 MEDICAL LEAVE INSURANCE BENEFITS PAID AND FOR THE ADMINISTRATION OF THE
13 FAMILY AND MEDICAL LEAVE INSURANCE PROGRAM.

14 (e) THE AMOUNT BY WHICH THE CONTRIBUTION RATE SHALL BE ADJUSTED TO
15 ENSURE THAT THE FAMILY AND MEDICAL LEAVE INSURANCE FUND ESTABLISHED BY
16 SECTION 23-382.15 MAINTAINS OR ACHIEVES AN ANNUALIZED AMOUNT OF NOT LESS
17 THAN ONE HUNDRED PERCENT OF THE PREVIOUS FISCAL YEAR'S EXPENDITURES FOR
18 FAMILY AND MEDICAL LEAVE INSURANCE BENEFITS PAID AND FOR THE
19 ADMINISTRATION OF THE FAMILY AND MEDICAL LEAVE INSURANCE PROGRAM. THE
20 CONTRIBUTION RATE ADJUSTMENT, IF ANY, MADE AS THE RESULT OF THE
21 COMMISSION'S CERTIFICATION AND REPORT UNDER THIS SUBSECTION SHALL
22 SUPERSEDE THE RATE PREVIOUSLY SET FORTH AND SHALL BECOME EFFECTIVE ON
23 JANUARY 1 OF THE FOLLOWING CALENDAR YEAR.

24 D. A SELF-EMPLOYED INDIVIDUAL WHO ELECTS COVERAGE UNDER SECTION
25 23-382.12 IS RESPONSIBLE FOR THE EMPLOYEE SHARE OF CONTRIBUTIONS SET FORTH
26 IN SUBSECTION B OF THIS SECTION ON THAT INDIVIDUAL'S INCOME FROM
27 SELF-EMPLOYMENT.

28 23-382.05. Reduced leave schedule

29 A. A COVERED INDIVIDUAL IS ENTITLED, AT THE OPTION OF THE COVERED
30 INDIVIDUAL, TO TAKE PAID FAMILY AND MEDICAL LEAVE ON AN INTERMITTENT OR
31 REDUCED LEAVE SCHEDULE IN WHICH ALL OF THE LEAVE AUTHORIZED UNDER THIS
32 ARTICLE IS NOT TAKEN SEQUENTIALLY. FAMILY AND MEDICAL LEAVE INSURANCE
33 BENEFITS FOR INTERMITTENT OR REDUCED LEAVE SCHEDULES SHALL BE PRORATED.

34 B. THE COVERED INDIVIDUAL SHALL PROVIDE THE EMPLOYER WITH PRIOR
35 NOTICE OF THE SCHEDULE ON WHICH THE COVERED INDIVIDUAL WILL BE TAKING THE
36 LEAVE, TO THE EXTENT PRACTICABLE. PAID FAMILY AND MEDICAL LEAVE TAKEN
37 UNDER THIS SECTION MAY NOT RESULT IN A REDUCTION OF THE TOTAL AMOUNT OF
38 LEAVE TO WHICH AN EMPLOYEE IS ENTITLED BEYOND THE AMOUNT OF LEAVE ACTUALLY
39 TAKEN.

40 C. THIS SECTION DOES NOT ENTITLE A COVERED INDIVIDUAL TO MORE LEAVE
41 THAN REQUIRED UNDER SECTION 23-382.02.

42 23-382.06. Leave and employment protection; enforcement

43 A. ANY COVERED INDIVIDUAL WHO EXERCISES THE COVERED INDIVIDUAL'S
44 RIGHT TO FAMILY AND MEDICAL LEAVE INSURANCE BENEFITS IS ENTITLED, ON THE
45 EXPIRATION OF THAT LEAVE, TO BE RESTORED BY THE EMPLOYER TO THE POSITION

1 HELD BY THE COVERED INDIVIDUAL WHEN THE LEAVE COMMENCED, OR TO A POSITION
2 WITH EQUIVALENT SENIORITY, STATUS, EMPLOYMENT BENEFITS, PAY AND OTHER
3 TERMS AND CONDITIONS OF EMPLOYMENT, INCLUDING FRINGE BENEFITS AND SERVICE
4 CREDITS, THAT THE COVERED INDIVIDUAL HAD BEEN ENTITLED TO AT THE
5 COMMENCEMENT OF LEAVE.

6 B. DURING ANY LEAVE TAKEN PURSUANT TO THIS ARTICLE, THE EMPLOYER
7 SHALL MAINTAIN ANY HEALTH CARE BENEFITS THE COVERED INDIVIDUAL HAD BEFORE
8 TAKING SUCH LEAVE FOR THE DURATION OF THE LEAVE AS IF THE COVERED
9 INDIVIDUAL HAD CONTINUED IN EMPLOYMENT CONTINUOUSLY FROM THE DATE THE
10 COVERED INDIVIDUAL COMMENCED THE LEAVE UNTIL THE DATE THE FAMILY AND
11 MEDICAL LEAVE INSURANCE BENEFITS TERMINATE, IF THE COVERED INDIVIDUAL
12 CONTINUES TO PAY THE COVERED INDIVIDUAL'S SHARE OF THE COST OF HEALTH
13 BENEFITS AS REQUIRED BEFORE THE COMMENCEMENT OF THE LEAVE.

14 C. THIS SECTION AND SECTION 23-382.07 SHALL BE ENFORCED AS FOLLOWS:

22 GENERAL TO BRING AN ACTION ON BEHALF OF THE EMPLOYEE IN ACCORDANCE WITH

24 (c) BRING AN ACTION ON BEHALF OF AN EMPLOYEE IN THE COUNTY WHERE
25 THE VIOLATION ALLEGEDLY OCCURRED.

26 3. AN EMPLOYEE MAY BRING A CIVIL ACTION IN A COURT OF COMPETENT
27 JURISDICTION AGAINST THE EMPLOYEE'S EMPLOYER FOR A VIOLATION OF THIS
28 ARTICLE REGARDLESS OF WHETHER THE EMPLOYEE FIRST FILED A COMPLAINT WITH
29 THE DIRECTOR.

30 4. AN ACTION BROUGHT UNDER PARAGRAPH 2 OR 3 OF THIS SUBSECTION
31 SHALL BE FILED WITHIN THREE YEARS AFTER THE OCCURRENCE OF THE ACT ON WHICH

43 AWARDED UNDER SUBDIVISION (b) OF THIS PARAGRAPH.

44 (d) REASONABLE ATTORNEY FEES AND OTHER COSTS.

1 (e) ANY OTHER RELIEF THAT THE COURT DEEMS APPROPRIATE, INCLUDING
2 REINSTATEMENT OF EMPLOYMENT, BACK PAY AND INJUNCTIVE RELIEF.

3 6. IF THE ACTION WAS BROUGHT BY THE ATTORNEY GENERAL UNDER
4 PARAGRAPH 2, SUBDIVISION (b) OF THIS SUBSECTION, THE COURT SHALL ORDER THE
5 EMPLOYER TO PAY AT LEAST \$1,000 PER VIOLATION TO THIS STATE.

6 23-382.07. Retaliatory personnel actions prohibited

7 A. IT IS UNLAWFUL FOR AN EMPLOYER OR ANY OTHER PERSON TO INTERFERE
8 WITH, RESTRAIN OR DENY THE EXERCISE OF, OR THE ATTEMPT TO EXERCISE, ANY
9 RIGHT PROTECTED UNDER THIS ARTICLE.

10 B. AN EMPLOYER, TEMPORARY HELP COMPANY, EMPLOYMENT AGENCY, EMPLOYEE
11 ORGANIZATION OR OTHER PERSON MAY NOT TAKE RETALIATORY PERSONNEL ACTION OR
12 OTHERWISE DISCRIMINATE AGAINST A PERSON BECAUSE THE PERSON EXERCISED
13 RIGHTS PROTECTED UNDER THIS ARTICLE. THESE RIGHTS INCLUDE ALL OF THE
14 FOLLOWING:

15 1. REQUESTING, FILING FOR, APPLYING FOR OR USING BENEFITS OR LEAVE
16 PROVIDED FOR UNDER THIS ARTICLE.

17 2. COMMUNICATING TO THE EMPLOYER OR ANY OTHER PERSON OR ENTITY AN
18 INTENT TO FILE A CLAIM, A COMPLAINT WITH THE COMMISSION OR COURTS OR AN
19 APPEAL.

20 3. TESTIFYING, PLANNING TO TESTIFY OR ASSISTING IN ANY
21 INVESTIGATION, HEARING OR PROCEEDING UNDER THIS ARTICLE AT ANY TIME,
22 INCLUDING DURING THE WAITING PERIOD AND THE PERIOD IN WHICH THE PERSON
23 RECEIVES FAMILY AND MEDICAL LEAVE INSURANCE BENEFITS UNDER THIS ARTICLE.

24 4. INFORMING ANY PERSON ABOUT ANY EMPLOYER'S ALLEGED VIOLATION OF
25 THIS ARTICLE.

26 5. INFORMING ANY PERSON OF A PERSON'S RIGHTS UNDER THIS ARTICLE.

27 C. IT IS UNLAWFUL FOR AN EMPLOYER'S ABSENCE CONTROL POLICY TO COUNT
28 PAID FAMILY AND MEDICAL LEAVE TAKEN UNDER THIS ARTICLE AS AN ABSENCE THAT
29 MAY LEAD TO OR RESULT IN DISCIPLINE, DISCHARGE, DEMOTION, SUSPENSION OR

37 DIMINISHED BY A COLLECTIVE BARGAINING AGREEMENT ENTERED INTO OR RENEWED,
38 OR AN EMPLOYER POLICY ADOPTED OR RETAINED, AFTER THE EFFECTIVE DATE OF
39 THIS ARTICLE. ANY AGREEMENT BY AN INDIVIDUAL TO WAIVE THE INDIVIDUAL'S
40 RIGHTS UNDER THIS ARTICLE IS VOID AS AGAINST PUBLIC POLICY.

42 A. EACH EMPLOYER SHALL PROVIDE WRITTEN NOTICE THAT COMPLIES WITH

5 B. ANY NOTICED PROVIDED UNDER THIS SECTION SHALL INCLUDE ALL OF THE
